RE: Final Plat – Ski Enterprise Subdivision

For reasons of Section 19-923 Revised Statutes of Nebraska, as amended, there is herewith submitted a final plat of Ski Enterprise Subdivision, located west of 190th Road and North of White Cloud Road in Hall County, Nebraska.

This final plat proposes to create 1 lot on a tract of land being part of Lot One (1) (now vacated), Ski Enterprise Subdivision, being part of the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section Twenty (20), Township Twelve (12) North, Range Twelve (12) West of the 6th P.M., in Hall County, Nebraska. This land consists of approximately 2 acres.

SKI ENTERPRISE SECOND SUBDIVISION

A subdivision being part of the Southwest Quarter of the Southwest Quarter of Section 20, Township 12 North, Range 12 West of the Sixth Principal Meridian, Hall County, Nebraska

LEGAL DESCRIPTION

A tract of land being part of Lot One (1) (now vacated), Ski Enterprise Subdivision, being part of the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section Twenty (20), Township 12 North, Range 12 West of the Sixth Principal Meridian (12N 12W 6M), Hall County, Nebraska. Referring to the Southwest Corner of the Southwest Quarter of said Section 20, said point also being the Southwest corner of said Ski Enterprise Subdivision, the West line of said Southwest Quarter and the West line of said Ski Enterprise Subdivision NORTH and all bearings contained herein are relative thereto, thence NORTH on the aforesaid West line a distance of 756.84 feet to the northeast corner of said Lot 1 (now vacated), thence S 89°26' E on the aforesaid North line a distance of 248.22 feet to the northeast corner OF BEGINNING, said place of beginning being the Northwest corner of said Lot 1 (now vacated), Ski Enterprise Subdivision and the East right-of-way line of 190th Road, thence continuing S 89°26' E on the aforesaid North line a distance of 254.49 feet, thence S 40°25' E a distance of 27.6 feet to the northeast corner of said Lot 1 (now vacated), Ski Enterprise Subdivision, thence S 00°57'02" E on the aforesaid East line a distance of 317.08 feet, thence S 89°09'40" W parallel with the South line of said Southwest Quarter and the South line of said Ski Enterprise Subdivision to the northeast corner of said Lot 1 (now vacated), thence NORTH parallel with the West line of said Southwest Quarter and on the West line of said Lot 1 (now vacated) a distance of 348.22 feet to the place of beginning. Containing 2.60 acres, more or less.

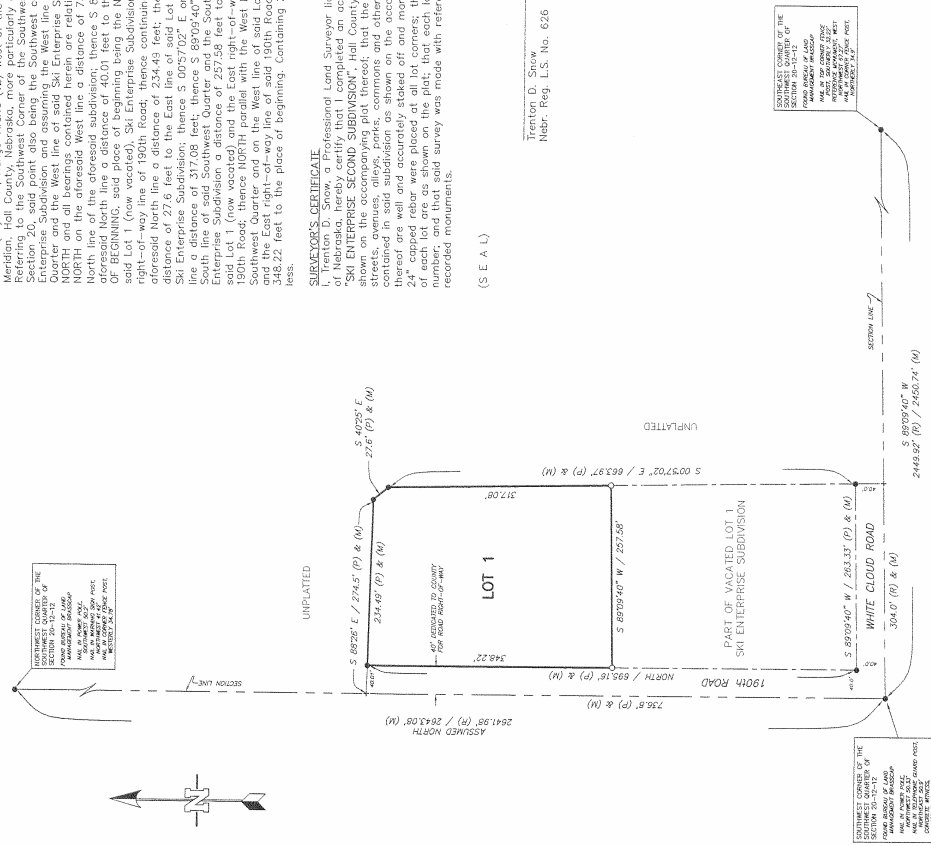

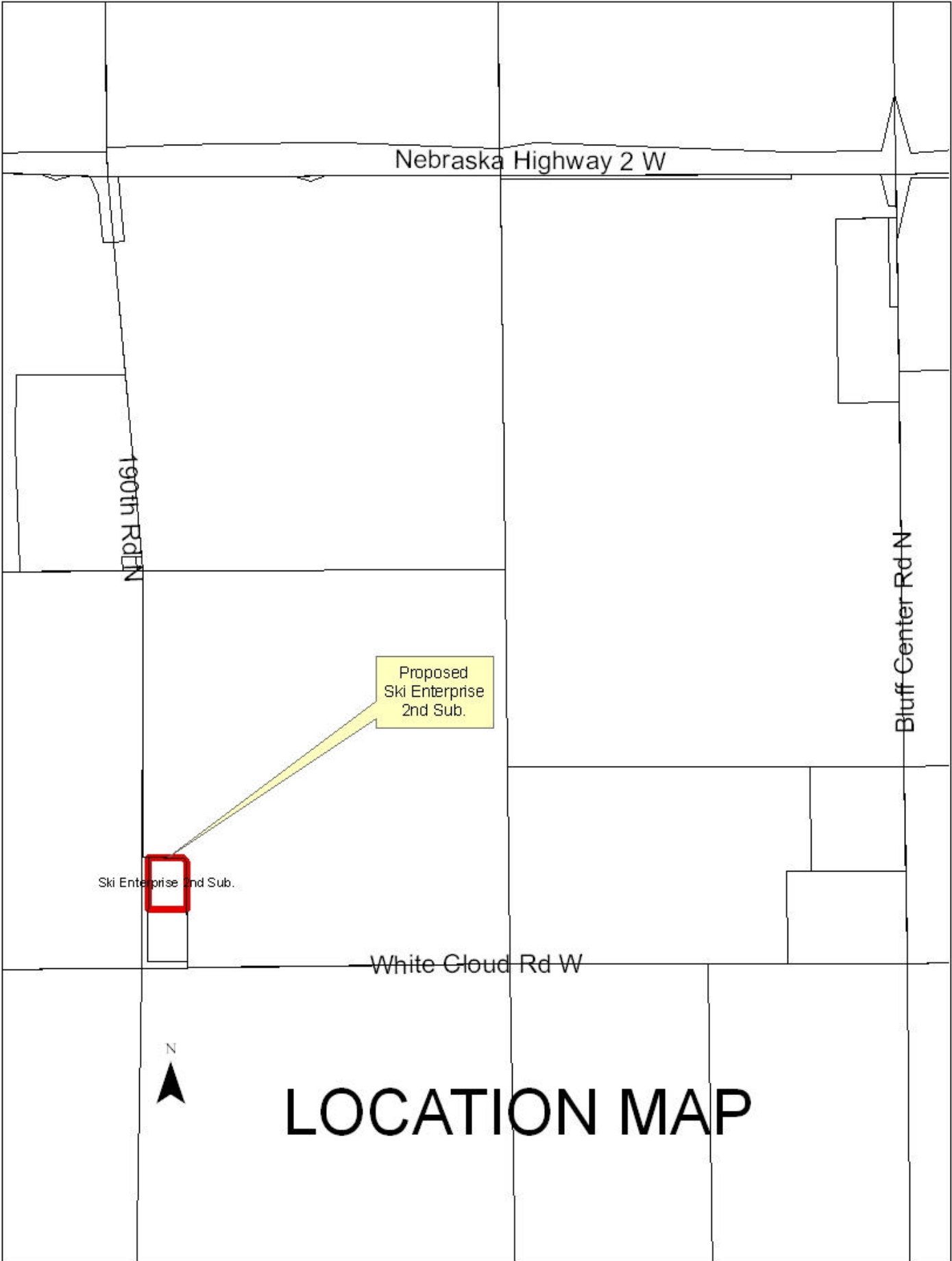
