The Grand Island water system has increased to where additional capacity is required to allow future growth in the city. An elevated storage tank is recommended by the recently completed water system master plan.

Discussion

To fund the cost of the elevated storage tank, a bond issue is proposed and a cost of service study was made by the Nebraska Municipal Power Pool in order to support projected revenue requirements of the bond debt service. The results of the study and possible changes to the water system rate structure will be provided to the Council for discussion.






