Background

This property is located north of Capital Avenue and east of Engleman Road in the City of Grand Island, in Hall County, Nebraska. It consists of 2 lots and 1.934 acres.

Discussion

The plat for Hope Valley Subdivision, Final Plat was considered by the Regional Planning Commission at the July 5, 2017 meeting.

A motion was made by Rainforth and seconded by Apfel to approve the plat as presented.

A roll call vote was taken and the motion passed with 8 members present and voting in favor (Apfel, Allan, O'Neill, Ruge, Rainforth, Rubio, Sears and Randone) and no members voting no or abstaining.




