Background

Van Kirk Bros. Contracting of Sutton, Nebraska was awarded a \$122,404.00 contract on April 25, 2017 via Resolution No. 2017-126.

The drainage improvements to be performed are located on Shady Bend Road between Seedling Mile Road and US Highway 30. These improvements are being made in response to Wetzel Street resident requests.

Discussion

To further improve drainage in the area of Shady Bend Road between Seedling Mile Road and US Highway 30 the removal and disposal of several trees is necessary. Along with tree removal, some further grading and culvert cleaning is also needed. Change Order No.1 covers the materials, labor and equipment for such additional work on this project.

The extra work adds a total cost of \$10,750.00 to the project, resulting in a revised contract amount of \$133,154.00. There are sufficient funds in Account No. 40000400-2000-40024.

Alternatives

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

Recommendation
