Background

A Request for Proposal (RFP) was issued for the complete design, materials, installation and construction of a pre-engineered metal building for the Utilities Department. Bids were received, reviewed and a contract was awarded to Chief Construction at the April 17, 2017 City Council meeting.

The facility will be utilized as a vehicle garage and warehouse on the north side of the Utilities Engineering/Customer Service Center located at 1306 W. 3rd Street. The building will provide indoor storage for vehicles used by the meter readers and the Engineering Division

Discussion

During construction of the building, the following scope changes were encountered:

- 1) The existing concrete pavement immediately west of the new facilities location was determined to slope towards the proposed building slab. To prevent water from flowing toward the proposed building, 936 square feet of existing pavement was removed, regraded and replaced at a cost of \$6,808.93.
- 2) During excavation, an old foundation was discovered under the construction site. Inspection of the soil in this location led to concern regarding its suitability as a base material. Soil was sampled, tested, deemed to be unsuitable, removed and replaced at a cost of \$8,767.11.
- 3) Initial plans for the project depicted the sewer connecting directly to an existing on-site manhole. A subsequent review required the connection point be changed from the manhole to the building's existing service line. In order to facilitate the extra pavement removal and pipe installation, an extra cost of \$6,257.47 was incurred.

The original Engineer's estimate was \$450,000.00. The original contract was for \$372,613.00. Total changes to the contract amount to \$21,833.51, resulting in a final contract cost of \$394,446.51.

Alternatives

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

Recommendation

City Administration recommends that the Council approve Change Order No. 1 to the Vehicle Garage & Warehouse contract at 1306 W. 3rd Street, in the amount of \$21,833.51, for a final contract cost of \$394,446.51.

WHEREAS, at the April 11, 2017 Council meeting, Council awarded the contract for Vehicle Storage Building and Warehouse at 1306 West 3rd Street, to Chief Construction Company of Grand Island, Nebraska, in the amount of \$372,613.00; and

WHEREAS, the existing concrete pavement just west of the new garage was deemed to slope towards the proposed building slab and to alleviate water from flowing toward the proposed building, 936 square feet of existing pavement was removed, regraded and replaced at a cost of \$6,808.93; and

WHEREAS, an old foundation was discovered during excavation and inspection of the soil in this location deemed the soil to be unsuitable as a base material and the soil had to be removed and replaced at a cost of \$8,767.11; and

WHEREAS, the connection point for the sewer be changed from a manhole toe the existing service line and in order to facilitate the extra pavement removal and pipe installation, an extra cost of \$6,257.47 was incurred; and

WHEREAS, as a result of these design changes, Change Order #1 was prepared for an additional \$21,833.51, for a total contract amount of \$394,446.51.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GRAND ISLAND, NEBRASKA, that Change Order #1 for the Vehicle Garage & Warehouse Project at 1306 W. 3rd Street, is hereby approved and the Mayor is hereby authorized to sign Change Order #1 on behalf of the City of Grand Island.
