Background

On October 5, 2017 the Solid Waste Division of the Public Works Department advertised for bids for one (1) Trailer Mounted Landfill Hydro Seeder. This hydro seeder will be used for seeding landfill side slopes where intermediate cover has been applied. Over the past several years it has become increasingly difficult to establish seeded areas on our side slopes due to the soil types present at the landfill. It is important to be able to properly establish grass on these areas in order to prevent soil erosion and to satisfy our regulatory permit requirements.

Discussion

One (1) bid was received and opened on October 17, 2017. The Solid Waste Division of the Public Works Department and the Purchasing Division of the Attorney's office reviewed the bids that were received. The hydro seeder bid by Roadbuilders Machinery
