#### **Background**

Gas Turbine #3 is located at the Burdick Generating Station. The unit was commissioned in 2003 and is used for electrical power generation, primarily operating as a peaking unit for the City. A Borescope inspection performed in September of 2017 revealed that a compressor blade had come loose. An additional borescope inspection was done to find the liberated blade, but it was not located. Without knowing where the blade was located in the unit, it could move and cause further damage in the unit.

A Modified Hot Gas Path Inspection was approved by Council on February 27, 2018, in the amount of \$494,261.00. The Hot Gas Path Inspection commenced on May 21, 2018. Change Orders #1 and #2 were approved by Council on June 26, 2018 for a net increase to the contract of \$50,878.83; for a contract cost of \$545,139.83.

#### Change Order #3

During the Hot Gas Path inspection, the ten primary and ten secondary fuel nozzles, and the combustion liners were sent to the repair facility for inspections. During the inspection process, flow test and visual inspections were completed. Several fuel nozzles did not meet the flow specifications and the combustion liners need repairs to maintain their function during operation. The repairs while in the facility will cost \$132,090.13. New gaskets are needed to reassemble the fuel nozzles, those materials totaled \$1,870.83. Grand Island Utilities supplemented the labor during disassembly and a credit was given in the amount of \$5,037.92. The total of these repairs, parts, and credit increases the final contract to \$674,062.87.

## **Discussion**

The Modified Hot Gas Path inspection of GT3 Change Order #3 requires a net additional cost of \$128,923.04 for a final contract cost of \$674,062.87.

### **Alternatives**

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

#### **Recommendation**

City Administration recommends authorizing Change Order #3 to the GT3 Modified Hot Gas Path Inspection at Burdick Generating Station for an addition to the contract price of \$128,923.04, to General Electric International, Inc., of Omaha, Nebraska.

WHEREAS, on February 27, 2018, Council approved a contract with General Electric International, in., in the amount of \$494,261.00 for Gas Turbine #3 Modified Hot Gas Path Inspection at Burdick Generating Station; and

WHEREAS, at the June 26, 2018 Council meeting, Council approved Change Orders #1 and #2 for the Hot Gas Path Inspection in the amount of \$50,878.83; and

WHEREAS, during the Hot Gas Path Inspection, the fuel nozzles and combustion liners were sent to the GI repair facility inspections; and

WHEREAS, during the inspection process, several fuel nozzles did not meet the flow specifications and the combustion liners need repairs to maintain their function during operation; and

WHEREAS, the repairs while in the facility will cost \$132,090.13 and new gaskets needed to reassemble the fuel nozzles will cost \$1,870.83; and

WHEREAS, Grand Island Utilities supplemented the labor during disassembly and a credit was given in the amount of \$5,037.92; and

WHEREAS, the total of these repairs, parts, and the credit received amount to an net increase in the contract of \$128,923.04, for a final contract cost of \$674,062.87.
