Luz Elena Castillo Rodriquez, 647 E. Meves has submitted an application with the City Clerk's Office for a Liquor Manager Designation in conjunction with Fiesta Latina, 2815 South Locust Street.

Discussion

Luz Castillo Rodriguez is applying to become the liquor manager at Fiesta Latina. According to her application, Luz has worked at JBS since 1996 until the present time. As requested, she did not list the year she moved to Grand Island. No spousal information is listed on the application, nor is there any information listed under convictions other than, "Over 10 years driving ticket."

I checked Luz through Spillman and found where our first documented contact with her goes back to 2003. She doesn't have any potential convictions listed or anything else concerning. I also checked Luz through NCJIS. I discovered that she has been convicted of disturbing the peace by fighting in 1998, speeding in 1999, and having a dog or cat at large in 2010. All of the convictions are infractions. While they should have been disclosed, none of them will automatically preclude her from becoming a liquor manager. Luz doesn't have any outstanding warrants for her arrest, and she has a valid Nebraska driver's license. According to ICE, she is a Naturalized U.S. Citizen. The last check I ran on Luz was through a paid, law enforcement-only database which contains mostly personal identifying information and information about civil issues. Nothing out of the ordinary was found.

The Grand Island Police Department has no objection to Luz Castillo Rodriguez becoming the liquor manager at Fiesta Latina.
