Background

Water Main Project 2018-W-3 installed approximately 1,740 linear feet of new City water main within Golden Age Subdivision. The project supplemented the existing 4” and 6” diameter water lines with new 10”, 8”, and 6” ductile iron pipe. The work provided increased capacity and fire protection for the area. A site map of the area is attached for reference.

Discussion

The project has been completed by Van Kirk Brothers Contracting of Sutton, Nebraska, in accordance with the terms and conditions of the contract documents and plans. The final contract amount for the work was \$210,011.50.

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

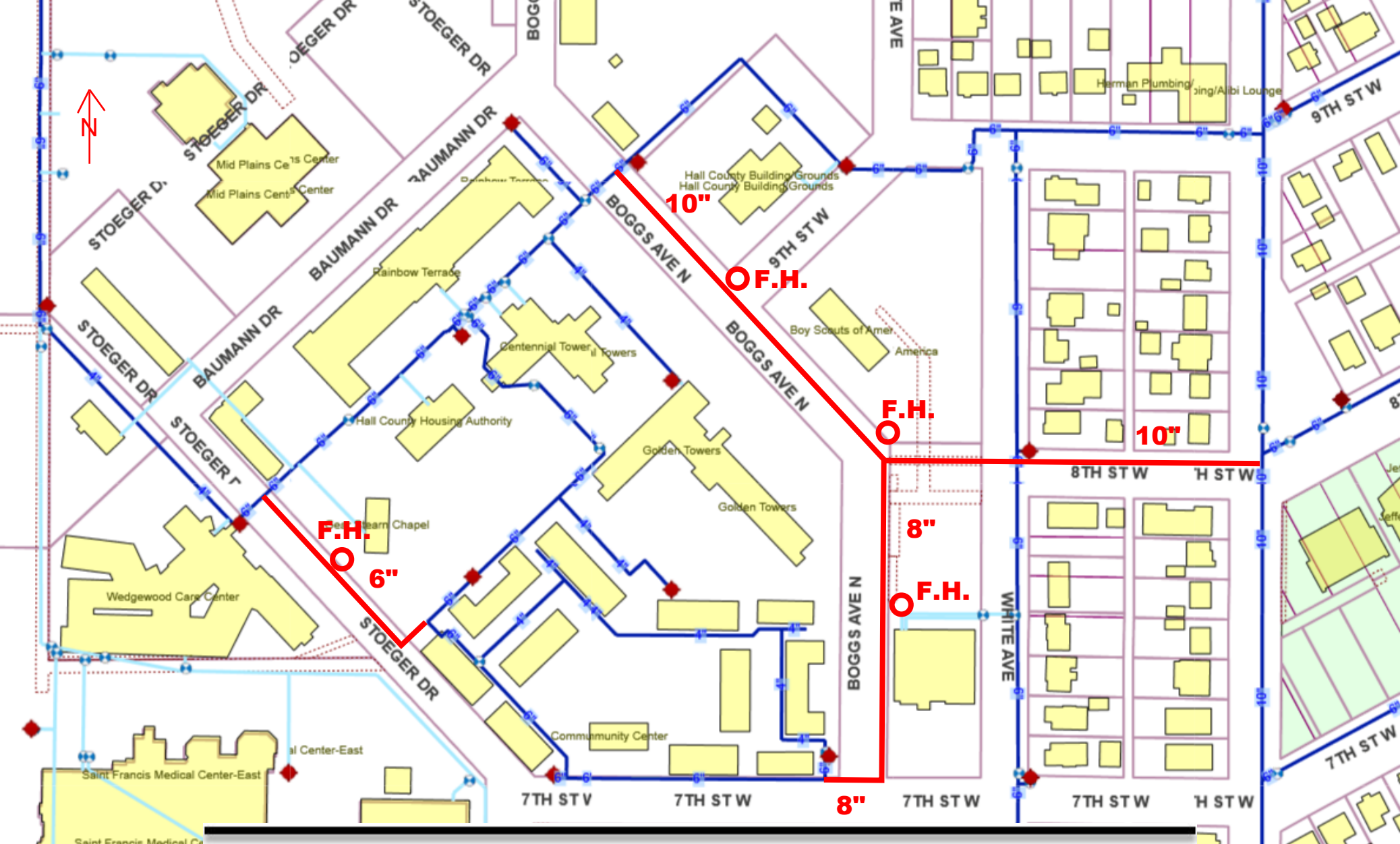
1. Move to approve




ENGINEER'S CERTIFICATE OF FINAL COMPLETION


