Background

The purchase of a new bucket truck/sign truck for the Streets Division was approved by the City Council on March 26, 2019 from Altec Industries Inc. The original council memo and resolution stated that the unit would be an Altec AT37G but that was incorrect and the new unit will actually be an Altec model AT40G.

Altec Industries Engineering staff and Sales staff conduct a 3D model review of the new unit prior to beginning the build. The 3D model review gives the customer the opportunity to remove, add, or adjust items within the utility body of the truck to ensure it is set up efficiently.

Discussion

Streets Staff participated in the 3D model review of the new bucket truck/sign truck on August 22, 2019. There are several deletions and additions that are being recommended for this unit, including the addition of a 2400 Watt inverter to run electric tools and charge batteries. These items can be added after the unit is built but it is less expensive and the final product will be better if installed during the installation of the utility body. A summary of additional items is shown on the attached Customer Decision Sheet.

The net cost of the changes will be \$7,423.00 and the added items are part of the Sourcewell Contract No. 012418-ALT.

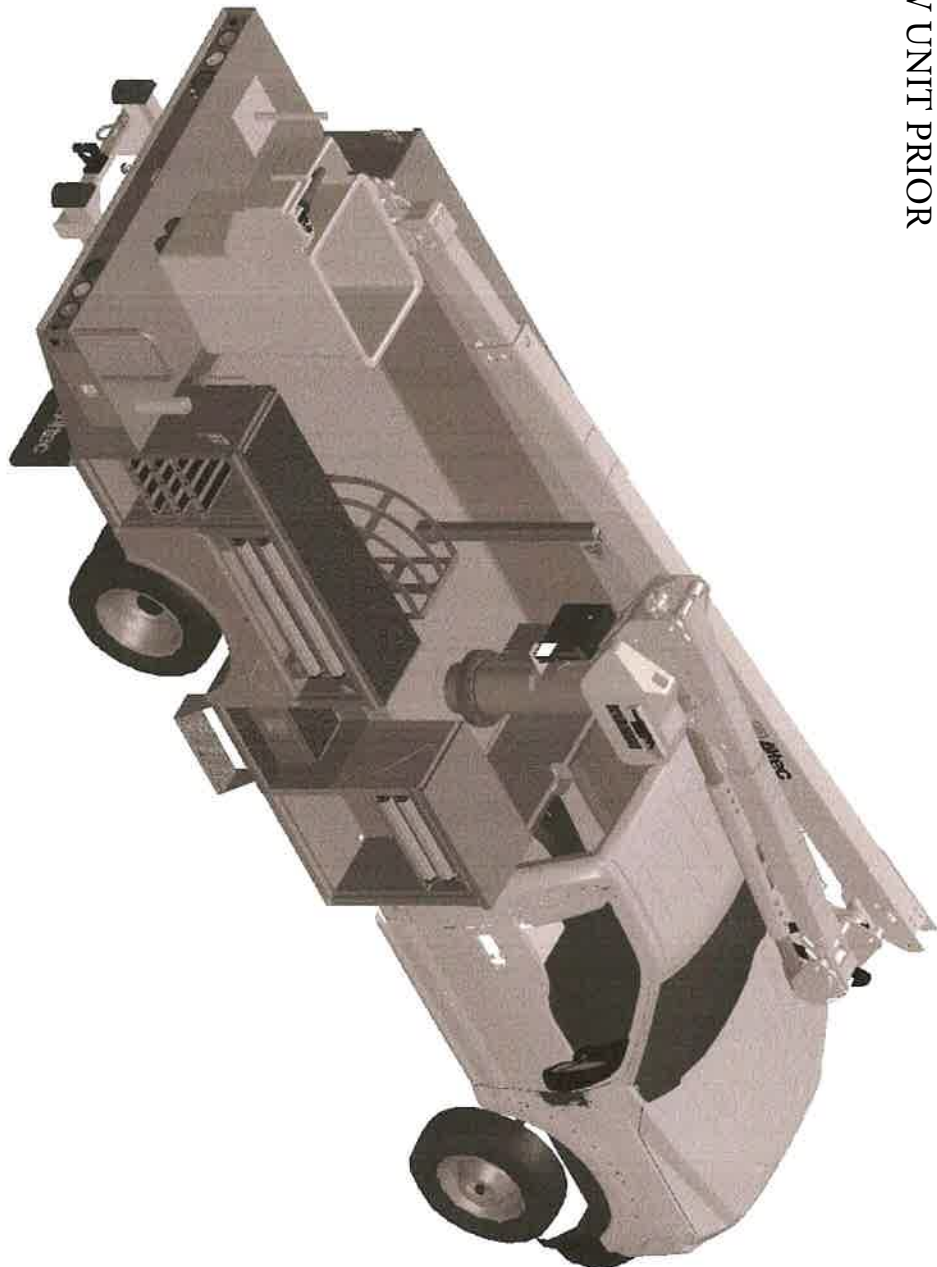
Recommendation
