#### **Background**

Water Main Project 2018-W-8 has been completed by The Diamond Engineering Company of Grand Island, Nebraska. The work eliminated conflicts between the storm sewer and water main within the intersection of Riverside Drive and Holcomb Street and now conforms to the current clearance requirements. A site map of the area is attached for reference.

#### **Discussion**

The project has been completed in accordance with the terms and conditions of the contract documents and plans. The final contract amount for the work was \$91,378.39.
