RESOLUTION 2020-134

WHEREAS, current City property is being dedicated by the City of Grand Island as right-of-way to accommodate the Old Potash Highway Roadway Improvements; Project No. 2019-P-1, Grand Island, Hall County, Nebraska and more particularly described as follows:

A TRACT OF LAND CONSISTING OF PART OF AN UNPLATTED TRACT LOCATED IN THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER (NW ¼, NE ¼) OF SECTION TWENTY-FOUR (24), TOWNSHIP ELEVEN (11) NORTH, RANGE TEN (10), WEST OF THE 6TH P.M., NEBRASKA, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT NORTH QUARTER CORNER SECTION 24, T11N, R10W OF THE 6TH P.M., HALL COUNTY, NEBRASKA; THENCE ON AN ASSUMED BEARING OF N89°28'39"E ALONG THE NORTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 24, A DISTANCE OF 1073.40 FEET TO THE NORTHEAST CORNER OF SAID UNPLATTED TRACT, SAID POINT ALSO BEING THE POINT OF BEGINNING; THENCE N89°28'41"E ALONG SAID NORTH LINE OF NE ¼ OF SEC. 24, A DISTANCE OF 85.84 FEET TO THE NORTHEAST CORNER OF SAID UNPLATTED TRACT; THENCE S01°56'43"W ALONG A EAST LINE OF SAID UNPLATTED TRACT, A DISTANCE OF 40.04 FEET; THENCE S01°56'33"W ALONG A EAST LINE OF SAID UNPLATTED TRACT, A DISTANCE OF 23.01 FEET; THENCE S49°50'39"E ALONG THE EAST LINE OF SAID UNPLATTED TRACT, A DISTANCE OF 11.52 FEET; THENCE S89°28'39"W A DISTANCE OF 91.33 FEET TO A POINT ON THE WEST LINE OF SAID UNPLATTED TRACT; THENCE N00°57'24"W ALONG SAID WEST LINE, A DISTANCE OF 30.50 FEET; THENCE N00°57'24"W ALONG SAID WEST LINE, A DISTANCE OF 30.50 FEET; THENCE N00°57'24"W A DISTANCE OF 40.00 FEET TO A POINT OF BEGINNING. SAID TRACT CONTAINS 5,960 SF MORE OR LESS, OF WHICH 2,805 SF ARE EXISTING AND 3,155 SF ARE NEW.

WHEREAS, such dedication of right-of-way has been reviewed and approved by the City Legal Department.


