Background

The Parks Division budgeted this year to replace two mowers. The replacement equipment is necessary as the current units are over 20 years old and becoming less dependable. The new equipment will provide additional years of service to the Parks Division operation.

Discussion

The equipment specifications awarded under the Sourcewell Cooperative Buying Group contract meet the requirements for the Parks Division. Turfwerks of Omaha, Nebraska submitted a bid for the equipment with no exceptions in the amount of \$60,484.00. The purchase will be funded from capital account 41044401-85615.
