Background

The Parks Division budgeted this year to replace three older mowers with one new 11' cut mower. The replacement equipment is necessary as the current units have over 4,000+ operating hours each and becoming less dependable. The new equipment will provide additional years of service to the Parks Division operation and increase staff efficiency.

Discussion

The equipment specifications awarded under the Sourcewell Cooperative Buying Group contract meet the requirements for the Parks Division. Midwest Turf and Irrigation of Omaha, Nebraska submitted a bid for the equipment with no exceptions in the amount of \$85,963.70. The purchase will be funded from capital account 41044401-85615.
