#### MUNICIPAL MARKET UPDATE:

An odd week? Or an odd month? After record-breaking supply in October, the first week of November featured the Presidential election which curtailed supply for the week. This week we had a mid-week holiday with Veterans Day on Wednesday. Thank you to all who served. The holiday also slowed supply for the week. After \$72Bln in supply for October, we have only seen \$5Bln price in the first two weeks of November, with next week the only full week left in the month before the Thanksgiving holiday week. With the lack of supply we did see a little tightening with credit spreads; let's see how long that lasts. While we have been sitting around \$6Bln on the 30-day visible supply calendar, the last two days saw that jump up by \$10Bln. We expect a busy December similar to what we have seen in the past.

Investors added about \$607 million to municipal-bond mutual funds during the week that ended Wednesday, according to Refinitiv Lipper US Fund Flows data.

- Long-term municipal funds saw outflows of about \$97 million
- Intermediate-maturity municipal funds saw inflows of about \$61 million
- High-yield municipal funds saw about \$21 million inflow

State and local debt maturing in 10 years now yields 96.372% of Treasuries, compared with 109.031% a week ago.

- 10-year ratio was 120.232% a month earlier
- Yields on benchmark 10-year notes rose 1.7bps in the past week to 0.850%
- The gap between yields on short-term and long-term securities flattened by 0.2bps in the past week to 148bps
- Rate for municipalities to swap to 10-year fixed-rate from floating-rate liabilities widened in the past week to 0.713% from 0.684%
- Institutional investors offered \$1.83b for sale through bid-wanted lists in the past week, down 23% from \$2.38b in the previous period, based on data compiled by Bloomberg



- Trading in the municipal market totaled \$31.3b in the past week, down 32% from \$46.4b in the previous period, according to the Municipal Securities Rulemaking Board
- U.S. state and local governments are set to sell more than \$9.83b of bonds next week
- State of New Jersey plans to sell \$4b of bonds; Commonwealth of Massachusetts has scheduled \$1.36b; Port of Oakland will offer \$531.1m and City of Baltimore MD Water Utility Fund will bring \$415.9m to the market next week

#### GENERAL MUNICIPAL MARKET:

- Inflows returned to the space as \$1.2bln came in

  - 10YR (+2bps) vs. Treasury (+7bps)
  - 30YR (unchanged) vs. Treasury (+4bps)
- With the moves, ratios are lower week/week
  - 5YR open ~68% (-12%)
  - 10YR open ~94% (-12%)
  - 30YR open ~97% (-7%)
- Ratios tightened w/w as Treasury yields pushed higher
- Ratios are trading towards their tightest levels since August with the respective moves in both Treasury yields and municipal benchmarks
- Supply continues to be limited, for the most part
- Positive seasonality should create a relatively solid floor for the space in the coming weeks as December through early February generally have more coupon/redemption income than supply
- Inflows continue to skew towards the positive, with the prior six week average being ~\$625mln/week

#### TAXABLE FIXED INCOME MARKET UPDATE:

Pfizer's announcement of strong results on the COVID 19 vaccine trial pushed rates higher. The yield curve flattened, as a vaccine would lessen the need for accommodative Federal Reserve policy. However, COVID cases continue to rise quickly and many cities and states are increasing restrictions. While the intermediate-term economic outlook has improved, the short-term outlook remains cautious, and various Federal Reserve speakers mentioned this. We believe that the Fed is concerned that the intermediate-term economic optimism will cause rates to rise too quickly, especially when current economic conditions are so weak. It is refreshing to write a rates commentary that leaves politics out. We will expect that to resume as we get closer to the Georgia Senate runoff election.

#### **Background**

Section 4-2 of the Grand Island City Code declares the intent of the City Council regarding liquor licenses and the sale of alcohol.

#### **Declared Legislative Intent**

It is hereby declared to be the intent and purpose of the city council in adopting and administering the provisions of this chapter:

- (A) To express the community sentiment that the control of availability of alcoholic liquor to the public in general and to minors in particular promotes the public health, safety, and welfare;
- (B) To encourage temperance in the consumption of alcoholic liquor by sound and careful control and regulation of the sale and distribution thereof; and
- (C) To ensure that the number of retail outlets and the manner in which they are operated is such that they can be adequately policed by local law enforcement agencies so that the abuse of alcohol and the occurrence of alcohol-related crimes and offenses is kept to a minimum.

#### **Discussion**

Roebuck Enterprises dba Chuckwagon BBQ/BYPI, 2504 South Locust Street has submitted an application for a Class "I" Liquor License. A Class "I" Liquor License allows for the sale of alcohol on sale only inside the corporate limits of the city.

City Council action is required and forwarded to the Nebraska Liquor Control Commission for issuance of all licenses. This application has been reviewed by the Clerk, Building, Fire, Health, and Police Departments. See attached Police Department report. Also submitted was a request for Liquor Manager Designation for Esmeralda Castorena, 922 West 4<sup>th</sup> Street, Grand Island, Nebraska. Staff recommends approval of the liquor license contingent upon final inspections and liquor manager designation for Esmeralda Castorena, 922 West 4th Street, Grand Island, Nebraska contingent upon completion of a state approved alcohol server/seller training program.

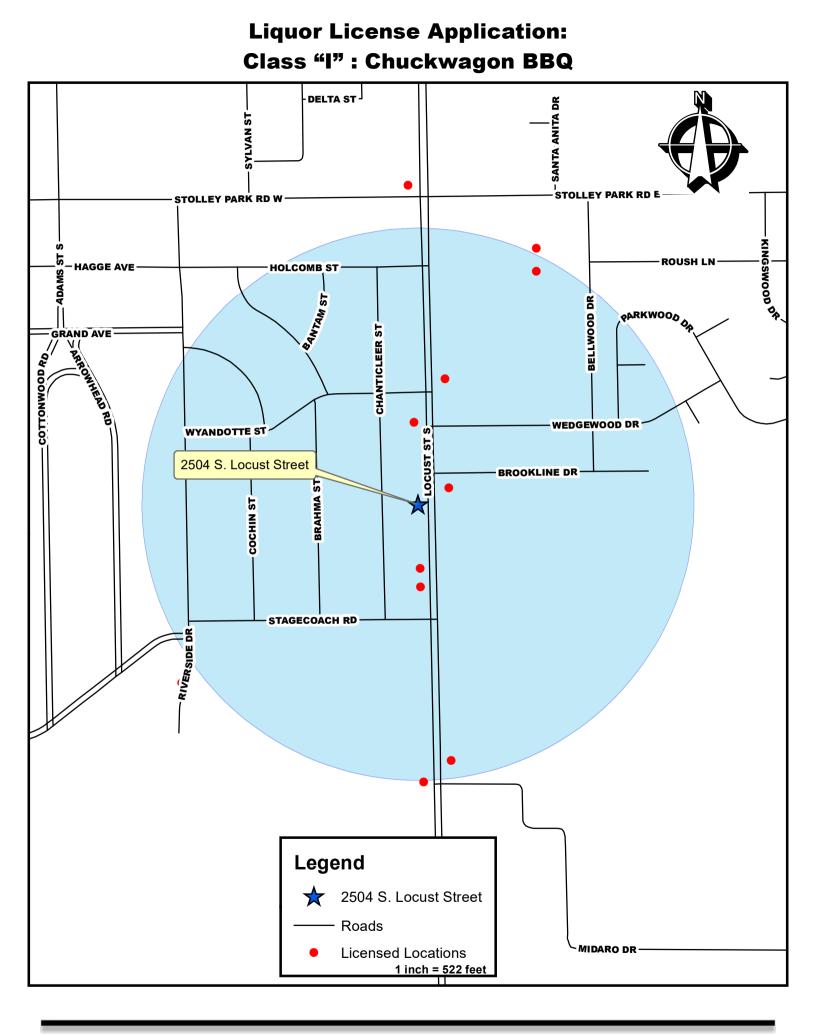

Roebuck Enterprises LLC, Larry Roebuck Jr owner, is planning to open a new restaurant at 2508 S Locust. This is the site of the former Amigos. The space was a restaurant previously (Amigos) but did not have a liquor license. The proposed business name is Chuckwagon BBQ and Pizza. The application is for a Class I Liquor License; beer, wine, distilled spirits, as on sale only.

I noted on the application forms that Roebuck disclosed a couple moving violations, all traffic infractions. The listed manager of the new location, Esmarelda (Esme) Castorena, disclosed one motor vehicle accident and indicated no moving violations associated.

I checked Roebuck and Esme through both Spillman and NCJIS. I found some noteworthy entries in Spillman (local) records, namely, numerous civil disputes and entries for paper service by the Hall Co Sheriff. however, upon reading further, I found that all of those civil or paper service entries were due to Roebuck Jr owning many properties in Grand Island, and landlord/tenet issues. I also found that both subjects have valid Nebraska drivers licenses. I found that neither of them have any outstanding criminal warrants for their arrest. I also checked Larry and Esme through a paid Law Enforcement Only database, which tends to provide mostly identifying information and details of any involved civil issues. I noted nothing of significance. I did find that Roebuck Jr is, or has been, the owner of many other businesses, and has been issued a Liquor License previously. Roebuck was last approved, after investigations, in 2013. I did not search any records prior to that year.

On 12-10-20, at 1300, I met with NSP Investigator Jeromy McCoy at the business. Larry Roebuck Jr was waiting there, and Esme Castorena also responded to speak with us.

Roebuck advised that all his properties are under the ownership of his LLC Chuckwagon Enterprises. He said he has already invested a large amount of money in refurbishing the building and parking lot. Larry Jr pointed out that he also owns the Sonic Drive In further north on Locust, many other properties in Grand Island, and Chucks 2.0 restaurant in Aurora.

McCoy covered Commission concerns and questions. Both subjects advised they have prior liquor sales experience, as Esme was the manager of other Roebuck enterprises in Grand Island, Sam and Louie's, and Flippin Chicken.

Larry Jr said their plan is to be open seven days a week. He said the business hours will be 1100-2300. The business plan is to eventually have approximately 20 employees, with the bulk of those rotating on a part-time basis. Roebuck said he is aware that minors under 19 years of age cannot serve alcohol, and plans to have someone over 21 on duty at all times to dispense any alcohol purchased.

Larry Jr advised he has no current outstanding civil actions against him, and does not have any undisclosed violations or convictions. I discussed

security system issues they should consider, and McCoy explained the various violations that could arise without proper management. Both advised they understood.

Larry Jr explained that he did not personally want to get a liquor license, and advised that he does not consume alcohol. He said that due to the nature of the menu for the new restaurant, namely BBQ and Pizza, he knows that he needs to offer beer sales, because "most people want a beer with their BBQ and Pizza."

The Grand Island Police Department has no objections to Larry Roebuck Jr, as owner of Roebuck Enterprises, receiving a Class I liquor license to serve beer, wine and distilled spirits as on sale only at Chuckwagon BBQ and Pizza, and no objections for Esme Castorena as the liquor manager for the business.

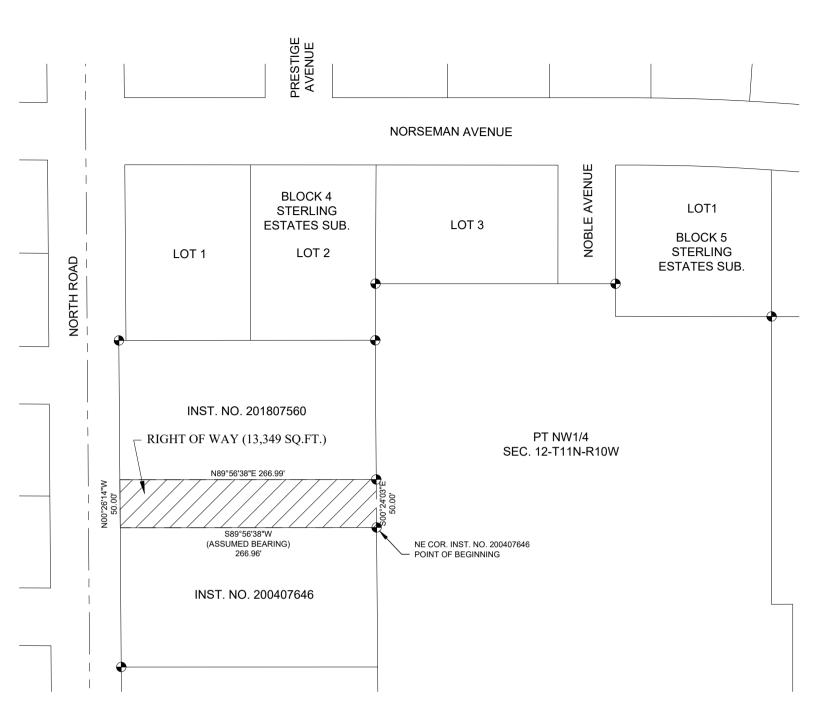

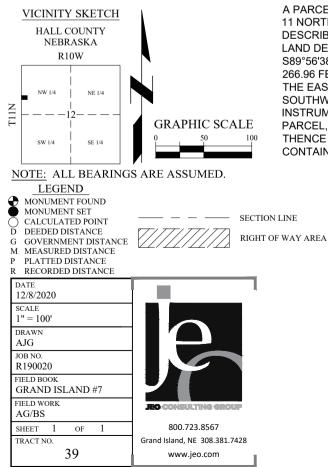

### **Background**

Proposed revisions to Chapter 30 of the City Code have been drafted for City Council consideration. The applicable section of the existing city code with markups is shown in this memo. A clean version of the proposed city code is attached as an ordinance.

### **Discussion**

The previous revision of Chapter 30 was approved via Ordinance No. 9763 dated January 28, 2020, and due to the need to regulate hot water discharges from users of the system further updates are necessary. While collection pipes within the system can handle the higher temperature, this revision to Chapter 30 will limit discharge of any liquid or vapor entering sensitive components and pumps within the wastewater system from exceeding 40° Celsius (104° Fahrenheit). This will protect the integrity of the wastewater collection system in the City.

#### ORDINANCE NO. 9813

An ordinance to amend Chapter 30 of the Grand Island City Code; to amend Section 30-48 Other Prohibited Discharges as now existing, and any ordinance or parts of ordinances in conflict herewith; and to provide for publication and the effective date of this ordinance.

### BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF

#### GRAND ISLAND, NEBRASKA:

SECTION 1. Section 30 of the Grand Island City Code is hereby amended to

read as follows:

#### **§30-48.** Other Prohibited Discharges

No person shall discharge, or cause to be discharged to, any sanitary sewer, any of the following described as substances, water, or wastes unless authorized by the Public Works Director:

(1) Any liquid or vapor having a temperature higher than 65 degrees Celsius (150 degrees Fahrenheit); or which cause the wastewater entering the wastewater treatment facilities; (Lift Stations, Pump Stations, Force Mains, etc.) to exceed 40° Celsius (104° Fahrenheit).

(2) Wastes containing oil or grease of petroleum origin shall be prohibited.

(3) Any gasoline, benzene, naphtha, fuel oil, mineral spirits, commercial solvent, motor oil, or other flammable or explosive liquid, solid or gas, or any other petroleum derivative.

(4) Any water or wastes containing dissolved gases (such as hydrogen sulfide, sulfur dioxide, nitrogen oxides, and ammonia) in concentrations sufficient to cause poisonous or toxic fumes or waste-water, or a malodorous or harmful condition.

(5) Any ashes, cinders, sand, mud, straw, shavings, metal, glass, rags, feathers, tar, plastics, wood, asphaltic materials, cement or concrete, paunch manure, hair and fleshings, entrails, lime slurry, lime residues, beer or distillery spent grains, chemical residues, paint residues, cannery waste, bulk solids, or any other solid or viscous substances, in amounts capable of causing obstructions to flow in sewers or interference with the proper operation of the wastewater treatment works.

(6) Any waters or wastes having a pH lower than 6.0 or higher than 9 at any time, or having any other corrosive property capable of causing damage or being a hazard to structures, equipment and personnel of the wastewater treatment works.

(7) Any waters or wastes containing pollutants in the form of compounds or elements, in solution or suspension, in concentrations exceeding the following:

Unless the permit required for discharge of industrial wastes specifies conditions of pretreatment, concentrations, and volumes.

(9) Any noxious or malodorous gas or substance, capable of creating a public nuisance or hazard to life or preventing entry into sewers for their inspection, maintenance, and repair.

(10) Any waters containing quantities of radium, naturally occurring, or artificially produced radioisotopes in excess of presently existing or subsequently accepted limits for drinking water as established by the national committee on radiation protection and measuring.

(11) Any concentrated dye wastes, spent tanning solutions, or other wastes which are highly colored, or wastes which are of unusual volume, concentration of solids, or composition that may create obstruction to the flow in sewers or interference with the wastewater treatment processes without proper pretreatment and written approval of the director.

(12) Waters or wastes containing substances which are not amenable to treatment or reduction by the wastewater treatment processes employed, or are amenable to treatment only to the degree that the wastewater treatment plant effluent cannot meet the requirements of the NPDES permit.

(13) Any water or wastes containing more than 2,000 mg/L total solids, maximum of 100,000 gallons.

(14) Any water or wastes containing more than 230 mg/L chlorides monthly average concentration, 380 mg/L chlorides daily maximum concentration (November 1 – February 28 (29), 389 mg/L chlorides daily maximum concentration (June 1 – October 31) and 390 mg/L daily maximum concentration (March 1 – May 31).

(15) Any water or wastes containing Conductivity greater than 2,000 umhos/cm monthly average (April 1 – September 30)

(16) Wastes at a flow rate and/or pollutant discharge rate which is excessive over short periods of time so that there is a treatment process overload and subsequent loss of treatment efficiency.

SECTION 2. Section 30 is now existing, and any ordinances or parts of

ordinances in conflict herewith be, and hereby are, repealed.

SECTION 3. This ordinance shall be in force and take effect from and after its passage and publication, within fifteen days in one issue of the Grand Island Independent as provided by law.

Mayor Roger G. Steele called the meeting to order at 7:00 p.m. The following City Council members were present: Mike Paulick, Justin Scott, Michelle Fitzke, Mark Stelk, Vaughn Minton, Bethany Guzinski, Mitch Nickerson, Chuck Haase, Clay Schutz and Jason Conley. The following City Officials were present: City Administrator Jerry Janulewicz, City Clerk RaNae Edwards, Finance Director Patrick Brown, Interim City Attorney Stacy Nonhof and Public Works Director John Collins.

<u>BOARD OF EQUALIZATION:</u> Motion by Minton, second by Paulick to adjourn to the Board of Equalization. Motion adopted.

<u>#2020-BE-6 - Consideration of Determining Benefits for Vehicle Off-Street Parking District #3.</u> Finance Director Patrick Brown reported that the creation of Parking District #3 occurred January 8, 2019. Property owners within the District will be charged a special assessment based on the entire square footage of their buildings. Property owners who have parking within their property that is open to the public, customers or users of building can apply for a \$10/space credit. There is an estimated \$13,000 in potential parking spot credits based on estimated property owners owned parking spots.

The Board of Equalization will approve the special assessments at their full amounts, as stated in the BOE resolution. If a credit is requested prior to billing then the net amount will be billed. If a credit is requested after the bill has been sent, but prior to the bill becoming delinquent the credit will be applied and a new bill can be generated. Staff recommended approval.

Travis Spiehs, 110 West 2<sup>nd</sup> Street questioned his parking assessment inside his building which was not for public use.

<u>Public Hearing on the Annual Report by Grand Island Area Economic Development</u> <u>Corp./Citizens Advisory Review Committee on the EDC Program Plan.</u> Dave Koubek, 1622 Stagecoach Road reported that the Citizen Advisory Review Committee had been conducting regular meetings during the last six months as required by the City Code and Nebraska Statutes. The committee received the annual report from the Economic Development Corporation at its meeting December 3, 2020 and voted to forward it to City Council. EDC President Dave Taylor gave the Annual Report. Staff recommended approval. No public testimony was heard.

Public Hearing on Acquisition of Utility Easement - 1039 North Gunbarrel Road (Merrick County) - Stanley Burst. Utilities Director Tim Luchsinger reported that acquisition of a utility easement located at 1039 North Gunbarrel Road was in order to have access to install, upgrade, maintain, and repair power appurtenances, including lines and transformers.

Martin Acres Subdivision and McLaughlin Manors Subdivisions electrical system was in need of upgrading. The proposed easement would allow the Utilities Department to install, access, operate and maintain the electrical infrastructure at this location. Staff recommended approval. No public testimony was heard.

<u>Public Hearing on Amendment to the Redevelopment Plan for CRA No. 2 located at 1201 South</u> <u>Locust Street (Ray O'Connor)</u>. Regional Planning Director Chad Nabity reported that in 2000 the Grand Island City Council declared property referred to as CRA Area 2 as blighted and substandard and approved a generalized redevelopment plan for the property. Raymond O'Connor representing the entities that own the Fonner View Center at 1201 S. Locust had submitted an application for tax increment financing to aid in the redevelopment of the property.

The redevelopment plan amendment specifies that the TIF would be used to offset allowed costs for acquisition, redevelopment and renovation of the commercial building at this location. The cost benefit analysis included in the plan finds that this project meets the statutory requirements for an eligible TIF project. The bond for this project would be issued for a period of 15 years. The proposed bond for this project will be issued in the amount of \$549,200. Staff recommended approval. No public testimony was heard.

<u>Public Hearing on Re-Adoption of the Grand Island Zoning Map.</u> Regional Planning Director Chad Nabity reported that over the course of 20 years the City of Grand Island had periodically readopted the official zoning map for the City. Chad explained a proposal to re-adopt the City of Grand Island Zoning map was brought forward every 18 months or 2 years. The city of Grand Island occasionally re-adopts the zoning map incorporating all changes since the last re-adoption of the entire map along with changes as recommended. Staff recommended approval. No public testimony was heard.

Public Hearing on Acquisition of Drainage Easements in Crane Valley and Crane Valley Seventh Subdivisions- 3645 W 13th Street (Concord Investments, LLC; Parcel No. 400150174 <u>& 400416182</u>). Public Works Director John Collins reported that public easements were needed to accommodate drainage for development within Crane Valley and Crane Valley Seventh Subdivisions. These subdivisions were located north of Faidley Avenue, west of Concord Avenue. Staff recommended approval. No public testimony was heard.

Public Hearing on Acquisition of Permanent Utility Easement for Sanitary Sewer District No. 544; Ellington Pointe and Westwood Park Subdivisions at 1104 N North Rd (Eiler), 4028 Driftwood Dr (Davis), and 4004 Driftwood Drive (Keophalychanh). Public Works Director John Collins reported public utility easements were needed to accommodate the extension of sanitary sewer to serve an area previously unserved that was located within the new subdivision of

Ellington Pointe and the existing subdivision of Westwood Park. The public utility easements would allow for the construction, operation, maintenance, extension, repair, replacement, and removal of sanitary sewer within the easements. The property owners had signed the necessary documents at no cost. Staff recommended approval. No public testimony was heard.

### **Background**

On average, Grand Island Utilities uses around 200 distribution transformers per year. These transformer purchases can be broken down into three categories: Three Phase Pad-mount, Single Phase Pad-mount, and Single Phase Pole-mount. With procurement lead times of up to 12 weeks, it is beneficial to have a pre-approved price sheet available for ordering. The proposed agreements provide for the purchase of the various transformers by unit pricing through the end of the 2021 calendar year.

### **Discussion**

The Utilities Department evaluated three independent categories of transformers: Three Phase Pad-mount, Single Phase Pad-mount, and Single Phase Pole-mount. The request for proposal was advertised on November 9, 2020. Proposals were received on December 9, 2020, with the following seven vendors submitting proposals:

ERMCO, Inc. Central Moloney, Inc. Kriz-Davis Company Dutton-Lainson Company Graybar Electric Co., Inc. WEG Transformers USA

Using evaluation criteria, which included unit pricing, estimated quantities, and transformer performance, the proposals were reviewed by the department's division managers. A tabulation of the evaluations' factors indicated the lowest evaluated price for the following selections:

### **Background**

Cable purchases can be broken down into two categories: Power Cable and Concentric Neutral Cable. With procurement lead times of up to eight weeks, it is beneficial to have a pre-approved bid sheet available for ordering. The proposed agreements provide for the purchase of cable by unit pricing through the end of the 2022 calendar year.

### **Discussion**

The Utilities Department evaluated two categories of electric cable; Power Cable and Concentric Neutral Cable. The Request for Proposals was advertised on November 9, 2020. Proposals were received on December 9, 2020, with the following vendors submitting proposals:

Wesco Distribution, Inc., Sioux City, Iowa Kriz-Davis Company, Grand Island, Nebraska

Using evaluation criteria, which included unit pricing and cable construction, the proposal was reviewed by the department's division managers. A tabulation of the evaluation factors indicated that the bids submitted by Wesco Distribution, Inc., met the criteria of the specifications.

### **Background**

The City of Grand Island and the Nebraska Department of Transportation have had an agreement for the maintenance of state highways within the City limits dating back to 1970. Maintenance responsibilities for State highways within the corporate City limits are defined by state statute.

The Nebraska Department of Transportation (NDOT) is responsible for the surface maintenance costs of the originally constructed highway lanes through a community and the City is responsible for the surface maintenance costs of any highway widening including parking, additional thru lanes, and dedicated turn lanes.

NDOT performs snow removal on NE Highway 2, US Highway 281, US Highway 34, and the portion of US Highway 30 west of Johnstown Road.

The City performs snow removal on US Highway 30 from Johnstown Road through town to the east City limits at Shady Bend Road.

The statutes provide that the NDOT is to reimburse the City for work the City performs on NDOT's highway lanes and the City is to reimburse NDOT for snow removal on State Highways within the City Limits.

## **Discussion**

The maintenance agreement requires the City to certify that it has completed the maintenance work required by the agreement for the 2020 calendar year.

The net result of this exchange of services is a payment by the Nebraska Department of Transportation to the City of Grand Island in the amount of \$46,562.80.

### Alternatives

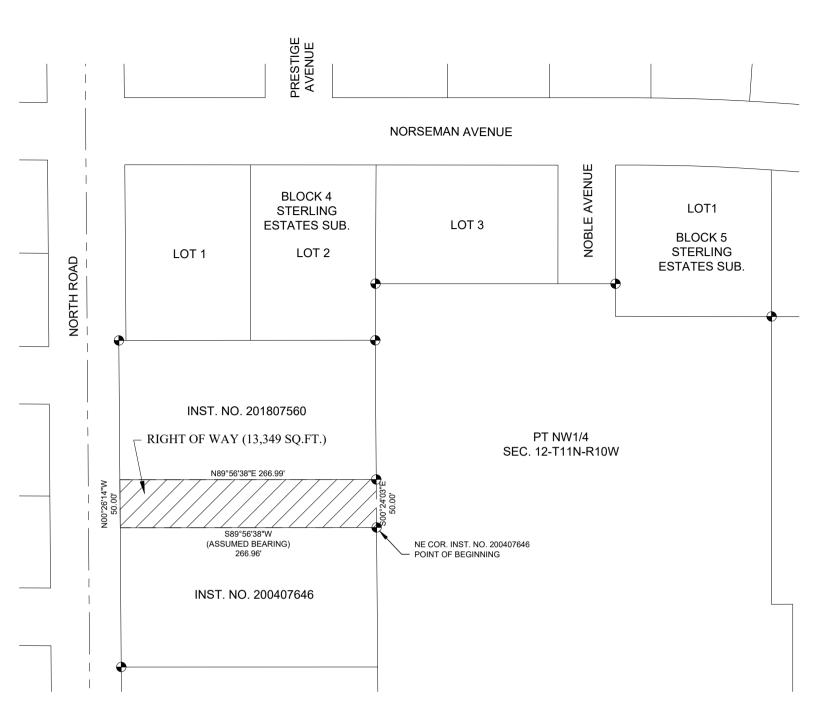

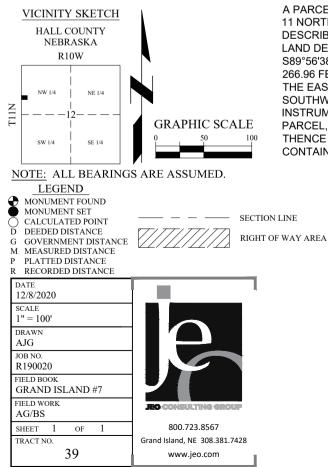

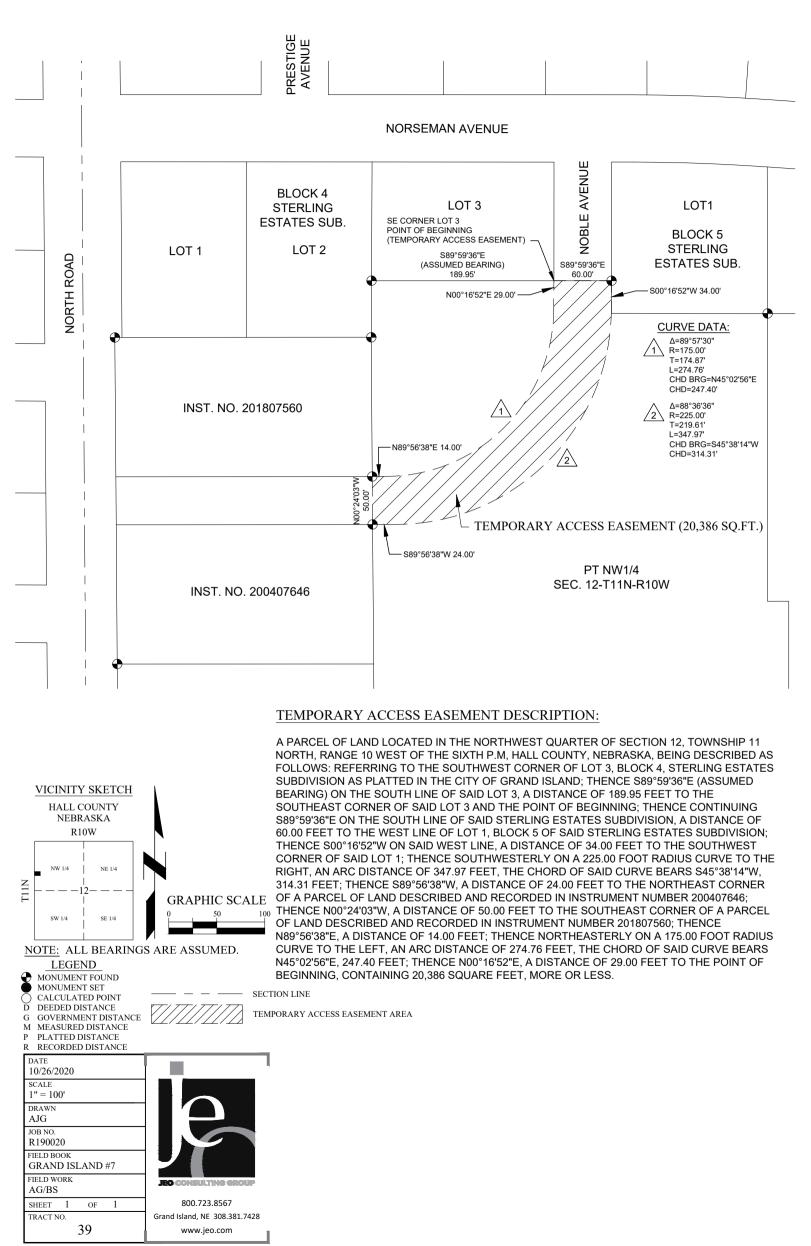

Subject:	Approving Designation of Sole Source Provider for Trojan UV System at the Wastewater Treatment Plant

### **Background**

City of Grand Island Wastewater Treatment Plant Ultraviolet (UV) disinfection system is a Trojan system UV3000 Plus. In the system, there are a total of 4 UV banks, which disinfect effluent water. This system was installed in 2004 and is in need of update to the self-cleaning system which involves replacing the drive cylinder, cleaning canisters and drive bar mechanism. Wastewater Division staff plan to do one (1) bank per year over the next three (3) years to the complete the updates.

### **Discussion**

The City of Grand Island is required to meet State mandated disinfection standards on the treated effluent from the Wastewater Treatment Plant annually May through September. The City UV disinfection is a Trojan UV3000 Plus system which is using the UV disinfection lamps to inactivate pathogens, such as *E. coli*, before discharging the effluent.

Currently, UV disinfection banks are a combination of Trojan and an off brand manufacturer. Over the years, we have experienced operation and maintenance issues using non-Trojan pieces in the Trojan UV disinfection system. Different manufactures offer varied life expectancy and intensity which is key to the UV disinfection process.

MC<sup>2</sup> Inc. of Omaha, Nebraska is the secured territory vendor of Trojan UV parts, materials, and service for the Trojan UV system.

We are requesting that  $MC^2$  Inc to be designated as the sole source provider for Trojan UV parts, materials, and service. This would allow the plant to optimally operate and maintain the UV system. At this time the cost to provide the updates to the self-cleaning system are estimated at \$38,140.17.

### **Alternatives**

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

## **Recommendation**

City Administration recommends that the Council pass a resolution designating MC<sup>2</sup> Inc as the sole source provider for Trojan UV parts, materials, and service.

### **Background**

On July 8, 2014 Community Development Block Grant funds in the amount of \$20,000.00 were loaned to Betti Dugger to assist in the cost of a down payment to obtain the property. The legal description is:

### Lot Eight (16), in Copper Creek 3<sup>rd</sup> Subdivision, in the City of Grand Island, Hall County, NE

The owner is requesting permission from the City to subordinate to the new loan amount and accept and remain in second position. The equity in the property is in excess of the lien amounts held by both the City and the bank.

### **Discussion**

A new lien in the amount of \$106,200.00 with Wells Fargo Bank, N.A. would by law be junior in priority to the City's lien; however, Wells Fargo Bank, N. A., has asked the City to subordinate its Deed of Trust to the new Deed of Trust.
