We received an application from Krystal Carter, of Lincoln, to become the corporate Liquor Manager for all eight Casey's General Stores in Grand Island. Should the application be approved, Carter would replace Tina Krings, of Norfolk, who has been the Liquor Manager of the Grand Island locations since at least 2005.

Carter does not disclose any spouse on her application, and indicates that she has worked for Casey's General Stores since 2009. Carter disclosed three separate addresses since 2001, all in the the area surrounding Lincoln. I utilized our local Spillman database, NCJIS, and a paid Law Enforcement only database to check Carter's background.

Krystal disclosed one traffic contact, which was verified on her Nebraska driver's license history, and her license is valid. There were no active warrants for her arrest. Her application did not include a spouse. There were no items of concern located on the LE Only database, which reveals mostly civil information and financial records.

Krystal Carter has been a Regional Manager for the Casey's organization since 2009. She has previously completed her State mandated liquor training. There are no questionable entries in any of her involvements that I can access. For these reasons, the Grand Island Police Department does not object to Krystal Carter being granted Liquor Manager status for the Grand Island Casey's General Stores.
