Background

The Solid Waste Division of the Public Works Department advertised for one (1) Leachate Evaporation System for Grand Island Regional Landfill, with four (4) potential respondents.

The Grand Island Regional Landfill Leachate Evaporation System will be used for leachate management and to more efficiently evaporate the leachate at the Grand Island Regional Landfill.

Discussion

One (1) vendor provided a submittal for One (1) Leachate Evaporation System for Grand Island Regional Landfill. RWI Enhanced Evaporation of Grand Junction, Colorado was selected as the vendor based on the pre-approved selection criteria.

- Conformance to preferred specifications (60%)
- Price (20%)
- Warranty Offered (20%)

The agreed upon purchase price from RWI Enhanced Evaporation is \$45,088.00.
