Background

The Parks Division budgeted this year to replace one (1) 1995 11' mower, one (1) 1999 utility cart, and one (1) 2005 utility cart. The Parks Division also budgeted to add one (1) ball drag unit and one (1) new utility vehicle lift attachment. The replacement equipment is necessary as the current units are becoming less dependable. The new ball drag unit and lift will help staff be more efficient in keeping up with growing demands.

Discussion

The equipment specifications awarded under the Sourcewell Cooperative Buying Group contract meet the requirements for the Parks Division. Midwest Turf and Irrigation of Omaha, Nebraska submitted a bid for the equipment with no exceptions in the amount of \$183,068.12. The purchase will be funded from capital account 41044401-85615.
