Background

The Parks Division budgeted this year to replace a 2003 and 2006 ½ ton pickups with two (2) new ¾ ton trucks. The replacement pickups are necessary as the current units are becoming less dependable. The new pickups will provide additional years of service to the Parks Division operation and provide additional hauling capacity.

Discussion

The specifications for pickups under State of Nebraska contract meet the requirements for the Parks Division. Anderson Ford of Grand Island, Nebraska submitted a bid with no exceptions in the amount of \$80,095.00 for one (1) new 2022 Ford F250 2 WD Regular Cab and one (1) new 2022 Ford F250 4WD Crew Cab pickups. The purchase will be funded from capital account 41044401-85625.

State of NE Contract No. 15520:

2022 Ford F250 2WD, Reg Cab, Dakota Service Body \$35,962.67

State of NE Contract No. 15524:

2022 Ford F250 4WD, Crew Cab, Belser Tool Boxes \$44,132.33

Alternatives

Recommendation

City Administration recommends that the Council approve the purchase of one (1) new 2022 Ford F250 2 WD Regular Cab and one (1) new 2022 Ford F250 4WD Crew Cab pickups from Anderson Ford of Grand Island, Nebraska. The total purchase price is \$80,095.00.
