- 4. Public Hearing Proposed Substandard and Blight Concerning a study to determine if the proposed CRA Area #33 qualifies as substandard and blighted and to forward a recommendation on the study to the Grand Island City Council. Proposed CRA Area #33 is approximately 220 acres of property in southwest Grand Island west of Prairie Road north of Husker Highway. (C-20-2021GI). See Full Recommendation (Hearing, Discussion Action)
- 5. Public Hearing One and Six Year Street Improvement Plan Hall County Public hearing and action on the fiscal year 2022 to 2027 street improvement plan for the City of Grand Island, Hall County, Nebraska (C-21-2021HC) See Attached Information from County Engineer (Hearing Discussion Action)
