Public Hearing Rezoning-Grand Island Public Hearing regarding the rezoning in the Southeast Quarter of the Southwest Quarter and the Southwest Quarter of the Southeast Quarter of Section 25, Township 11 North, Range 10 west of the 6th P.M., Hall County, Nebraska. This property is located north of Husker Highway and west of Prairieview Street in the City of Grand Island. The request would rezone property from R2 Low Density Residential to RD Residential Development Zone. (C-08-2022GI)

- 4. Public Hearing Zoning Change-Grand Island. Public Hearing to consider a change for property located west of Prairieview Street and north of Husker Highway proposed for platting as Legacy 34 Subdivision from R2 Low Density Residential to RD Residential Development zone. A copy of the proposed changes will be available at the Hall County Regional Planning Department office located at the Grand Island City Hall. (C-08-2022GI) Preliminary and Final Plat for Legacy 34 Subdivision recommendation will be made with recommendation to rezone. This property will be subject of many rezoning applications as it moves forward. The first subdivision is around 6 of the 200 acres. See Full Recommendation (Hearing, Discussion Action)
