The Central Nebraska Humane Society (CNHS) respectfully requests your consideration for Community Redevelopment Authority (CRA) funding for our proposed new facility to be constructed at 1312 Sky Park Road.

The proposed development of our property will consist of a new 17,000 square foot building, new parking, landscaping and removal of our current facility upon completion of our new building. CNHS has proposed a plan that will not only enhance our services but will bring a much needed facility to the city.
