### **Background**

We received notice in June of 2013 from Motorola that they will no longer support portable radios with phone patch buttons after June of 2014. This means that we will not be able to get them repaired by authorized Motorola service centers and will not be able to get parts for them.

The Police Department needs to begin replacing about 100 portable radios currently in use. This is the first purchase of thirty radios to begin replacing the ones currently in use.

#### **Discussion**

We received notice in June of 2013 from Motorola that they will no longer support portable radios with phone patch buttons after June of 2014. This means that we will not be able to get them repaired by our local authorized Motorola service center. It also means that Motorola will no longer supply repair parts for the radios.

The Police Department has approximately 100 Motorola portable radios with the phone patch feature in use at this time. The majority of these radios are 10 years old or older and reaching the end of their life cycle and the Police Department would be faced with beginning to replace them in the near future. The announcement from Motorola has hastened the need to accelerate the replacement schedule.

The Department will purchase 30 new portable radios this year and has plans to purchase 40 more next year. We will hopefully complete the switchover in the third budget year.

The Department received three quotes from authorized Motorola dealers in the region. While they all have the title of Platte Valley Communications, each of these are independently owned dealerships. The Police Department also contacted National Two-

Way Radio, an on-line company. National Two-Way Radio gave a telephone quote of \$790.00 for the Motorola 7550 radio with a standard battery. The lowest quote for the purchase of 30 radios is \$765.00 per radio with a high capacity battery from Platte Valley Communications of Grand Island. The price quote of \$30,990.00 includes 30 extra high capacity batteries, microphones and carrying cases for the radios.

#### **Alternatives**

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

#### Recommendation

City Administration recommends that the Council approve the purchase of 30 Motorola XPR 7550 radios and additional accessories from Platte Valley Communications of Grand Island, NE for \$30,990.00.


