Background

On February 12, 2013, the City Council unanimously approved Resolution #2013-40 - Consideration of Support for Community Proposal to Continue Service for Veterans in a New Facility in Grand Island. The purpose of this Resolution was to state the City's support for the team of volunteers working on a community proposal to continue its service to honor and care for veterans in its new facility in our community.

On May 28, 2013, the City Council unanimously approved Resolution #2013-167 - Consideration of Funding the Community Offering and Approving Authorized Official to Retain the Grand Island Veterans Home. The purpose of this Resolution was to approve the City's \$3 million financial commitment of funding and to approve the Mayor as the authorizing official.

The community offering was submitted to the State on June 11, 2013. A site visit with the State's Site Selection Committee and its advisers occurred Friday, June 14, 2013. The Site Selection Committee was tasked with evaluating and recommending a site for the new Central Nebraska Veterans Home.

On June 21, 2013, Resolution 2013-186 - Consideration of Providing Responses to Veterans Home Site Selection Committee Questions and Concerns was unanimously approved by the City Council. The purpose of this Resolution was to formally address matters raised during the site visit and to confirm information and fully meet the needs and expectation of the State.

Discussion

The purpose of the study session is to promote greater openness, more citizen awareness and more public engagement of a decision that may likely affect generations to come.

Council leadership should have ample time to gain a greater understanding of the community's desire for potential engagement of efforts that may occur to alter the State's recommendation to move the Grand Island Veterans Home to Kearney. An understanding how this request may affect the City of Grand Island, our community, the State of Nebraska, and the Grand Island Veterans Home members should result.

A funding request seeking tax payer funds in the amount of \$5,000 to research options has been tendered by the Grand Island Area Chamber of Commerce to the City of Grand Island in conjunction with the Home for Our Heroes Committee.

Conclusion

This item is presented to the City Council in a Study Session to allow for any questions to be answered and to create a greater understanding of the issue at hand.

Dear Mayor and Councilmembers:

Since the State announced its decision to recommend to the Federal government that the Grand Island Veteran's Home be relocated to Kearney, the GI Home for Heroes Committee has been working diligently to explore various alternatives that would represent the interests of Veterans by retaining the Home in Grand Island.

The Committee has concluded that there are a number of significant legal and regulatory considerations that support the retention of the Home in Grand Island. The Committee believes that these provisions can serve as the basis to affirm Grand Island's position in support of Veterans and their interest in preventing the relocation of the Home.

In order to properly represent this position and serve as an advocate for our Veterans, the Committee believes it is prudent to engage representation for legal services to undertake a thorough examination and full evaluation of the governing statutes, regulations, and processes.

In the last 24 hours, a former Grand Island resident and past board chair of the Chamber, has stepped forward and submitted a proposal to assist Grand Island with this examination and evaluation. Don Dunn with Remboldt Ludtke will provide these same services at a significantly reduced price (\$15,000). Inasmuch as Don has a personal investment in seeing Grand Island be successful in this initiative and the cost savings are significant, we propose to engage Remboldt Ludtke for legal services.

Since the GI Home for Our Heroes Committee is not a legal entity, the Chamber of Commerce will likely be the contracting entity (subject to Chamber Board approval on August 14, 2013). It should be noted that the Chamber is a not-for-profit member organization and is not subsidized by tax dollars. However, we do believe it is appropriate to research and analyze the community's options and have committed to providing the same administrative and management services moving forward as with the proposal process. The Committee has recommended that funding be as follows: County - \$5,000, City - \$5,000, Chamber of Commerce - \$2,500, and Grand Island Area Economic Development Corporation - \$2,500. The contract for legal services is contingent upon funding approval from the aforementioned partners.





RESOLUTION 2013-167

WHEREAS, on March 4, 1887 the Nebraska Legislature passed an Act for the establishment and maintenance of the Nebraska Soldiers' and Sailors' Home to be located in Grand Island; and

WHEREAS, that facility is now known as the Nebraska Veterans' Home and has been continuously located in Grand Island for more than 126 years; and

WHEREAS, the Nebraska Veterans' Home located in Grand Island was the first in the State of Nebraska and has served as the model for other Veterans' Homes constructed and located in Bellevue, Norfolk, and Scottsbluff; and

WHEREAS, the people of Grand Island have supported the Nebraska Veterans' Home, its residents, and all veterans by initially purchasing and donating 640 acres of land for the Home's location; and

WHEREAS, the people of Grand Island have supported the Nebraska Veterans' Home, its residents, and all veterans, through sponsoring activities at the Home, constructing and maintain veterans' memorials throughout the community, and organizing and financing the Heroes' Flight program; and


WHEREAS, the people of Grand have supported the Nebraska Veterans' Home and its residents which have included veterans of the nation's armed conflicts since the Civil War and veterans who served in peacetime; and

WHEREAS, in 2012 the State of Nebraska announced it would construct a new Veterans' Home and solicited proposals from cities in Central Nebraska for its location; and


WHEREAS, the people of Grand Island will be submitting a proposal to retain the Nebraska Veterans' Home as this City is the best choice for that facility given Grand Island's lengthy and unfailing support for the Veterans' Home, its residents, and all veterans; and

WHEREAS, part of that proposal will include a statement of financial support for the Nebraska Veterans' Home and authorization approving the Mayor as the authorized official.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GRAND ISLAND, NEBRASKA, that the City of Grand Island commits itself to providing financial support for the retention of the Nebraska Veterans' Home in an amount not to exceed three million dollars and authorizing the Mayor as the authorized official.



RESOLUTION 2013-186

WHEREAS, State Senator Mike Gloor, Mayor Jay Vavricek, Hall County Board of Supervisors Chair Pam Lancaster, Home for Our Heroes Chair Cindy Johnson, former EDC President Marlan Ferguson, Public Works Director John Collins and Planning Director Chad Nabyty assembled Friday, June 14, 2013 with the State Veteran's Home Site Selection Committee; and

WHEREAS, during the site visit questions were raised concerning City plans and intentions concerning certain City services and infrastructure; and

WHEREAS, representatives of the Site Selection Committee indicated their interest in certain assurances with respect to City plans; and

WHEREAS, the Grand Island Home for Our Heroes Committee requested the City Council formally and expeditiously address these matters on behalf of the community of Grand Island; and

WHEREAS, the Mayor and City Council wish to formally address these matters in an affirmative manner to confirm information and fully meet the needs and expectation of the State; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GRAND ISLAND, NEBRASKA,

- 1) Regarding the drainage swale adjacent to the Veterans Cemetery, the drainage swale acts as an overflow to the storm water detention cell south of Veteran's Memorial Avenue, and usually only contains storm water runoff during large rain events. This swale is currently isolated west of the proposed site along Webb Road, and would not have any adverse impacts to the development of the conceptual layouts of the site. Since the majority of the land around the proposed Veteran's Home site has been removed from the flood plain and is above the Base Flood Elevation, storm water runoff is not anticipated to impact development of the site.

There are several options that can be evaluated by the City and Department of Administrative Services (DAS) to relocate the drainage around the cemetery, including grading of a new ditch, installing storm sewer, or a combination of both. Any of these alternates can be designed so that there are no negative impacts to the proposed Veteran's Home site.


The City will work with the State to address this matter. In addition, the City clarifies the funding source for this project is a portion of the \$4 million committed by the Grand Island community.

- 2) Future street improvements will be subject to State approval and the City will work with the State in the event the State plans any changes on the proposed site.

- 3) Regarding the grade elevation of the site, as the Federal Emergency Management Agency documented in its May 28, 2013 Letter of Map Amendment Determination Document (Removal), in excess of 45 acres is above the floodplain elevation and, as at any building site, one to two feet of fill for pad site and general grading for drainage purposes would be necessary. A natural borrow area would be established onsite to supply borrow material for the project.
- 4) Regarding the widening project of Veterans Memorial Avenue to five lanes, the hike and bike trail project along the north side of Veterans Memorial Avenue from Webb Road to Broadwell Avenue and the pedestrian-activated signal crossing 1,000 feet east of Webb Road, these improvements are designed to improve vehicular and pedestrian/member safety. In particular, the hike and bike trail project provides for member access to retail locations to the west as well as to the south, and leisure activities at Eagle Scout Lake, Veterans Athletic Fields and United Veterans Club.
- 5) Regarding the potential for use of a geothermal heating system, such systems have been successfully used in Grand Island. Fluids in a closed loop system do not interact directly with each other or the soil or groundwater and therefore, drawing contamination toward the site or drawing contaminants into the building is highly unlikely. The City will work with the State to answer any questions if the design for the Veterans Home incorporates a geothermal heating system; no city permits are required for State building projects on state-owned property.
- 6) Regarding the potable irrigation well, City water is available and would be used at the site so the abandonment of the irrigation well may occur and would have no impact.
- 7) Regarding concern over the possible presence of contamination in the groundwater that may exist within a portion of the site, the availability of City water will mitigate this.
