#### **Background**

It is customary in December of each year for the Mayor to recommend appointments of Councilmember's to represent the City on various Boards and Commissions. During the December 14<sup>th</sup>, 2004 the Council discussed many concepts concerning Boards, Committees, and Commissions. Most of the discussion centered on the following:

- Determining if any appointments need to be made
- Reviewing the effectiveness of the Boards and Committees
- Determining if new boards need to be created
- Determining if current boards are no longer needed or beneficial
- Reviewing any changes in Boards that may be necessary
- Making suggestions to create stronger and more effective Boards and Committees
- Deciding Council liaisons needed on various Boards and Committees

City Administration has taken the information supplied at the Study Session, discussed the matter with each councilmember and the Mayor and has attempted to bring a plan to move forward concerning this issue.

### **Discussion**

The following actions are proposed to move forward with the management of Board, Committees, and Commissions:

- The Council appointments for the League of NE Municipalities Legislative Committee, Natural Gas Rate Area Committee, and the Local Government Facility Planning Committee have been eliminated.
- The Humane Society, Multi-Cultural Coalition, and Senior Citizen Board have been contacted to ask for their thoughts on adding a Councilmember to their boards.
- Discussions have been initiated concerning the establishment of a Government Efficiency Committee.
- Research has begun on providing a training packet for Board, Committee, and Commission members.
- Research has begun concerning requiring all Board, Committee, and Commission members/staff to sign conflict of interest forms.
