### **Background**

Grand Island City Code Section 17-15 allows for the Collection, Transportation, and Disposal of Garbage and/or Refuse. These permits are effective October 1 through September 30 of each calendar year.

### **Discussion**

Tom and Tommy Ummel, owners of Heartland Disposal, 2423 W. Old Lincoln Highway have submitted an application for a garbage haulers license. All City Code requirements have been met.

### **Alternatives**

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Approve the garbage hauler license for Heartland Disposal.
- 2. Disapprove or deny the renewals.
- 3. Modify the renewals to meet the wishes of the Council.
- 4. Table the issue
