



**LEGAL DESCRIPTION** 

A tract of land comprising a part of the West Half of the Southwest Quarter (W1/2 SW1/4) of Section Twenty Four (24), Township Twelve (12) North, Range Eleven (11) West of the 6th P.M., Hall County, Nebraska, and more particularly described as follows:

Beginning at the southwest of said West Half of the Southwest Quarter (W1/2 SW1/4); thence N00°20'26"E, along and upon the west line of said West Half of the Southwest Quarter (W1/2 SW1/4), a distance of Six Hundred Forty Four and Seven Hundredths (644.07) feet; thence S80°41'14"E, a distance of One Hundred One and Eleven Hundredths (101.11) feet; thence S39°11'15"E, a distance of Two Hundred Eighty Two and Sixty Nine Hundredths (282.69) feet; thence S09°11'17"W, a distance of One Hundred Twenty Four and Fifty Three Hundredths (124.53) feet; thence S88°35'47"E, a distance of Two Hundred Seventy Three and Eighty Five Hundredths (273.85) feet; thence S33°11'35"E, a distance of One Hundred Twenty Four and Sixty Two Hundredths (124.62) feet; thence S01°18'34"W, a distance of One Hundred Eighty Five and Seventy Two Hundredths (185.72) feet to a point on the south line of said West Half of the Southwest Quarter (W1/2 SW1/4); thence N88°56'56"W, along and upon the south line of said West Half of the Southwest Quarter (W1/2 SW1/4), a distance of Six Hundred and Eighteen Hundredths (600.18) feet to the point of beginning and containing 5.648 acres, more or less.

## **DEDICATION**

KNOW ALL MEN BY THESE PRESENTS, that we, Roy D. Stoltenberg and Mary P. Stoltenberg, husband and wife, being the owners of the land described hereon, have caused same to be subdivided, platted and designated as "COTTONWOOD CORNER SUBDIVISION", Hall County, Nebraska, as shown on the accompanying plat thereof, and do hereby dedicate the roads as shown thereon, to the public for their use forever, and the easements, if any, for the location construction and maintenance of public service utilities forever, together with the right of ingress and egress thereto, and hereby prohibiting the planting of trees, bushes and shrubs, or placing other obstructions upon, over, along or underneath the surface of such easements, and that the foregoing subdivision as more particularly described in the description hereon as appears on this plat, is made with the free consent and in accordance with the desires of the undersigned owners and proprietors.
