An application for Liquor Manager Designation for Whiskey Creek Wood Fire Grill, 1016 Diers Avenue, Grand Island, Nebraska in the name of Dominic Montavon was received.

While reviewing Dominic Montavon's application, I noticed that he has lived in Ohio, Indiana, Illinois, Michigan, and Florida within the last ten years. In the spot on the application where it asks if the applicant has ever been convicted or plead guilty to any charge, Dominic listed a DUI in Illinois in 2005. Dominic does not have a Spillman entry, doesn't have any convictions listed through NCJIS and doesn't have any warrants through NCIC.

Since I am unable to run criminal histories for liquor license investigations, I called the Police Department in each city (Columbus, Ohio; Fort Wayne, Indiana; Lansing, Michigan; Peoria, Illinois; Rock Island, Illinois; Port Charlotte, Florida; and Lady Lake, Florida) and asked them for information on Dominic. If the city police department didn't share the same computer system as the county, I spoke to the sheriff's department as well. I learned that besides the DUI that Dominic disclosed, he was also arrested for DUI in Peoria in 1998. Each DUI arrest also had a no insurance charge as well.

Dominic's failure to disclose his other DUI conviction and no insurance charges technically makes the application false according to the Nebraska Liquor Control Act (Part II Chapter 2 Section 010.01). The application clearly asks, "Has anyone who is a party to this application, or their spouse, ever been convicted of or plead guilty to any charge." It further states that a charge includes "federal, state, local law, ordinance, or resolution." The DUI and no insurance arrests (if convicted) would fall under state law. However, the equivalent charges in Nebraska are misdemeanors that don't rise to the level of a Class I Misdemeanor in a specified crime under Nebraska State Statute Chapter 28 that would automatically exclude him from being a liquor manager.

Since I had to call numerous agencies in different states to get the information on the undisclosed charges, I decided to call Dominic and ask him to explain his failure to disclose the additional charges. Dominic confirmed that he was also convicted of DUI in Illinois in 1998. He said the no insurance charges were dropped. He added that he has received two speeding tickets in his life, both of which occurred in Illinois.

Dominic didn't think that the DUI and speeding tickets were recent enough for him to list. I cautioned him to read the application closely and fill it out completed if he ever has to do it again.

I also noticed on the application, Dominic listed that he has worked for Wild West Inc. for the last two years. He listed a local telephone number. However, in the section that asked for residences in the last ten years, he listed that he was living in Florida from 2006 until 2008. Dominic said that he was living in Florida from 2006 until 2008. Dominic said that he was lived Wild West Inc. is the parent company for Whiskey Creek. Dominic worked for two different Whiskey Creek's in Florida. He also advised that the reason he has lived in so many different places over the last ten years is because he is a "franchise opener" who goes around and trains managers.

After getting some clarifications on Dominic's application, the Police Department has no objection to Dominic Montavon being the Liquor Manager for Whiskey Creek.
