Background

On December 11, 2014 the Parks and Recreation Department advertised a Request for Proposals (RFP) for New Clubhouse Windows at Jackrabbit Run Golf Course. The clubhouse currently has four sets of five windows (20 windows total). The existing windows are over thirty years old and have deteriorated.

Discussion

Three firms submitted proposals to supply labor and materials to install new windows.

Pella Window & Doors, Grand Island, NE Nelson Contracting, Grand Island, NE Tech Construction, Lincoln, NE

Staff recommends accepting the proposal from Pella Windows & Doors of Grand Island in the amount of \$17,598.83. Pella proposes to furnish Imervia Series Duracast Fiberglass windows with insulated dual panes. Staff recommends Pella because of their listed experience providing and installing windows, proposed guarantee, approach to the project, and overall value. Dollars were approved in the 2014-2015 City Budget for this project and will be funded by the Golf Course Enterprise Fund Account 51040001-85612.

Alternatives


