Background

Grand Island City Code Chapter 2-23 specifies as follows:

§2-32. Bonds for Appointed Officials

Before entering upon the duties of their employment, the following named appointed officials and employees of the city are hereby required to give bonds and security as provided by law for the faithful performance of their duties, which bonds shall be approved by the city council and shall be given for the following sums:

City Treasurer	\$100,000
Deputy City Treasurer	\$ 50,000
City Clerk	\$ 10,000
City Administrator	\$ 20,000

Discussion

The City Clerk has contacted Mueller Insurance Agency, Inc. of Grand Island, Nebraska who has supplied the bond for City Administrator Marlan Ferguson. See attached.
