Background

The City Council awarded the bid for construction of Sanitary Sewer District No. 528 and No. 530T to Van Kirk Brothers Contracting of Sutton, Nebraska on June 10, 2014.

Any changes to the contract require council approval.

Discussion

Several factors have delayed completion of the project; including inclement weather, problems with dewatering, and subcontractor construction problems that have hindered their ability to reach the contract deadline.

Van Kirk Brothers Contracting is requesting that the final completion date be changed from June 15, 2015 to July 27, 2015 for Sanitary Sewer District No. 528 and from March 15, 2015 to April 24, 2015 for Sanitary Sewer District No. 530T.

Alternatives

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

Recommendation

City Administration recommends that the Council approve extending the completion date to July 27, 2015 for Sanitary Sewer District No. 528 and April 24, 2015 for Sanitary Sewer District No. 530T.
