Background

Water Main Project 2014-W-5 has been completed by The Diamond Engineering Company of Grand Island, Nebraska. The project installed 1,100 linear feet of 16” diameter water main in Airport Road and 2,500 linear feet of 12” diameter water main in Academy Drive. The construction is part of the Utilities Department’s Master Plan to complete the northeast corner of the water system adjacent to the Central Nebraska Regional Airport. A site map of the area is attached for reference.

Discussion

The project has been completed in accordance with the terms and conditions of the contract documents and plans. Their final contract amount for the work was \$251,639.56.

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

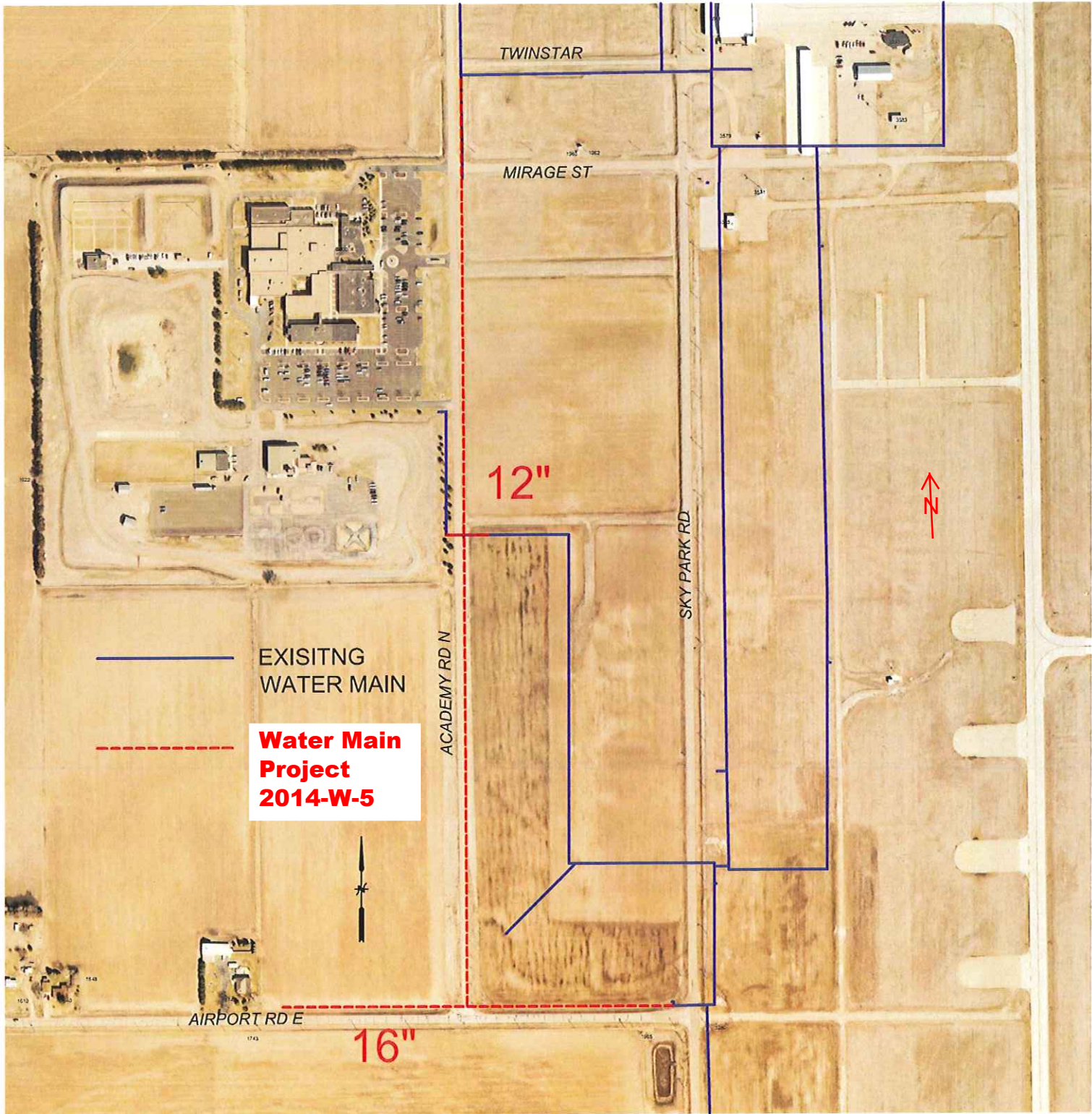
1. Move to approve


