#2010-131 - Approving Bid Award for (3) Cardiac Monitors

Background

Cardiac monitors are utilized at emergency medical scenes to evaluate the patient's heart activity and provide emergency defibrillation, synchronized cardioversion, and external pacemaker therapy, as needed. Cardiac monitors developed over the last several years have the capability of allowing one cardiac monitor to be used by emergency care providers with differing levels of training instead of each level of training needing a different cardiac monitor. These monitors also utilize an alternative technology which is purported to be more effective in correcting ventricular fibrillation, the most common heart rhythm associated with cardiac arrest. The Grand Island Fire Department (GIFD) has an assortment of cardiac monitors on its emergency response vehicles. GIFD has three different models of cardiac monitors of two different brands. This assortment of cardiac monitors require training on each brand and type, two different charging systems, and stocking of two different types of electrodes and defibrillator patches.

Discussion

On April 9, 2010 the Fire Department advertised for bids for cardiac monitors. The City of Grand Island received six bids. The bids were opened on April 28 at 2:00 pm with prices ranging from \$10.775.00 to \$23,558.30 for one unit. Foremost Equipment of Rochester, New York was the lowest responsive bidder at \$10,775 per unit that is in compliance with the specifications. Foremost also offered \$1,000 trade in value for each of the three Zoll cardiac monitors currently owned by GIFD. These three monitors will become surplus following this purchase, so trading them in is appropriate to lessen the overall cost. The total purchase price is \$32,325 less \$3,000 trade in value for a cash outlay of \$29,325. There are sufficient funds remaining in the current budget to complete this purchase.

The transition to multi-skill level use model of cardiac monitor will eliminate the necessity of carrying multiple monitors on the same apparatus. Patient care transferred from personnel on one apparatus to another will gain efficiency due to the interoperability of the same electrodes. Further operational cost savings will be gained by having one style of battery and one style of battery charging system. These proposed monitors are also equipped with capnography which the three being replaced do not have.

The bid from Foremost Equipment is recommended primarily for the following reasons:

- 1. Foremost Equipment is the least expensive of all the bids.
- 2. Added value is gained by having batteries interchange between cardiac monitors and suction devices.
- 3. In-service training demands related to cardiac monitors is lessened by only having to provide training on one cardiac monitor style versus three.
- 4. Capnography capability will be available on all GIFD response units.

Alternatives

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

- 1. Move to approve
- 2. Refer the issue to a Committee
- 3. Postpone the issue to future date
- 4. Take no action on the issue

Recommendation

City Administration recommends that the Council moves to approve the purchase of three (3) cardiac monitors to Foremost Equipment of Rochester, New York for \$32,325 less \$3,000 trade in value for a cash outlay of \$29,325.
