Background

The City of Grand Island, the Village of Alda, and the U.S. Department of Agriculture – Rural Development, entered into an agreement to provide a safe water supply to the Village. The agreement provided for the City to construct the water line and the Village to pay the City a connection fee for that project. A map of the project route is attached for reference.

Van Kirk Brothers Contracting of Sutton, Nebraska was awarded the contract for construction of the referenced project. All piping and related infrastructure has been installed, has been successfully tested, and has been placed in service.

Discussion

The work on the project is complete. Attached is the Certificate of Final Completion and it is recommended the project be accepted by the City of Grand Island.

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

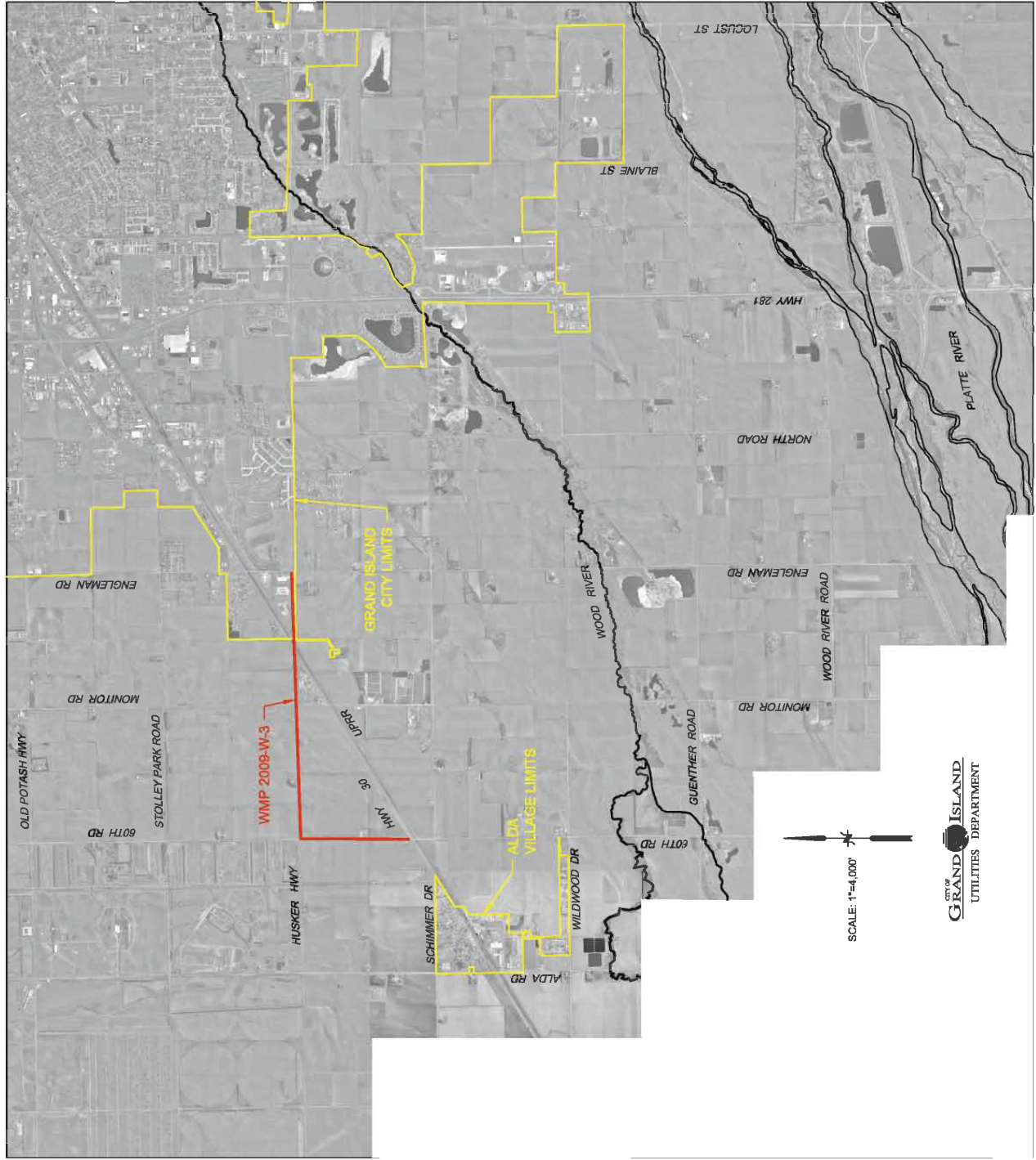
1. Move to approve

Recommendation

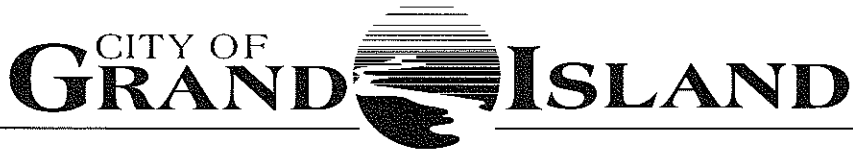




