Background

The Community Redevelopment Authority and the City entered into an agreement for the installation of an 8" water main and service connections along Poplar Street between 9th Street and 12th Street. The project was initiated to help encourage development in the area.

The Diamond Engineering Company was awarded the contract for Project 2010-W-1 for construction of the referenced work. All piping and related infrastructure has been installed and has been successfully tested. The project has been placed in service and provided municipal service for seven new buildable lots. Currently the Habitat for Humanity organization is constructing four single family homes adjacent to the project.

Discussion

The work on the project is complete. Attached is the Certificate of Final Completion and it is recommended the project be accepted by the City of Grand Island.
