COMMENCING AT THE SOUTHWEST CORNER OF LOT SIX (6), TIMBERLINE 2ND SUBDIVISION; THENCE NORTH 02°24′50" WEST A DISTANCE OF 84.39 FEET; THENCE SOUTH 74°59′10" EAST A DISTANCE OF 31.43 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 74°59′10" EAST A DISTANCE OF 901.99 FEET; THENCE SOUTH 89°04′30" WEST A DISTANCE OF 109.24 FEET; THENCE NORTH 74°59′10" WEST A DISTANCE OF 787.54 FEET; THENCE NORTH 02°24′50" WEST A DISTANCE OF 31.44 FEET TO THE POINT OF BEGINNING.

WHEREAS, an Agreement for the public utility easement has been reviewed and approved by the City Legal Department.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GRAND ISLAND, NEBRASKA, that the City of Grand Island be, and hereby is, authorized to enter into the Agreement for the public utility Easement on the above described tract of land.

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized and directed to execute such agreements on behalf of the City of Grand Island.
