Background

The Diamond Engineering Co. was awarded a \$47,797.23 contract on February 13, 2008. The contract was for the replacement of Sanitary Sewer District No. 96, between Yund & Division Streets, from Plum Street to Vine Street, due to the deterioration of the old sewer line that was installed in 1923.

Discussion

The project was completed in accordance with the terms, conditions, and stipulations of the contract, plans, and the specifications. It was completed at a total cost of \$49,881.40. Two areas of the project, one of which was to remove and replace concrete alley returns was overrun by a total amount of \$1,027.62, the other consisted of removing and replacing the existing services and had an overrun of \$1,125.00.

Alternatives

It appears that the Council has the following alternatives concerning the issue at hand. The Council may:

1. Move to approve
2. Refer the issue to a Committee
3. Postpone the issue to future date
4. Take no action on the issue

Recommendation


