Background

The State of Nebraska has approved moving the site of the state fair to Grand Island to operate at the Fonner Park location in 2010. To accommodate the fair, several new buildings will be required, upgrades and refurbishment of existing facilities is needed, as well as enhanced infrastructure support in utilities and streets. To accomplish this, a fund of \$42 million is to be provided, of which a minimum of \$8.5 million is to come from local sources. The necessary aggregate commitments for these monies is \$3 million by 10/1/2008, \$6 million by 2/1/2009, and the total \$8.5 million by 7/1/2009

Discussion

While many local entities, organizations, and groups have been supportive of the fair and may donate to the \$8.5 million local share, it appears that the City would be asked to be a significant contributor. Tonight, we are seeking council direction in this endeavor and what they wish the City's role to be.

- Level of the City's involvement in the project?
- One option would be a City / County bond issue for \$5 million.
- The debt service would require additional tax of some form.
- The bonding and city participation would necessitate that the City be the owner of one or more of the new buildings.
- The City would be obligated, as the largest in the County, to also do a 10% annual match of lottery revenues, estimated at \$200,000 to start.

1 Section 1. Section 2-101, Revised Statutes Cumulative
2 Supplement, 2006, is amended to read:

3 2-101 (1) The Nebraska State Fair Board, formerly known
4 as the State Board of Agriculture, shall hold an annual meeting for
5 the purpose of deliberating and consulting as to the wants,
6 prospects, and conditions of the agricultural, horticultural,
7 industrial, mechanical, and other interests throughout the state,
8 as well as those interests in the encouragement and perpetuation of
9 the arts, skilled crafts, and sciences.

10 (2) The Nebraska State Fair Board may provide in its
11 constitution and bylaws for the qualification and participation
12 of delegates at the annual meeting from such associations
13 incorporated under the laws of the state for purposes of promoting
14 and furthering the interests of participants in agricultural,
15 horticultural, industrial, mechanical, or other pursuits or for the
16 encouragement and perpetuation of the arts, skilled crafts, and
17 sciences, and from such associations as provide for the training,
18 encouragement, and competition of the youth of Nebraska in such
19 endeavors. The annual meeting shall be held in every odd-numbered
20 year at the capital of the state and in every even-numbered year at
21 such location as the board determines. The chairperson of the board
22 shall also have the power to call meetings of the board whenever he
23 or she may deem it expedient. All meetings of the board shall be
24 conducted in accordance with the Open Meetings Act.

25 (3) The ~~state fair~~ Nebraska State Fair shall be held

1 at or near the city of Lincoln, in Lancaster County, under the
2 direction and supervision of the Nebraska State Fair Board, upon
3 the site and tract of land selected and now owned by the state for
4 that purpose and known as the Nebraska State Fairgrounds. The board
5 may, at its discretion, hold or dispense with the holding of the
6 fair, in any year.

7 (4)(a) It is the intent of the Legislature that the
8 Nebraska State Fair be permanently located within the city of Grand
9 Island upon the site and tract of land owned by the Hall County
10 Livestock Improvement Association and known as Fonner Park no
11 later than 2010. The Nebraska State Fair Board shall cooperate and
12 coordinate with the Hall County Livestock Improvement Association,
13 the city of Grand Island, and other appropriate entities to
14 provide for and carry out any plan of improvements to Fonner Park,
15 including the construction of buildings, other capital facilities,
16 and other enhancements, necessary to develop the site as a location
17 suitable for conducting the Nebraska State Fair. Such cooperation
18 and coordination may include financial participation in the costs
19 of new construction and other capital improvements upon Fonner Park
20 and includes the execution of any agreement for site governance,
21 revenue sharing, and facility utilization between and among the
22 Nebraska State Fair Board, the Hall County Livestock Improvement
23 Association, and other appropriate entities.

24 (b) The Nebraska State Fair Board, the Department of
25 Administrative Services, and the Board of Regents of the University

1 of Nebraska shall cooperate with each other and with other
2 appropriate entities to provide for and carry out the plan to
3 relocate the Nebraska State Fair and transfer the Nebraska State
4 Fairgrounds in Lancaster County to the Board of Regents, including
5 activities by the Board of Regents to obtain due diligence surveys,
6 reports, and site assessments at the Nebraska State Fairgrounds in
7 Lancaster County and by the Nebraska State Fair Board in connection
8 with providing marketable title to the same in a form acceptable to
9 the Board of Regents.

20 or devise to any state agency, board, or commission. Therefor,
21 prior to any construction, repair, or maintenance work on such

3 (2) The State Treasurer shall transfer funds from the
4 Cash Reserve Fund to the General Fund upon certification by the

14 transfer one million dollars from the Cash Reserve Fund to the
15 Microenterprise Development Cash Fund.

16 (22) On July 7, 2008, the State Treasurer shall transfer
17 two hundred fifty thousand dollars from the Cash Reserve Fund to
18 the Building Entrepreneurial Communities Cash Fund.

19 (23) On the operative date of this section the State
20 Treasurer shall transfer five million dollars from the Cash Reserve
21 Fund to the Nebraska State Fair Relocation Cash Fund.
