Background History Prior To HEC Becoming A Reality

- How Fonner Park Got Started
- In looking back in time, in the early 1950's there was not a permanent location to host the Hall County Fair.
- In 1953 a group of area farmers, ranchers and civic leaders began meeting to address the need to develop a permanent site for the county fair and host other community and area events.

Fonner Park History (cont)

- As discussions were held it was noted that in Omaha, Lincoln, Columbus, Madison, Mitchell, and South Sioux City all had thoroughbred race tracks and the facilities were also utilized to host other events including county fairs and Lincoln, hosted both the Nebraska State Fair and the Lancaster County Fair.
- At a joint meeting between Fonner Park and the Hall County Agricultural Society they reached a tentative agreement on how both groups could work together.
- Long story short, the Fonner group formed a non-profit public service corporation - the Hall County Livestock Improvement Association, Inc.

Organizational Meetings Were Held

- Ray Baxter, Wilbur Bachman, Bill Hehnke, Dick Stephens, Bill Green, & Jake Grasmick were elected to serve on the first Executive Council with Ray Baxter being chosen to serve as President.
- Land was purchased from Gus Fonner and the facility became known as Fonner Park.
- \$220,000 was raised to purchase land, build a race track, grandstand and barns to be used for racing, and be the location to host the Hall County Fair, and other community events.
- A racing license to conduct thoroughbred race meets was received from the Nebraska State Racing Commission. Race dates were approved for Fonner Park to host its first race meet in 1954.

Successful Race Meets Thru The Years Allowed For Many Improvements To Be Made To Improve The Facility For Racing And To Host Other Events

- The addition of the Fonner Concourse made it possible to have trade shows, banquets, dances and other community events.
- Additional Barns allowed for more horses to be stabled during Fonner Park race meets and created facilities for other livestock events.
- Four additions increased seating in the grandstand by adding a Club House, Turf Club, and Skyline Levels which are also used for community events.

In the Mid 80's, a committee did an assessment of community needs and determined that in Central Nebraska, there was a need for a Civic Center.

- The first attempt to build a 8,000 seat facility was placed on the ballot on November 7, 1989 to be funded by a sales tax and was not approved by voters.
- In 1995 the issue was again on the ballot to be funded again by a ½ percent city sales tax and was not successful.
- After the second election failed to pass, some members of the community continued to talk about ways that this project might become a reality.

In 1997 - Another Committee Was Organized To Identify Needs Of The Community And Set Goals

 In April of 1997, The Heartland Vision 2000 Study Group, Identified An <u>Events Center</u> As The <u>Top Goal</u> To Accomplish.

 In the fall of 1997, motel owners Larry Huwaldt, Ray O'Connor, and Gene McCloud representing Grand Island Motels asked for a meeting with Fonner Park CEO, Hugh Miner, Jr

Motel Owners Ask Fonner To Help (Cont)

- The motel owners shared information concerning the fact that motel occupancy in Grand Island was around 50% during some months of the year, while in Kearney that was not the case. It was their feeling that in order to be more competitive, Grand Island needed to develop a multipurpose facility to host all kinds of activities and events.
- The group asked if Fonner Park would consider taking the lead role in the development of a year round community facility on behalf of the community and motels. Fonner Park had been identified as the best location to build the events center in the first two attempts to make it a reality.

Motel Owners Ask Fonner To Help (Cont.)

- If Fonner Park would provide land for the facility and take the lead role in organizing an effort to raise the funding, the group also indicated they felt that Fonner Park should also manage the facility.
- The motel owners also acknowledged that most event centers lose money and facilities have to be tax supported. They indicated that if Fonner Park would take the lead role, they would meet with other motels to approve requesting the City of Grand Island authorize the implementation a 2% motel lodging tax to be used by the Heartland Events Center.
- The motel lodging tax would be used to cover any operating shortfalls and also for other operational expenses to include marketing and other needs.

Discussions with Motel Owners

- Miner advised the group that he would take their request to the next Fonner Board Meeting for discussion.
- Discussions with the Fonner Board:
 - a. Board indicated that they would be willing to work with the community with the understanding that it would be "community project" and not a Fonner Project.
 - b. In addition, the Funding for the project needs to come from sources other than a half-cent city sales tax.
 - c. Articles of Incorporation will need to be filed with the State of Nebraska for a new subsidiary corporation of Fonner Park to obtain approval from the IRS for the new corporation to become a non-profit 501-C3 corporation. This would allow donors to make a tax deductable contribution to the construction of the civic center.
 - d. A consulting firm will need to be hired to develop a business plan for the facility.

This Project Was A Joint Venture

- The Community Redevelopment Authority provided \$25,000 to assist in the initial development of the project.
- The Grand Island Area Economic Development Corporation provided \$50,000 to develop schematic drawings for the project.
- Business & Community Leaders played a major role in fund raising efforts for the project.
- Area Foundations, Trusts, And Corporations also played a key role in making the center a reality by making major contributions to fund construction of the facility.

MANAGEMENT CONTRACT **Heartland Events Center**

THIS MANAGEMENT CONTRACT ("Management Contract"), dated as of December 1, 2004, by the CITY OF GRAND ISLAND, NEBRASKA, a city of the first class of the State of Nebraska ("City") and FONNER PARK EXPOSITION AND EVENTS CENTER, INC., a Nebraska nonprofit corporation ("Heartland").

- STATEMENT OF PURPOSE. The purpose of this Management Contract is to 1. set forth the terms and conditions under which Heartland will manage an agricultural exposition and events center (the "Project") which is the subject of a Lease Purchase Agreement dated October 9, 2001 (the "Original Agreement"), by and between the City and Heartland, as amended and supplemented by that Addendum to Lease Purchase Agreement dated August 26, 2003 (the "First Addendum") by and between said parties, as further amended and supplemented by that Second Addendum to Lease Purchase Agreement dated as of December 1, 2004 (the "Second Addendum" and collectively, with the Original Agreement and the First Addendum, the "Agreement"). Under the terms of the Agreement, the City is to receive possession of the Project upon issuance of a certificate of substantial completion and thereafter the City requires the services of a manager for the Project. Heartland has been formed for the purposes of serving the City and its inhabitants through, among other things, operating and managing the Project. The capitalized words and terms used in this Management Contract and not otherwise defined herein shall have the same meanings, unless the context or use indicates another or different meaning or intent, as indicated in Section I of the Second Addendum.
- 2. PROJECT **MANAGEMENT** HEARTLAND. Upon issuance of the certificate of occupancy for the Project in accordance with $\mathbf{B}\mathbf{Y}$ the Agreement and the City taking possession of the Project, Heartland agrees to act for the City as manager of the Project and as such manager shall have the following rights, duties and responsibilities in regard to the management of the Project:
 - to provide the Project with such equipment, supplies and other goods (in addition a. to the fixtures and equipment included in the Project under the terms of the Construction Contract which fixtures and equipment as included in the Project are herein referred to as the "Project Equipment") necessary and prudent for the efficient and effective operation of the Project as a public multi-purpose agricultural exposition and events center at Heartland's expense, which additional property shall not constitute a part of the Project or an addition to the Project and shall remain the sole and separate property of Heartland; the parties hereto acknowledge and agree that under the terms of the Agreement Heartland is selling and leasing to the City the Project, including the Project Equipment, and that Heartland shall use and manage both the Project Equipment and the equipment supplies and other goods (as separately acquired by Heartland under the terms of this Management Contract) in connection with its management of the Project.
 - to enter into such agreements as necessary with Hall County Livestock b. Improvement Association, a Nebraska nonprofit corporation ("Fonner Park") for

the use of property, facilities or grounds of Fonner Park during the term of this Management Contract in connection with the efficient and effective operation of the Project as a public multi-purpose agricultural exposition and events center at Heartland's expense, which property, facilities or grounds of Fonner Park shall remain the sole and separate property of Fonner Park subject to any rights therein of Heartland and the City under the Parking Rights and Access Agreement, and to enter into such agreements with Fonner Park for the use of the Project by Fonner Park during the term of this Management Contract as shall be consistent with the terms of this Management Contract;

- c. to manage and operate the Project efficiently and effectively and with proper economy with the goal of maximizing the use of the Project as a public multipurpose agricultural exposition and events center serving the recreational, cultural and economic needs of the City and its residents;
- d. to make any arrangements for the use of all or part of the Project by exhibitors, licensees, concessionaires and users of the Project in the ordinary course of business for such charges or payments as determined by Heartland; provided, however, that any such arrangements shall be cancelable consistent with the requirements of Rev. Proc. 82-26 and, specifically, the requirement that the City have the right to obtain unencumbered fee title to the Project (including additions thereto) and exclusive possession of the Project; in such connection, Heartland agrees, in the event that the City exercises its rights under the Agreement and the Indenture to defease all bonds outstanding under the Indenture, to immediately cancel all encumbrances on the Project, including leases, management contracts and other similar contracts relating the Project or the use of any portion thereof and further agrees to require the parties to any such encumbrances to vacate within not less than 90 days;
- e. to receive all revenues from the general operations of the Project and retain or use such revenues for the general operation of the Project and the general operations of Heartland which are consistent with Heartland's corporate purposes and with the description of its activities set forth in Heartland's Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code as submitted to the Internal Revenue Service on Form 1023 (the "Application");
- f. to receive such portion of the proceeds of any city occupation taxes from the City under Neb. Rev. Stat. § 16-205 which the City and Heartland have separately agreed to and retain or use such proceeds for the general operation of the Project and the general operations of Heartland consistent with Heartland's corporate purposes and the description of its activities set forth in the Application;
- g. to administer, supervise, staff and direct the general operations of the Project at Heartland's expense;
- h. to establish and enforce rules of conduct for supervisors, staff, exhibitors, licensees, concessions, patrons, and any other individual or group using the

Project to protect and preserve the Project and the health, safety and welfare of individuals and the public at Heartland's expense;

- i. to provide maintenance, repair, janitorial and security services necessary and prudent to protect and preserve the Project and provide a clean orderly facility for users, exhibitors, patrons and others; provided, however, that any alterations, additions and improvements to the Project requested by the City shall be paid for by the City and shall become part of the Project subject to the terms of the Agreement;
- j. to pay all expenses for utility services and operational expenses for the Project on a timely basis excluding any local property taxes and special assessments against the Project, which taxes and special assessments shall be paid for by the City in accordance with the terms of the Agreement.
- k. to ensure that the Project, any administrator for the Project employed by Heartland, supervisors and staff and all users of the Project conform to all valid statutes, laws, ordinances, regulations, rules, orders, judgments and requirements of all federal, state, local and other governmental authorities, now or hereafter applicable to the Project;
- 1. to provide the City and Trustee an annual accounting of all receipts and expenditures of the Project, from whatever source derived within sixty (60) days following the close of the fiscal year for Heartland; at the request of the City, such accounting shall include a balance sheet and a profit and loss statement prepared to government accounting standards and audited by a mutually agreeable certified public accounting firm with an office in the State of Nebraska; provided, however, that the cost of such accounting and audit shall be paid for by the City;
- m. to negotiate and administer such licensing, catering and concession contracts and naming, pouring and signage right contracts as Heartland deems appropriate; provided, however, that all such contracts shall comply with the requirements of Rev. Proc. 82-26 and, specifically, the requirement that the City have the right to obtain unencumbered fee title to the Project (including additions thereto) and exclusive possession of the Project; in such connection, Heartland agrees, in the event that the City exercises its rights under the Agreement and the Indenture to defease all bonds outstanding under the Indenture, to immediately cancel all such contracts relating the Project or the use of any portion thereof and further agrees to require the parties to any such contracts to vacate or cease any usage of the Project within not less than 90 days; and
- n. to make such alterations, additions and improvements to the Project requested by the City; provided, however, that the City shall pay for the costs of such alterations, additions and improvements and any such additions and improvements shall become part of the Project and shall be subject to the terms of the Agreement.

The City and Heartland each expect that the Project will provide substantial social, cultural, recreational and economic benefits to the citizens of the City but that the Project will at best operate on a break-even basis. Any net revenue from the operation of the Project shall belong to Heartland as its separate property and shall be used by Heartland in manner consistent with Heartland's corporate purposes and the description of its activities set forth in the Application. Such net revenues shall not inure to or be paid to the City under any circumstances during the term of the Agreement.

- 3. **PROJECT MANAGEMENT; OBLIGATIONS OF HEARTLAND.** Heartland hereby agrees to manage the Project on behalf of the City as an agricultural exposition and events center in such a manner as will:
 - (a) attract agricultural and horticultural fairs, expositions and exhibitions of livestock, farm equipment and farm products;
 - (b) bring in for the enjoyment of the general public of the City cultural and entertainment events that appeal to the general public of the City, including but not limited to:
 - (i) music concerts;
 - (ii) plays and theatrical productions;
 - (iii) other artistic, cultural or educational performing groups; and
 - (iv) professional and amateur athletic events;
 - (c) attract trade shows, meetings, expositions and conventions, including but not limited to:
 - (i) trade shows and meetings, expositions and exhibitions of an agricultural or horticultural nature;
 - (ii) other trade shows and meetings, expositions and exhibitions;
 - (iii) meetings of businesses, nonprofit organizations and governmental entities; and
 - (iv) other conventions; and
 - (d) to promote, conduct and manage all types and kinds of artistic, scientific, athletic, agricultural, horticultural and educational expositions, events, exhibitions, trade shows, meetings and conventions for the development and advancement of the people of the City and its surrounding area.

All such activities shall be carried out in accordance with the corporate purposes of Heartland and the description of the activities of Heartland set forth in the Application. The City shall retain such supervisory control of the Project as may be necessary to insure that the Project is

being operated in the public interest with reasonable charges relating to both the conducting and the attending of events. In connection with such management of the Project, Heartland is authorized to impose or agree to such schedule or schedules of rates and charges for use of the Project as Heartland shall in its reasonable discretion determine appropriate. Any such schedules shall be filed with the City Clerk upon request by the City and shall be deemed approved within thirty days of the time of any such filing. The City shall have the right but not the obligation to review any such filing of schedules of rates and charges as it determines appropriate from time to time but any such review shall be conducted on the basis of the understanding between the City and Heartland as set forth in this Management Contract that Heartland, in undertaking to provide management services hereunder, shall have reasonable discretion to exercise its best business judgment for the operation of the Project for the benefit of the City and its inhabitants. It is further acknowledged and agreed by the parties hereto (i) that the purpose of hiring Heartland as manager is to lessen the burdens of government in connection with the operation and management of the Project; (ii) that Heartland shall have the right to make reasonable charges in connection with the operation and management of the Project, the approval of which shall not be unreasonably withheld by the City; (iii) that the charges which Heartland imposes for use of the Project shall be reasonable and that Heartland shall manage and operate the Project in the public interest. Notice of any contract with respect to the Project having a term in excess of three (3) years entered into by Heartland shall be given to the City. Any contracts entered into by Heartland shall not run with the land as to the Project or commit the City to making any payments thereunder. The contracts made by Heartland listed on Exhibit A hereto attached, without regard to length of term, are hereby approved by the City. Each contract entered into by Heartland after the date of this Management Contract with respect to the Project shall contain the

"Any rights hereunder shall in all events be subject to the requirements of that Lease Purchase Agreement dated October 9, 2001 (the "Original Agreement"), by and between the City and Heartland, as amended and supplemented by that Addendum to Lease Purchase Agreement dated August 26, 2003 (the "First Addendum") by and between said parties, as further amended and supplemented by that Second Addendum to Lease Purchase Agreement dated as of December 1, 2004 (the "Second Addendum" and collectively, with the Original Agreement and the First Addendum, the "Agreement"), including, but not limited to, requirements for cancellation under Rev. Proc. 82-26 and, specifically, the requirement that the City have the right to obtain unencumbered fee title to the Project (including additions thereto) and exclusive possession of the Project."

4. LIABILITY INSURANCE. During the term of this Management Contract, Heartland shall at its own expense maintain comprehensive general liability insurance on the Project and its operation in amounts not less than \$1,000,000 for bodily injury and property damage for each occurrence with an annual aggregate limitation of not less than \$2,000,000. During the term of this Management Contract, Heartland shall also maintain excess liability or umbrella liability insurance coverage on the Project and its operation in an amount not less than \$1,000,000 for bodily injury and property damage for each occurrence and with an annual aggregate limitation of not less than \$2,000,000. Any policy for liability insurance maintained under the terms of this paragraph 4 shall show the City as an additional named insured. Heartland shall provide evidence of such insurance upon request by the City as made from time

to time. The City shall have the right to obtain such additional liability insurance with respect to the Project as it shall determine appropriate from time to time.

- Contract, the parties shall promptly comply with all valid statutes, laws, ordinances, regulations, rules, orders, judgments and requirements of all federal, state, local and other governmental authorities, now or hereafter applicable to the Project as to the manner of use or condition of the Project. In the event compliance with any of the foregoing requires additions, improvements and/or modifications to the Project, Heartland agrees to plan, design and construct such additions, modifications and/or improvements and the City agrees to reimburse Heartland as additional rent under the Agreement for direct expenses of the Project including engineers, architects, contractors, supplies and materials. In connection with any such required additions, improvements and/or modifications, the cost thereof required to be paid by the City shall not include the cost of any services provided by Heartland or its officers or employees.
- 6. **CHOICE OF LAWS.** This Management Contract shall be governed by the laws of the United States and the State of Nebraska and the ordinances of the City.
- 7. **AMENDMENTS.** Any amendment to this Management Contract shall be made in writing, duly approved and executed by the City and Heartland, notwithstanding any verbal or informal understanding or commitment to the contrary.
- 8. STATUS OF MANAGEMENT CONTRACT; SEVERABILITY OF PROVISIONS. This Management Contract represents an independent agreement of Heartland and the City. If any provisions of this Management Contract shall be held or deemed to be or shall, in fact, be inoperative or unenforceable as applied in any particular case, for any reason, such circumstance shall not have the effect of rendering the provision in question inoperative or unenforceable in any other case or circumstance, or of rendering any other provision or provisions herein contained invalid, inoperative or unenforceable to any extent whatever. The invalidity or unenforceability of any one or more phrases, sentences, clauses or paragraphs in this Management Contract contained shall not affect the remaining portions of this Management Contract or any part hereof. Any determination as to the invalidity or unenforceability of this Management Contract or any part hereof shall not affect the validity or enforceability of any other agreements of the parties with respect to the Project, specifically including, without limitation, the Agreement, the Indenture and the Parking Rights and Access Agreement, all of which shall remain in full force and effect in accordance with their respective terms.
- 9. **HEADINGS.** The headings of paragraphs in this Management Contract are to be deemed informational only, shall not be used in construing and shall not be construed as terms, or conditions of this Management Contract.
- 10. **LEGAL NOTICE AND CORRECTION OF DEFAULT.** Either party to this Management Contract shall notify the other in writing if it deems there is a default in any of the provisions of this Management Contract or any related documents. Such notice may be delivered in hand, by first-class U.S. mail or using electronic media, without limitation. The party to whom notice is sent shall have thirty (30) days from the receipt of the notice to respond in writing establishing that there is no default or to correct the condition creating the default. If either party has created a default which is not removed in accordance with this paragraph and

such other provisions of this Management Contract as applied, the non-defaulting party may exercise its rights in the manner provided in this Management Contract or as provided at law or in equity to enforce its rights under this Management Contract. ASSIGNMENT. Heartland agrees that it will not assign its rights under this Management Contract without the approval of the assignment by the City. Consent to any proposed assignment by Heartland shall not be unreasonably withheld by the City, provided that it shall not be deemed unreasonable for the City to require that any such assignment shall be to an organization exempt from taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended, (the "Code") qualified for such exemption under Section 501(c)(3) of the Code.

Heartland covenants that it will not make an assignment of any interest in this Management Contract which would have the effect of causing the interest on the Building Bonds to be includable in gross income under the Code.

12. TERM OF MANAGEMENT CONTRACT. It is the expectation of the parties that this Management Contract will be renewed and continued periodically until all bonds outstanding under the Indenture have been paid in full or satisfied prior to final maturity in accordance with the terms of the Indenture. The term of this Management Contract shall be deemed to commence upon execution by the City and Heartland and shall extend for a period of one year. At the end of this initial one-year term, the term of this Management Agreement shall be automatically extended for additional consecutive one year periods, until terminated as hereinafter provided. Anything in this Management Contract to the contrary notwithstanding, the term of this Management Contract including any and all extensions shall automatically terminate in the event that the City exercises its right to obtain unencumbered fee title to the Project under the terms of the Indenture and the Agreement, in accordance with and under the requirements of Rev. Proc. 82-26. Heartland shall have the additional right to terminate this Management Contract at any time upon one hundred twenty (120) days' notice to the City.

- 13. RELATIONSHIP OF PARTIES. The relationship between the City and Heartland is that of beneficial owner (the City) and agent manager (Heartland) and nothing contained in this Management Contract is intended to or shall be deemed to create any other relationship.
- 14. This Management Contract has been dated for convenience of reference as shown on the initial page hereof. This Management Contract has been actually executed on the date set forth below for each of the parties.





Background

The first restriction on open burning in the City of Grand Island was passed in 1909, this prohibited the burning of paper or refuse in the streets and alleys of the City. Then in 1951 an ordinance was passed that restricted burning to set hours on certain days of the week. This was then amended on June 1, 1972 to permit open burning on Wednesday and Saturday. At this time the Fire Chief was also empowered to ban open burning when warranted.

On July 8, 1991 Ordinance 7729 was approved that banned open burning in the City with very few exceptions.

At the May primary election in 1994 the citizens of Grand Island overturned the ban on open burning by approving a ballot referendum. This resulted in council passing Ordinance 7993 on May 23, 1994 allowing for open burning for two weeks in the fall and two weeks in the spring, with a written permit. This resulted in the Fire Department issuing an average of 43 permits per day during the two week burn period. Since that time only minor modifications have been made to the ordinance.

It should be noted that according to State Statute 81-520.01 there is a state wide ban on all open burning, with few exceptions.

Discussion

The issue with open burning of yard waste in the City of Grand Island is twofold, with the first being environmental. During the burn period there is a consistent haze over the city, which infiltrates homes and causes health issues. The burn period is also used by some people to burn non-yard waste, which includes treated lumber, old carpet and furniture. These products produce toxic gases which linger in the smoke.

The second issue is public safety. These fires are not always burned according to safety regulations, this leads to the possibility of spreading to structures. Fires are also started in city right of ways, which include under power lines. They also generate unnecessary complaint calls to 911; this in turns commits our limited emergency response resources.

It should also be noted that Grand Island is one of three surveyed cities in Nebraska that allows open burning.

So why change the open burning policy now?

During the early 1990's this issue came before the council several times before being placed on the 1994 primary ballot. One of the arguments at the time was that the citizens had no way of disposing of yard waste without paying a fee. Since this time, a composting program has been established at the Transfer Station located on Old Potash, which allows for dumping of yard waste at no cost. This allows for an environmentally responsible way of disposing yard waste.

People's attitudes have also changed over the years and we are now more aware of how our actions affect others. People have come to expect clean air, free of smoke, year round. We want a safe and clean living environment for ourselves and children.

I would like to offer the following options to be considered. The open burning policy can be left as is, with no modification. Adopt state statute and allow the fire chief to set stringent regulations and charge a \$10 fee for each permit. This would allow burning year round or stay with the two week policy.

My recommendation is to adopt state statute and not allow open burning within the city limits, except for the following special considerations: live fire training, essential agricultural operations, the destruction of dangerous or storm damaged materials and diseased trees, clearing of land for development and recreational or cooking fires.

Since this issue had been voted on by the people it will require a 2/3 vote by the council to overturn.

Conclusion

This item is presented to the City Council in a Study Session to allow for any questions to be answered and to create a greater understanding of the issue at hand.

It is the intent of City Administration to bring this issue to a future council meeting for the consideration of approving the recommendation to discontinue open burning in the City of Grand Island.

History of Open Burning

- Wednesdays and Saturdays. At this time a complete To until July, 1991 burning was allowed on burn ban was issued.
- March 17, 1994 council voted to place a repeal of burn ban on the May ballot.
- allow opening burning for two weeks in the fall and May 23, 1994 council passed Ordinance 7993 to two weeks in the spring.
- Currently open burning of yard waste is allowed two weeks in October and two weeks in April.

City Ordinance 7993

- Allows for the burning of yard waste for two weeks in the fall and two weeks in the spring. Fire Chief may modify time period due to inclimate weather.
- Material must be indigenous to the property. Must be yard waste (leaves and brush), no household waste.
- This ordinance is in effect up to the city limits. Fire Chief has no jurisdiction outside of city limits.

State Statute 81-520.01

- Statewide open burning ban on all bonfires, outdoor rubbish fires, and fires to clear land.
- Local fire chief may waive burning ban by issuing a written permit, and may charge a fee for the permit not to exceed \$10.

Problems with Open Burning
