Regular Meeting May 16, 2016

The Scottsbluff City Council met in a regular meeting on Monday, May 16, 2016 at 6:00 p.m. in the Council Chambers of City Hall, 2525 Circle Drive, Scottsbluff. A notice of the meeting had been published on May 13, 2016, in the Star Herald, a newspaper published and of general circulation in the City. The notice stated the date, hour and place of the meeting, that the meeting would be open to the public, that anyone with a disability desiring reasonable accommodations to attend the Council meeting should contact the City Clerk's Office, and that an agenda of the meeting kept continuously current was available for public inspection at the office of the City Clerk in city hall; provided, the City Council could modify the agenda at the meeting if it determined that an emergency so required. A similar notice, together with a copy of the agenda, also had been delivered to each council member, made available to radio stations KNEB, KMOR, KOAQ, and television stations KSTF and KDUH, and the Star Herald. The notice was also available on the city's website on May 13, 2016. Mayor Meininger presented an appreciation plaque and key to the City to retiring City Manager Rick Kuckkahn and thanked him for his many years of dedication and service to the City of Scottsbluff. Mr. Kuckkahn commented that the city staff has been great to work with and helped make his job easier. Their devotion and work ethic are second to none. Over the years, he has worked with a number of City Councils and they have all been very positive with a "can do" attitude. He expressed his appreciation to the City Council and added that he will remain in Scottsbluff, as he loves this community.

Shawn Overeynder, Twin Cities Development (TCD), gave the Council an update of the projects and businesses with whom they are currently working. He explained that they are working on a new regional marketing strategy with the City of Scottsbluff and Thomas P. Miller and Associates. They have also been working on what our industry demands are and any unsatisfied areas and building business cases to determine what businesses they want to pursue. By attending job fairs, they are hoping to add populace to the area, sharing information about the advantages of living here, such as a lower cost of living and a better, cleaner quality of life. Mr. Overeynder recently attended a NETA conference which focused on the growing trend of food manufacturing. TCD is still looking at retail development. Currently there are three site selectors looking at the area, based on leakage.

TCD staff recently completed two grant proposals: Downpayment and Repair Assistance, \$130,000.00 to help with the purchase and repairs of properties for first time homeowners; and Rental Acquisition, \$755,000.00 (WNHO Project) for the 2nd phase of the Eastwood Apartments on East Overland. Council Member Colwell asked what the main draw is for the eCenter. Mr. Overeynder commented that it's mainly access to workshops to help build business, accounting assistance for businesses, and helping new business owners get through the gap through mentorship. They are currently putting together an advisory panel with long term entrepreneurs along with successful business owners in Scottsbluff. One of the selling points for locating here is jobs.net which is a big selling point. Millennials are now looking at quality of place, rather than relocation because of job.

Becky Horne, representing the Scotts Bluff County Tourism Old West Balloon Fest Committee presented a \$10,000.00 request for KENO funds to match an \$18,000.00 marketing grant for the event. She explained that they are trying to find a location for the Balloon Glow event in Scottsbluff. They are working with a Balloon Meister to find the best location for this event which will include 15 - 30balloons. A portion of the KENO funds have been allocated to be used for matching grant funds. Moved by Mayor Meininger, seconded by Council Member Shaver, "to approve the request from the Scotts Bluff County Tourism for \$10,000.00 of KENO funds for the Old West Balloon Fest," "YEAS", Gonzales, Meininger, McCarthy, Shaver and Colwell "NAYS", None. Absent: None.

Triniti Burgner, Special Events Coordinator, presented a request for a Community Festival Permit to Council including information regarding a street dance and beer garden event planned for June 18, 2016, on Broadway and the downtown mini park. This event is co-sponsored by Bluffs Broadcasting, who will be bringing in a national act for the street dance, along with local bands. The event will be 5:00 p.m. to approximately 11:00 p.m. The bands and the event are "family friendly". Council Member Shaver asked why there is a beer garden if it's a family friendly event. Ms. Burgner explained that having the outdoor event with a beer garden draws a larger crowd. The beer garden section is fenced off, with no minors allowed. The Scottsbluff Police Department and security staff from the Elks will be present to assure the safety of the attendees. Moved by Council Member Gonzales, seconded by Mayor Meininger, "to approve the Community Festival Permit for Scottsbluff Parks and Recreation at the Broadway Mini Park, parking lot, including street closures, vendors, and noise permit for a Downtown Street Dance on June 18,

2016 from 5:00 p.m. to 1:00 a.m.," "YEAS", Gonzales, Meininger, McCarthy and Colwell "NAYS", Shaver. Absent: None.

Regarding the Special Designated Liquor License for the downtown street dance, City Manager Johnson explained that only employees and volunteers with the Elks will be serving alcohol. Robin Darnall, Elks Manager, explained to the Council that this beer garden will give the Elks an opportunity to participate in a community event. They will fence off a 60' x 60' space which will be secured with two sets of fence and a narrow entrance to prevent people from entering without showing their identification. No one under the age of 21 will be admitted and everyone will have wrist bands. They will have experienced bar tenders from the Elks serving the beer and checking ID's. They will have security guards inside and outside of the beer garden. Moved by Council Member Gonzales, seconded by Mayor Meininger, "to send a positive recommendation to the Nebraska Liquor Control Commission for a Special Designated Liquor License for the Elks Lodge and Scottsbluff Parks and Recreation to serve beer at a Community Festival event at the Broadway Mini Park and connecting streets on June 18, 2016 from 5:00 p.m. to 1:00 a.m.," "YEAS", Gonzales, Meininger, McCarthy and Colwell "NAYS", Shaver. Absent: None.

City Manager Johnson explained the request for payments for the improvements to Cleveland Field. After publication of the Agenda on Friday 5/13/16, staff was informed that Mr. Hessler received \$6880.00 for the fencing for this project. The cost of the backstopping was slightly higher than reflected on the invoice. Therefore, \$2790.51 of outstanding invoices remain for this project. Council previously allocated \$15,000.00 for this project. Council Member Shaver commented that it appears we have paid about \$28,000.00 on this project. Mr. Johnson commented that in addition to the repairs, we also had engineering work completed for this site. Mr. Johnson noted that there is still a possibility of getting additional funds to pay for this project, however we have invoices that need to be paid. Mayor Meininger commented that the repairs that were completed were necessary. There were some additional, unexpected costs, but needed to be completed to ensure the safety of the field and facility. Mayor Meininger asked the City Manager to bring back a policy regarding the process of paying for outside projects so we can remain consistent and avoid paying more for future projects. Moved by Mayor Meininger, seconded by Council Member Gonzales, "to approve paying outstanding invoices in the amount of \$2790.51 from KENO funds, for improvements to Cleveland Field, which may be reimbursed to the City if outside funding sources are received," "YEAS", Gonzales, Meininger, McCarthy and Colwell "NAYS", Shaver. Absent: None.

Mr. Johnson presented the final plat for property owned by Rod Adams Farms on Highland Road. The owners are proposing to separate 2.7 acres of their 73 acres as an Ag Estate Dwelling. The remaining land will remain agricultural. Scotts Bluff County Roads Department has approved access to the property from Highland Road. The plat meets the necessary requirements of an Agricultural Estate Dwelling (AED) in an Agricultural Zoning District. Planning Commission recommended approval of the final plat at their May 9, 2016 meeting. Moved by Council Member Shaver, seconded by Council Member McCarthy, "to approve the final plat for an Ag Estate Dwelling Plat for a tract of land situated in the north half of the NE ¼ of Section 30, Scotts Bluff County, Nebraska and authorize the Mayor to sign the certificate," "YEAS", Gonzales, Meininger, McCarthy, Shaver and Colwell "NAYS", None. Absent: None.

City Manager Johnson presented the Ordinance authorizing the sale of six acres of city owned property to James Becker for \$51,000 which was approved at the May 2, 2016 meeting.
