The Scottsbluff City Council met in a regular meeting on October 2, 2017 at 6:00 p.m. in the Council Chambers of City Hall, 2525 Circle Drive, Scottsbluff. A notice of the meeting had been published on September 29, 2017, in the Star Herald, a newspaper published and of general circulation in the City. The notice stated the date, hour and place of the meeting, that the meeting would be open to the public, that anyone with a disability desiring reasonable accommodations to attend the Council meeting should contact the City Clerk's Office, and that an agenda of the meeting kept continuously current was available for public inspection at the office of the City Clerk in City Hall; provided, the City Council could modify the agenda at the meeting if it determined that an emergency so required. A similar notice, together with a copy of the agenda, also had been emailed to each council member, made available to radio stations KNEB, KMOR, KOAQ, and television stations KSTF and NBC Nebraska, and the Star Herald. The notice was also available on the city's website on September 29, 2017.

Mayor Meininger presided and City Clerk Dickinson recorded the proceedings. The Pledge of Allegiance was recited. Mayor Meininger welcomed everyone in attendance and encouraged all citizens to participate in the council meeting asking those wishing to speak to come to the microphone and state their name and address for the record. Mayor Meininger informed those in attendance that a copy of the Nebraska open meetings act is posted in the back of the room on the west wall for the public's review. Starr Lehl, Economic Development Director, presented the Proclamation naming October as Manufacturing Month. Ms. Lehl explained that manufacturing is second only to agriculture as the most important industry in the State of Nebraska. The City of Scottsbluff and Western Nebraska Community College will host the First Annual Manufacturing and Distribution Summit on October 12, 2017, at the Harms Center. Mayor Meininger read and signed the Proclamation.

Moved by Mayor Meininger, seconded by Council Member Shaver, "to remove from the table the Business Promotional Event Permit for Shots Bar and Grill, which was tabled at the September 18, 2017 Meeting," "YEAS", Colwell, Meininger, McCarthy, Shaver, and Gonzales, "NAYS", None. Absent: None.

City Manager Johnson explained that the event permit for Shots Bar & Grill is a family friendly event which will include a car show and chili cook off. They would like to block off the 1700 Block of Broadway and a portion of 18th Street from Broadway east to the alley. A representative from Shots explained that they plan to have a small band play music, and would like to use the Downtown Plaza area for children activities and the chili cook off. Proceeds from the event will be donated to a non-profit foundation. Mayor Meininger suggested that they talk with the other business owners on the 1700 Block of Broadway to inform them of the event, since the street will be closed. Moved by Mayor Meininger, seconded by Council Member Shaver, "to approve a Business Promotional Event Permit for Shots Bar & Grill to hold a car show and Chili Cook-off on October 7, 2017 from 10:00 a.m. to 6:00 p.m. at 18th

Street and Broadway, and the Downtown Plaza, to include street closure and a noise permit for music," "YEAS", Colwell, Meininger, McCarthy, Shaver and Gonzales, "NAYS", None. Absent: None.

City Manager Johnson presented the amendments to the City's Comprehensive Plan, to provide for improvements to the 23 Club Baseball Park and other park facilities in the City of Scottsbluff. Moved by Mayor Meininger, seconded by Council Member McCarthy, "to approve the amended Parks and Recreation section of the City's Comprehensive Plan, "YEAS", Colwell, Meininger, McCarthy, Shaver and Gonzales, "NAYS", None. Absent: None.

Mr. Johnson presented the Resolution authorizing the Mayor to submit an application for a grant from the Land and Water Conservation Fund to make improvements to the 23 Club. We are applying for the maximum grant amount of \$165,000 which will be used to build a club house with ADA accessible restrooms and a facility for concessions. Staff has been working with Geoff Nemnich, 23 Club President, and Jack Baker, Engineer with Baker and Associates, on this worthwhile project. Staff is recommending approval of the Resolution to enable submission of the grant application.

Council Member Shaver asked where the sponsor match for the project will come from. Mr. Johnson explained that the match will be from in-kind contributions and council contingencies. Our intent is to use potential funding from the land sale and from the private sector. The City currently has adequate funds to match the grant. We can use donations for matching funds as well. Mr. Baker added that their goal is to apply for the grant first, then continue working on fundraising for additional improvements to the 23 Club Baseball Park.

Moved by Council Member Colwell, seconded by Mayor Meininger, "to approve Resolution No. 17-10-01 regarding the application for federal assistance from the Land and Water Conservation Fund program for the purpose of building improvements at the 23 Club Baseball Field," "YEAS", Colwell, Meininger, McCarthy, Shaver and Gonzales, "NAYS", None. Absent: None.

RESOLUTION NO. 17-10-01

WHEREAS, the City of Scottsbluff, Nebraska proposes to apply for federal assistance from the Land and Water Conservation Fund program for the purpose of reconstruction of the Clubhouse and Concessions Building at the 23 Club Baseball Complex.

WHEREAS, the Mayor is authorized to sign documents to obtain financial assistance, including a Project Agreement with the State of Nebraska and the National Park Service.

WHEREAS, the City of Scottsbluff, Nebraska has the financial capability to operate and maintain the completed project and park property is a safe, attractive and sanitary manner.

WHEREAS, the City of Scottsbluff, Nebraska will not discriminate against any person on the basis of race, color, age, religion, disability, sex or national origin in the use of any property or facility acquired or developed pursuant to the project proposal, and shall comply with the terms and intent of Title VI of the Civil Rights Act of 1964, P.L. 88-354 (1964), and any of the regulations promulgated pursuant to such Act by the Secretary of the interior and contained in 43 CFR 17.

WHEREAS, no property acquired and/or developed under this project shall, without the approval of the Nebraska Game and Parks Commission and the Secretary of the Interior, be converted to other than public outdoor recreation use. And, such approval may be granted only if it is in accord with the then existing Statewide Comprehensive Outdoor Recreation Plan (SCORP), and only upon such conditions as deemed necessary to assure the substitution of other outdoor recreation properties of at least equal fair market value and of reasonable equivalent usefulness and location.

WHEREAS, the City of Scottsbluff, Nebraska will replace the land in the event of a conversion in use in accordance with Section 6(f)(3) of the Land and Water Conservation Fund Act of 1965, as amended.

NOW BE IT RESOLVED, the City of Scottsbluff, Nebraska agrees to comply with all State and Federal requirements and standards where they can be applied in making the facilities developed under this project, and all future projects, accessible to and usable by the disabled.

City Manager Johnson gave a progress report on the downtown improvement projects, as requested at the last Council Meeting. Over the last several weeks, city staff has been pouring concrete in the downtown plaza area to accommodate the skating rink/stage area which is now complete. Costs have been reduced greatly with the assistance of our city staff. We are also working with the Scottsbluff High School Skills Class to build the shed which will be used as an ice skate rental facility; and working with students who need community service volunteer hours to help rent skates. NPPD is working to get electricity to the shed location, and also for lighting across the top of the ice skating rink. This electricity source will also be used for the irrigation controls. Staff is also working with a fencing company to provide functional, aesthetic fencing around the rink.

The Downtown Plaza plantings are complete, thanks to Amy Seiler with the Nebraska Forest Service and NEXT Young Professionals who assisted city staff in the planting process. The conduit for irrigation was recently completed, so the remaining plantings for the bulb-outs should be completed by this fall.

The Business Improvement District board has been working with city staff to prioritize the developments of the downtown amenities. There has been some significant interest by business owners to sponsor something in the plaza.

Council Member Gonzales asked what has been done to help slow the traffic on Broadway. Mr. Johnson commented that the bulb-outs have helped to slow the traffic. We have increased the patrol of the area and we have the electronic speed lights posting the speed of motorists. Council Member Gonzales commented that he didn't think we needed to have downtown patrolled as much when we had the traffic lights in operation. Mr. Johnson noted that the traffic counts downtown currently do not warrant re-installing the street lights.

Chief Spencer added that he has received minimal complaints about the traffic downtown. He added that stop lights downtown statistically increase the number of accidents. The electronic signs collect data, so he can provide a report to the Council regarding traffic speeds. He has received a few speeding ticket reports, so he knows the officers are patrolling this area. Council Member Shaver would like to receive reports on the traffic conditions on a regular basis. Mayor Meininger commented that the number of injury ambulance calls to Broadway have gone down recently.

Katie Bradshaw, resident, commented that she supports the development downtown, however added that many people do not know what the plan is for downtown, and she would suggest providing more information regarding changes from the original plan for the plaza. She also commented that the

traffic change is easier for pedestrians with only two lanes of traffic; however, she wanted to know if the "pedestrian crossing" signs in the crosswalks would be replaced. Ms. Bradshaw also asked about the plans for a public restroom. Public Works Director Mark Bohl explained that the pedestrian crossing signs were all eventually driven over and destroyed. They are expensive to replace, however, they can be replaced if the Council directs him to.

Regarding downtown restrooms, Mr. Johnson explained that some of the funding sources have not allowed us to do some of the things we wanted to do, including restrooms. We are looking for non-traditional funding to accomplish some of these goals. In the meantime, we are working with local merchants to provide restroom accommodations. He emphasized that we are implementing the original plan for the downtown plaza area. We are working to minimize costs and involve more city staff, so the development is taking longer than originally planned.

Council Member Colwell suggested revisiting the downtown plans since there have been some changes. Mr. Johnson explained that we have made some changes and encountered some issues along the way; he feels it's important at this point to implement these improvements to show progress.

Mayor Meininger presented the item to consider appointing Council Member Gonzales to the East Overland Steering Committee as a Council Representative. Council Member Shaver commented that he's not sure if it's appropriate to have a Council Member or a Community Redevelopment Authority (CRA) member serve on the Steering Committee. There are no legal conflicts with this appointment, however. Council Member Gonzales explained that he has heard from members of the East Overland Steering Committee, and they felt there was not adequate leadership, which could be provided by a member of the City Council. In addition, a Council Member would be able to provide information back to the City Council.

City Manager Johnson explained that the East Overland Steering Committee is strictly an advisory committee. Economic Development Director Lehl explained that the Steering Committee was very anxious to see the progress of the East Overland improvement projects; the City has received seven applications to date. Council expressed a need to have someone on the Steering Committee who owns property on East Overland.

The grant applications for the East Overland grants will be reviewed first by administration, then by the CRA, with the final approval from the City Council. Funds would be reimbursed after the work by the applicant is complete.

CITIZEN'S ADVISORY COMMITTEE MINUTES September 27, 2017 Scottsbluff City Hall

A meeting of the City of Scottsbluff Economic Development Citizen's Advisory Committee was held on September 27, 2017, at Noon, at City Hall, 2525 Circle Drive, Scottsbluff, NE.

Committee members in attendance were Mark Harris, Diane Vandenberge, and Sam Mark. Also in attendance were Nathan Johnson (City Manager/Program Administrator), Starr Lehl (City Economic Development Director), Liz Hilyard (City Finance Director) and Rick Ediger (Deputy City Attorney).

Chairman Harris opened the meeting. It was noted that a copy of the Nebraska Open Meetings Act is posted on the south wall of the Council chambers. There were no changes in the agenda or citizens with unscheduled business.

The first order of business was to approve the minutes of the April 6, 2017 meeting. It was moved by Mark and seconded by Vandenberge that the minutes of that meeting be approved. Voting yes: Harris, Vandenberge and Mark. Voting no: None.

The next order of business was to review Job Credit Reports from Economic Development Program participants. Due to the fact that confidential information would be presented, it was necessary for the Committee to go into executive session for the purpose of reviewing Job Credit Reports. At 12:07 p.m., it was moved by Vandenberge and seconded by Mark that the Committee go into executive session and include all City staff currently present at the meeting. Voting yes: Harris, Vandenberge, and Mark. Voting no: None. The executive session began at 12:07 p.m.

At the conclusion of the executive session, the meeting was reconvened in open session at 12:34 p.m. The Chairman indicated the Committee had received substantial information concerning various program recipients during the executive session, but no action had been taken during the executive session. The next order of business regarded discussion concerning functioning and progress of the City's Economic Development Program. Economic Development Director Lehl introduced

Laurie Richards, who is the Nebraska Film Officer, as a consultant to the Nebraska Department of Economic Development. Ms. Richards and Ms. Lehl reported on the filming of the current Coen brothers film at FX Ranch in Sioux County. At least 250 people were involved in the production. Lodging, meals and other supplies and equipment were all provided locally. The Local Option Municipal Economic Development Act includes in the definition of "Qualifying Business" any business which derives its principal source of income from the production of films, including feature, independent, and documentary films, commercials, and television programs. The purpose of bringing this to the Committee was to determine if there would be any interest in adding film production as a Qualifying Business under the City of Scottsbluff's Plan. Ms. Richards indicated she could provide examples of policies from the Cities of Freemont and Valentine, both of which had added film production to their plans. In particular, Freemont provides for definite levels of performance and for payment in arrears. The Members of the Committee generally were in favor of the concept. However, it was the consensus of the Committee that we should find out more information from the other cities that give grants for film production and bring it back to this Committee at a future meeting.

Economic Development Director Lehl gave her report on her activities since she started working for the City on August 1st. Committee Members were encouraged to contact her with ideas, and to provide input at any time.

With respect to action items, it was moved by Mark and seconded by Vandenberge that the Job Credit Reports from the above businesses be accepted. Voting yes: Harris, Vandenberge, and Mark. Voting no: None. Notification of this action by the Committee will be given to all of the above businesses.

It was moved by Vandenberge and seconded by Mark that staff prepare report to City Council indicating that the reporting businesses were in substantial compliance with their Agreements under the Program. Voting yes: Harris, Vandenberge, and Mark. Voting no: None.

There being no further business, it was moved by Mark and seconded by Vandenberge to adjourn the meeting. Voting yes: Harris, Vandenberge, Mark, Meyer and Philips; Voting no: None. The meeting was adjourned at 1:08 p.m.

Economic Development Program Report of Citizen's Advisory Committee Meeting September 27, 2017

The Economic Development Citizen's Advisory Committee met on September 27, 2017, and issues this report to the City Council based on action taken by the Committee at those meetings. All reports received between the last Committee meeting and June 30, 2017, were reviewed.

As of June 30, 2017, the City had awarded 44 grants to businesses since the beginning of the Program. 13 are active, with the rest having previously been terminated, earned, repaid, or settled. 2 more grants have been approved since June 30, 2017. Annual Reports were reviewed and accepted for the following businesses for the periods ended June 30, 2017:

Vertex Aulick Manufacturing Fusion Ranch EagleMed SWBC Regional West Medical Center

Each of the Committee Members and the Council Members have been provided with Job Report Summaries as of June 30, 2017. The information concerning actual employee numbers for each business are, however, confidential and cannot be released as to specifics without the permission of the individual businesses. The following general information can, however, be provided in summary form:

- 1. Job creation grants and loans netting almost \$9 million (after repayment of amounts granted and repaid) have been awarded to businesses since the beginning of the program (1/1/96). The City has also invested in two water extension projects and a drainage project benefitting the areas near the airport which include Fusion Ranch and the EagleMed Hanger. In addition, the City's program has made a significant contribution to job training in this area through assistance to Western Nebraska Community College.
- 2. From the businesses that continue to be in operation or have been sold to entities who have maintained the business, over 1,350 jobs have been created or retained through the assistance of the City's program. Additional jobs were created for a period of time by businesses that have since been closed.
- 3. From the funds that have been awarded to businesses for job creation, the amount lost from businesses that did not survive as of the last reporting period is approximately 5.5%. Many of the businesses that have benefited from our program have produced jobs well in excess of their job commitment to the City. If these additional jobs were factored in, the impact of the net loss from failed businesses is much less.

- 4. City Staff and the Citizen's Review Committee are satisfied with the information provided by the businesses reviewed at the Review Committee meeting. With a couple of exceptions, all businesses with active grants are current in their reporting.
- 5. The Committee has been encouraged to consider adding businesses which derive their principal source of income from the production of films as a Qualifying business, in light of the Coen brothers film which took place at a ranch in Sioux County. It was pointed out that a significant amount of money had been spent with local hotels, motels and merchants in connection with the production. The Committee requested that staff obtain information as to what other communities are doing so that this information can be considered in the future.

We already started reconditioning our property with the initial investment of signage for our building which was installed in August of 2017. We are requesting additional fund to complete the following:

Broken Windows-We have two broken windows facing the street that need to be replaced. We received a quote from a local contractor in the amount of \$481.07

Roof Improvement-We require to fix the roof to the building. We need two different aspects of the roof fixed.

- A. Rubber roof directly above the floor of the store. We received a quote from a local company in the amount of \$4924
- B. Shingles facing the street need to be replaced. This needs to be done for two purposes: To protect the roof but also to help improve the façade which faces overland and 8th avenue. The estimate we received for this is from the same roofing company and its equivalent to \$4130.

Outside Painting-to help match the outside work we have done with the sign, windows, and single roof, we will be repainting the outside of the business. The estimate we received from a local company is \$1700.

Repair Sunken Floor and Room improvements-One of the biggest needs our property needs is to fix the sunken floor in our storage rooms inside the store. Humidity and the weight of the items have sunken the floor that is nearest the back yard. It is in desperate need of repair. We received an estimate from a local contractor in the amount of \$7139, however; as the estimate states and because of the nature of the work we expect the cost to rise to up to \$10,000. It is nearly impossible to tell how much damage the humidity has caused so we are expecting a higher expense than the current conservative estimate. We been recommended by the contractor to keep this 'cushion' for a worst-case scenario.

Ambient Lights-We will be installing ambient lights in the outside of the store to give it a unique look and call attention. For years, customers have been telling us that its hard to find us. We want to do something unique and we found a look out of state that will bring life to our business. The cost of the lights is \$45 per foot. We will need 30 feet to cover the windows we want to highlight for a total of \$1350. We do not know the cost of the installation yet but, we are estimating it to be around \$1000

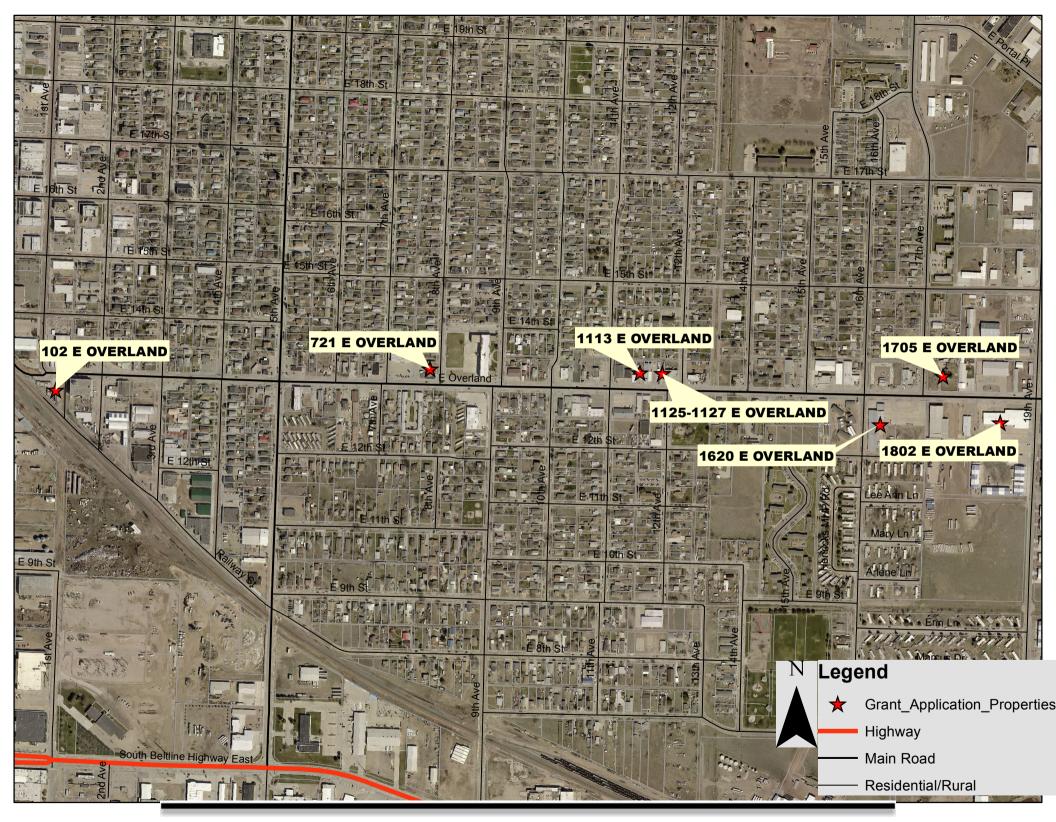

MASTER ACTIVITIES COOPERATION AGREEMENT

This Master Activities Cooperation Agreement ("Agreement") is entered into on _______, 2017 by and between the City of Scottsbluff, Nebraska, a municipal corporation ("City") and the Young Men's Christian Association of Scottsbluff, Nebraska, a Nebraska non-profit corporation ("YMCA").

- 1. Purpose of Agreement. The City and YMCA both desire to explore opportunities to cooperate and share resources with one another to provide recreational and community activities in the Scottsbluff area (each a "Cooperative Activity"). Upon the agreement of each party's role regarding a specific Cooperative Activity, the parties shall enter into an Addendum to this Agreement specifying each party's role and contribution of resources and any other applicable terms. All terms of this Agreement shall also apply to each Cooperative Activity unless specifically amended in an Addendum.
- 2. Independent Contractor. The City and YMCA shall remain independent contractors in conducting Cooperative Activities pursuant to this Agreement. City employees providing services relating to a Cooperative Activity shall at all times remain employees of the City and shall not be deemed employees of the YMCA for any purpose whatsoever. YMCA employees providing services relating to a Cooperative Activity shall at all times remain employees of the YMCA and shall not be deemed employees of the City for any purpose whatsoever. Neither party shall be required to withhold or in any way be responsible for the payment of any Federal, State or local income or occupational taxes, FICA taxes, unemployment compensation or workers' compensation contributions, vacation pay, sick leave, retirement benefits, or any other payments for or on behalf of the other party or its employees.
- **3. Insurance**. Each party shall list the other party as an additional insured on the party's general liability and errors and omissions insurance policies.
- **4. Termination**. This Agreement shall be effective until terminated by either party upon 60 days written notice to the other party. No termination of this Agreement shall relieve either party of its obligations incurred while this Agreement was in effect.
- **5. Authority.** The CEO of the YMCA shall have authority to negotiate the terms of and sign any Cooperative Activity Addendum on behalf of the YMCA. The City Manager shall have authority to negotiate the terms of and sign any Cooperative Activity Addendum on behalf of the City.

6. Miscellaneous.

- a. This Agreement represents the complete understanding between the parties concerning the subject matter of this Agreement, and no other promises or agreements relating to the subject matter of this Agreement shall be binding unless they are made in writing, including an Addendum and signed by both parties.
- b. This Agreement shall be construed and enforced according to the laws of the State of Nebraska.

- c. This Agreement may not be assigned or transferred by either party without the written consent of the other party.
- d. This Agreement shall be binding upon and inure to the benefit of the successors and permitted assigns of both parties.
- e. If for any reason, whatsoever, any one or more of the provisions, or any portion of any provision, of this Agreement shall be held or deemed to be inoperative, unenforceable, or invalid as applied to any particular case or in all cases, such circumstances shall not have the effect of rendering such provision invalid in any other case or of rendering any other provision of this Agreement inoperative, unenforceable, or invalid.

Tri-City Interlocal Stormwater Program Agreement for the Cities of Gering, Scottsbluff and Terrytown

This agreement is made pursuant to the Interlocal Cooperation Act, Neb. Rev. Stat. §§13-801ff, by the City of Gering, City of Terrytown and City of Scottsbluff, hereinafter called "Tri-City Stormwater", "the parties", "the partners", or "the partnership". All of the parties are municipal corporations established pursuant to the laws of the State of Nebraska.

ARTICLE I. PURPOSE OF THE AGREEMENT

The purpose of this agreement is to enable the parties to cooperate with one another to facilitate their performance of their obligations under General NPDES Permit NER 310000, the laws of the State of Nebraska and the United States of America regarding the management of stormwater. This cooperation shall include but not be limited to:

- 1. Jointly meeting and consulting with one another about stormwater management issues.
- 2. Developing and recommending to their governing bodies appropriate legislation addressing storm water management issues.
- 3. Developing appropriate public educational materials and programs regarding stormwater management issues.
- 4. Jointly purchasing items from time to time for the parties' common use in carrying out the purposes of this agreement.
- 5. Jointly hiring consultants, accountants, attorneys and such other persons with such expertise as the parties may decide would be beneficial.

ARTICLE II. GOVERNING BOARD

- To conduct the joint and cooperative undertaking, there is hereby established the "Tri-City
 Stormwater Board ("the Board"). The governing body of each party to this agreement will designate
 an officer or employee to serve on the Board. A certified copy of the resolution or other document
 designating such representative shall be furnished the Board to be included in the books and
 records of the Board.
- 2. The Board shall carry out the functions described in Article I herein, and such other functions as it may decide appropriate to accomplish the purposes of this Agreement, including but not limited to:
 - a) Defining storm water management program service needs (operation and maintenance and regulatory compliance) and desired levels of service for each party.
 - b) Providing access to staff and appropriate administrative services and data for understanding the needs for the defined service and desired levels of service; and information on existing commitment in storm water management.
 - c) Making recommendations for facilitating outreach, education, and public meetings to inform citizenry about comprehensive Storm Water Management Program service needs and desired service levels. Each Party will hold public meetings as required and the parties will provide staff to support these meetings.
 - d) Viewing and evaluating the results of the Storm Water Management Program and the funding for the program.
- 3. Board shall meet from time to time as the parties may agree.
- 4. It is contemplated that Chapter 84, Article 14, Revised Statutes of Nebraska (pertaining to public meetings) is applicable to such meetings. Each party shall meet the requirements of the Chapter 84,

- Article 14, Revised Statutes of Nebraska by the same procedures it uses in publicizing meetings of its City Council.
- 5. Each party acknowledges that it has its own obligations in the management of storm water. It is contemplated that each party will incur expenses of various kinds, including but not limited to staff time, equipment, engineers, consultants, and attorneys to meet these obligations. No party will be entitled to reimbursement for such expenses.

ARTICLE V. PUBLIC EDUCATION, OUTREACH AND TRAINING ACTIVITIES

City of Scottsbluff will manage and coordinate education, outreach and training activities for the partenership. This will include programming, activities and events for audiences common to all three communities.

ARTICLE IV. FUTURE COSTS

The parties contemplate that additional costs may be incurred in carrying out the purposes of this agreement. Such costs may be shared among the parties according to the following formula, 60/35/5. This is determined by the population of each party according to the most recent federal census. Each party pays the proportion of the cost that its population bears to the total population of all parties. No costs shall be incurred for any individual expenditure that will result in any party's share being more than seven thousand five hundred dollars unless a specific agreement is made.

ARTICLE V. JOINTLY PURCHASED ITEMS FOR INDIVIDUAL OR COMMON USE BY THE PARTIES.

The parties contemplate that it may be desirable from time to time to jointly purchase items for the individual or common use of the parties. Any item purchased for common use will be deemed to be the property of the city that purchases the item but will be available for the use of all parties who participated in the purchase, under such terms as the parties may agree.

ARTICLE VI. MISCELLANEOUS.

- 1. This agreement shall be effective January 1, 2018 until December 31, 2023 or the duration of General NPDES Permit NER 310000, whichever comes later.
- 2. Any party may withdraw from this agreement by giving 30 days written notice to each other party. A withdrawing party shall bear no responsibility for costs incurred by the Board after the date of notice of withdrawal has been given to the other parties; provided that the withdrawing party shall remain obligated for its proportionate share of the costs of any obligations incurred prior to the date it gives notice of withdrawal.
- 3. Each party will finance its obligations under this agreement through its ordinary budgeting processes.
- 4. No Party shall sell or assign any interest in or obligation under this Agreement without the prior express written consent of all other Parties.
- 5. Any communication required or permitted by this Agreement must be in writing except as expressly provided otherwise in this Agreement.
- 6. No separate entity is created by this Agreement.
- 7. If any provision of this Agreement shall be unenforceable, such provision, to the extent permitted by law, shall be severed from this Agreement, leaving the remaining provisions intact.

- 8. This Agreement constitutes the entire contract between the parties, and this Agreement shall not be changed except in writing signed by all the parties.
- 9. No officer, agent or employee of any party shall be subject to any liability or accountability by reason of the execution of this Agreement or any other documents related to the transactions contemplated hereby. Such officer, agents, or employees shall be deemed to execute such documents in their official capacities only, and not in their individual capacities. This section shall not relieve any such officer, agent or employee from the performance of any official duty provided by law. The officials and employees of each party shall not be deemed agents or employees of any other party in performance of this Agreement.
- 10. This Agreement may be executed in several counterparts, each shall be an original, but all of them together constitute the same instrument.

SUMMARY EXPLANATION: The applicant(s), Henry Huber and wife, and Larry Reisig have requesting a replat of an Agricultural Estate Dwelling described as a tract of land in the Northeast Quarter of the Northwest ¼ of Section 16, Township 22 North, Range 55 West of the 6th P.M Scotts Bluff County, Nebraska. Properties to the west, south, and north are all zoned agricultural, with the property to the east zoned heavy commercial. This is located in the City's Extra Territorial jurisdiction.

The parcel is currently platted as an Ag Estate Dwelling Site (AEDS). The applicant is requesting a replat in order to move the property line to allow the adjacent property more area that can be farmed. Planning Commission Minutes Regular Scheduled Meeting October 9, 2017 Scottsbluff, Nebraska

The Planning Commission of the City of Scottsbluff, Nebraska met in a regularly scheduled meeting on Monday, October 9, 2017, 6:00 p.m. in the City Hall Council Chambers, 2525 Circle Drive, Scottsbluff, Nebraska. A notice of the meeting had been published in the Star-Herald, a newspaper of general circulation in the City, on September 29, 2017. The notice stated the date, hour and place of the meeting, that the meeting would be open to the public, that anyone with a disability desiring reasonable accommodation to attend the Planning Commission meeting should contact the Development Services Department, and that an agenda of the meeting kept continuously current was available for public inspection at Development Services Department office; provided, the City Planning Commission could modify the agenda at the meeting if the business was determined that an emergency so required. A similar notice, together with a copy of the agenda, also had been delivered to each Planning Commission member. An agenda kept continuously current was available for public inspection at the office of the Development Services Department at all times from publication to the time of the meeting.

ITEM 1: Chairman Becky Estrada called the meeting to order. Roll call consisted of the following members: Anita Chadwick, David Gompert, Angie Aguallo, Becky Estrada, and Mark Westphal. Absent: None. City officials present: Annie Folck, Planning Coordinator, Gary Batt, Code Administrator II, Anthony Murphy, Fire Prevention Officer.

ITEM 2: Chairman Estrada informed all those present of the Nebraska Open Meetings Act and that a copy of such is posted on bookcase in the back area of the City Council Chamber, for those interested parties.

ITEM 3: Acknowledgment of any changes in the agenda: None

ITEM 4: Business not on agenda: None

ITEM 5: Citizens with items not scheduled on regular agenda: None

ITEM 6: The minutes of the September 11, 2017 meeting were reviewed.

Conclusion: A motion was made by Aguallo and seconded by Westphal to approve the minutes from the meeting on September 11, 2017. "YEAS": Gompert, Westphal, Estrada, Aguallo, and Chadwick. "NAYS": None. **ABSTAIN:** None **ABSENT:** Zitterkopf, Weber, Huber, and Wayman. Motion carried.

ITEM 7A: Planning Commission opened a public hearing for the review of a replat of an Ag Estate Dwelling Site (AEDS) located at 190439 County Road J. Folck stated that the applicant is requesting a replat in order to move the property line to allow the adjacent property more area that can be farmed. This will reduce the size of the parcel from to 6.05 acres to 4.143 acres. The minimum lot size for an AEDS is 2 acres, so this is still well within the requirements. They are also proposing an access easement along the east side of the property that would serve the adjacent farm. Staff recommended approval of the replat.

Conclusion: A motion was made by Gompert and seconded by Westphal to approve the Replat of the AEDS located at 190439 CR J, situated in the NE ¼ of the NW ¼ of Section 16, T 22N, R55W. "YEAS": Gompert, Westphal, Chadwick, Aguallo, and Estrada. "NAYS": None. **ABSTAIN:** None **ABSENT:** Weber, Huber, Zittorkopf, Wayman. Motion carried.

ITEM 7B: The Planning Commission opened a public hearing to consider designating an area located on west of Avenue I, south of Highway 26, and north of the BNSF railroad tracks as blighted and substandard. Folck reported that a study has been done and submitted for review in an area located west of Avenue I, south of Highway 26, and north of the BNSF railroad tracks. The study stated that there were several dilapidated and deteriorating structures within the area, as well as substandard infrastructure in the area. There is no functional storm drainage system, and many of the streets are unpaved. These are the main factors influencing the study's recommendation that the area be designated as blighted and substandard.

Folck stated that the City is allowed to designate up to 35% of its area within corporate limits as blighted and substandard. Currently, there are 4,217.5 acres within the City's corporate limits, of which 926.1 acres are blighted. This is equal to 22% of the City that is designated as blighted and substandard. The proposed study area is 121.79 acres, so if this study is approved, it will bring the City's total blighted and substandard areas to 24.8%, well within our allowed limits.

Commissioner Westphal asked who had commissioned the study. Folck stated that the study was done on behalf of the City, as they are trying to be more proactive in encouraging redevelopment and enabling the use of incentives such as Tax Increment Financing (TIF). Westphal asked if there are currently any issues with flooding in the area. Folck answered that because there are no storm drains in the area, it does periodically become inundated with stormwater. This is particularly apparent on the Panhandle Coop property west of Avenue I and south of 27th Street. Rex Morse, representing Aulick Leasing, inquired how this designation would benefit property owners. Folck stated that the blight designation makes properties in that area eligible for TIF to be used as an incentive for development. Eric Reichert, representing Eric Reichert Construction, asked if areas that had previously been designated as blighted could be taken out of that designation. Folck said that this is a possibility, and that there are several areas, such as where the Reganis dealership and Fairfield Inn were built, where this could be done, since TIF had already been used for redevelopment.

Westphal asked Folck for her thoughts on the proposed blight designation. Folck answered that the study was put together while she was on maternity leave, so she had not been a part of the process, but reviewing what was submitted, it looked like they had done a good job documenting several factors that contribute to a blight and substandard determination. Westphal asked if the entire area is within City limits. Folck responded that it is. Aguallo asked if any of the property is owned by the City. Folck stated that it is all private property.

Conclusion: A motion was made by Aguallo and seconded by Chadwick recommend approval of the study designating an area located west of Avenue I, south of Highway 26, and north of the BNSF railroad tracks as blighted and substandard "**YEAS**": Gompert, Westphal, Chadwick, Aguallo, and Estrada. "**NAYS**": None. **ABSTAIN:** Wayman, Huber, Weber, Zitterkopf **ABSENT:** None. Motion carried.

ITEM 7C: The Planning Commission opened a public hearing to consider an ordinance instituting a stormwater impact fee and new requirements for stormwater retention on new developments. Annie Folck gave an overview of the ordinance, stating that currently, the City requires all new subdivisions to install stormwater retention basins on-site. After installation, the developers are also required to maintain these facilities in perpetuity. This has proven to be very impractical and difficult to enforce, as it is very unappealing for developers to sacrifice developable land for stormwater facilities, and once the lots have been sold off, the developer does not want to remain responsible for the ongoing maintenance of the facilities. Previously, developers' agreements have stated that homeowners associations will be created to fund the ongoing maintenance of stormwater facilities; however, in practice, these associations have not been established, leaving no entity to take responsibility for the stormwater facilities. The City is also facing new regulatory requirements that ultimately hold the City responsible for ensuring that adequate maintenance is performed on all of these facilities; this is extremely difficult to accomplish when these facilities are privately owned.

In order to alleviate the burden on developers to build and maintain stormwater treatment facilities, and to relieve the City of the challenge of enforcing maintenance requirements on private property owners, City staff is proposing that from now on, when property is developed or redeveloped, resulting in increased stormwater runoff, that runoff should be routed to City facilities. The City will install and maintain these facilities in perpetuity. In order to fund this, an impact fee will be charged for any new impervious cover (streets, driveways, buildings, etc.) that is installed. This will be a one-time fee that is charged any time a building permit or paving permit is issued. The paving permit will be established to allow the City to track and charge an impact fee for any new paving of over 1,000 square feet. This will better allow the City to accommodate the increased runoff from large paving projects throughout the City. Regular maintenance activities on existing pavement (overlays, repair, etc.) will not be required to pay an impact fee. This will

also allow the City to fulfill the requirements of its NPDES permit by ensuring that they have access to and control over all future retention facilities, allowing them to ensure regular maintenance is performed.

Folck stated that at the previous Planning Commission meeting, there were questions about how the impact fee amount had been determined. She introduced Dave Schaff, contracted as the City engineer, who then explained the process that he used to recommend the fee of \$1.50/ft² of impervious area. He stated that they evaluated many other communities and how they charge impact fees. Nebraska is somewhat behind other states in stormwater requirements, and this is an issue that all communities our size or larger are struggling with. Scottsbluff's current ordinance regulates runoff from new subdivisions, but it does not address water quality, and so does not meet the requirements of the City's stormwater permit through NDEQ. The current ordinance is also difficult to enforce consistently, developers do not always follow through with implementation, and detention ponds are sometimes filled in by subsequent property owners. In order to effectively meet the requirements of the City's NPDES permit, the City needs to be able to have control over stormwater facilities that will treat runoff to improve water quality. Due to the unique nature of the City's stormwater system with the majority of the community draining into the Scottsbluff Drain, the city can treat runoff within the stormwater system itself. However, they need a viable funding source to pay for improvements to the Drain to address quantity and quality of runoff and to maintain and operate the system. The proposed impact fee of \$1.50 per square foot of impervious area will fund capital improvements that are needed throughout the system.

Schaff continued to explain that as the City's ordinance is written now, developers must locate retention areas on their own property. This typically takes up about 10% of developable land. When factoring in the amount of developable property that must be sacrificed to be used for retention, engineering costs for a drainage report and retention design, legal fees for setting up a homeowner's association, and ongoing costs for maintenance and monitoring of the retention area, the cost for developers to build their own retention areas is much more than the proposed impact fee. Schaff stated that this will actually be a net savings for developers, while also being a much more workable solution for the City. He added that they were primarily looking at costs for residential construction and trying to keep the costs reasonable for residents, because commercial developments generally have many other options to help offset the costs, such as LB840 and tax increment financing.

Commissioner Westphal asked if the impervious surface areas for which the fee would be charged included sidewalks, streets, and driveways. Schaff stated that he felt it would be best to only charge for impervious surfaces on the lot itself, so nothing would be charged for the streets or sidewalks that are within the City's right of way. He said that in considering how the fee should be structured, they looked at charging based on lot size, but ultimately decided that this would unfairly penalize large lots that have little impervious cover. By basing the fee on impervious surfaces, it is more equitable for the property owner as the fee charged is in proportion with the amount of runoff they are contributing to the stormwater system. Commissioner Gompert asked if there was anything on paper explaining the process used to determine the fee. Schaff stated that there is, and it is the intent of the City to put together some educational materials explaining the fee and how it was determined.

 Westphal asked if they had calculated how much extra costs this would add to development. Schaff stated that based off the national average of 1500-1800 ft² homes, the impact fee should amount to 1-3% of the cost to build. He added that this additional costs theoretically should be offset by lower priced lots, as the developer will have more developable ground and reduced costs from not needing to have a drainage report and engineered retention areas installed. Westphal asked if there would be anything property owners could do to reduce the impact fee by attempting to retain more stormwater on site. Schaff stated that they could reduce their impervious cover by using pervious pavers, reducing driveway size, etc. Folck stated that the City did not want to allow property owners to get credit for on-site retention because in order for the City to meet permitting requirements, they would have to track and inspect all of these retention areas. Additionally, in the past, there have been many retention areas that were installed as the property developed that were later filled in by subsequent property owners, with the additional runoff inundating the City's stormwater system.

Reichert asked how if an analysis had been done of how much a fee like this would have generated over the last few years. Schaff answered that such an analysis had not been done, but that all the money generated would go to capital improvements, especially those located within the Scottsbluff drain. These improvements would improve retention capacity and water quality. He said it would be possible to look at building permits over the last few years, but his estimate is that the amount generated would be far less that the amount necessary to make the needed improvements to the Drain. Westphal asked what the overall goal for the Drain is. Schaff stated that it was originally built to dewater areas to allow them to be developed, but it silts in quickly, and there is a lot of additional surface water resulting from developments above the drain that is well beyond the capacity of the Drain. The overall goal would be to daylight the section of the drain that goes underground, as this is the section that is over capacity, and if this was made into an open channel, facilities could be added withi that channel that would address water quality. Additionally, a daylighted drain could also be an attractive recreational opportunity, with a pathway alongside the channel. Gompert asked who maintains the Drain. Schaff answered that it is jointly owned and maintained by the City and the County.

Gompert asked Leann Sato to provide a little background on the NPDES permit requirements. Sato stated that in the Nebraska, the NPDES program is administered by the Nebraska Department of Environmental Quality. Nebraska is a little behind other states in this program, as they are just now starting their second permit term in 2018, while many other states are on their third or fourth permit terms. She stated that the new permit is trying to catch up on requirements to address water quality, velocity, etc. The post construction ordinance is something that is mandated by the permit. The ordinance should demonstrate that all runoff from new or redevelopment is being treated to improve water quality. Folck added that this all a part of the Clean Water Act and essentially amounts to an unfunded federal mandate. Compliance with the permit is required, but the City is not receiving funding to help with this requirement. Westphal asked if there would be any more ordinances that would need to be passed to stay in compliance with the permit. Sato said no, because the City has already passed ordinances addressing illicit discharge detection and elimination and runoff from construction sites, so the post construction ordinance should be the final one. Folck stated that the benefit of the ordinance that is being proposed is that in addition to helping the City come into compliance with regard to water quality, it will also allow the City to improve the way it addresses additional runoff from new development.

Kelly Strey, representing B & C Steel, stated that it is already hard to get people and businesses to come to this community, and that there is already a lot of development out at the airport just because it is outside of the City's zoning jurisdiction and they don't have to follow the same requirements. He felt that the City is expecting new construction to pay to fix everyone else's problem. Schaff stated again that he believes that the impact fee will actually be more economical for developers, and for commercial projects, there are many incentives such as LB840 and TIF. Reichert asked why everyone in the community couldn't be charged to pay for the needed improvements to the stormwater system. Schaff stated that in Nebraska, there is currently no legislation that would authorize the City to implement a stormwater utility. Strey asked if City owned retention facilities means that there would be any additional liability to the City in the event of a flood. Schaff stated that there would be no more liability than the City already has. Reichert asked what other communities that have been audited by the EPA have been required to do. Sato stated that they are required to get policies in place to meet requirements.

Gompert stated that flooding is definitely an issue, and the City is behind many communities in Colorado when it comes to water quality issues, so it seemed that everyone agrees that something needs to be done, but the biggest issue is cost. He inquired if the City could split costs of improvements with the developers. Schaff stated that the City would have to find the money in the budget somewhere, and with the budget difficulties that they had been experiencing, it would be unlikely that they would have anything available. Gompert asked what would happen if no new buildings were built; how would the City fund improvements? Sato stated that if there was no new growth, then they would not have to add any new facilities to meet permit requirements.

facilities to meet permit requirement Reichert questioned where money

Reichert questioned where money from new developments goes. When a new development generates additional sales tax and property tax, the City does not have additional day to day costs, so where does the extra money go? He said that the City may lose revenue from businesses choosing to locate in other communities or just outside City limits. Folck stated that, similar to other communities across the nation,

the City has been seeing a decline in sales tax due to online shopping and tends to struggle just to keep up with inflation. Anthony Murphy added that many businesses will only come to a community with a good ISO rating. He explained that an ISO rating is based on how well the fire department can protect properties, which affects insurance costs. Many franchises will only locate in a community with an ISO of 3 or better. Scottsbluff is rated at a 3, but that is only within city limits. So there are benefits to locating in Scottsbluff that other communities in the area cannot offer.

Reichert asked what would happen if the City were to approve a fee at 50 cents per square foot to get started on meeting permit requirements. Schaff stated that the costs of needed improvements are so significant that a smaller dollar amount would not show that the City is taking this issue seriously. Westphal asked how many meetings had been held with developers. Schaff stated that there had been one meeting with developers, and Folck added that a newsletter had gone out to all the contractors and developers for whom the City has contact information informing them that the City is considering this issue and inviting them to attend Planning Commission meetings to voice any concerns. Strey asked if there is any way to make adjustments to the fee if it is determined that it is hindering development. Folck answered that the ordinance could be amended at any time through the same process that is used to pass it in the first place. Morse stated that he still felt that properties in the ETJ that are not served by storm drains should not have to pay the same fee as properties that are served by storm drains. Schaff stated that it is assumed that areas within the ETJ will eventually be annexed and that the City should look at the storm drain system as a whole to determine where improvements are needed.

Conclusion: A motion was made by Westphal and seconded by Chadwick to recommend approval approval of the post-construction ordinance Chapter 24, Article 4 and revisions to Chapter 4, Article 11; Chapter 6, Article 6; and Chapter 21, Article 1, Sections 39 and 52 "YEAS": Westphal, Chadwick, Aguallo, and Estrada. "NAYS": Gompert. ABSTAIN: None ABSENT: Wayman, Huber, Weber, Zitterkopf. A majority of those present voted in favor; however a majority of the Planning Commission is required to make a recommendation (5 votes minimum). Motion failed, and ordinance will be brought back to next Planning Commission meeting to be considered again.

ITEM 7D: Election of Officers. Folck stated that Estrada has served as chair of the Planning Commission for three years now, so her term has been completed. It is typical for the vice-chair to become chair and a new vice chair elected. Angie Aguallo is the current vice-chair.

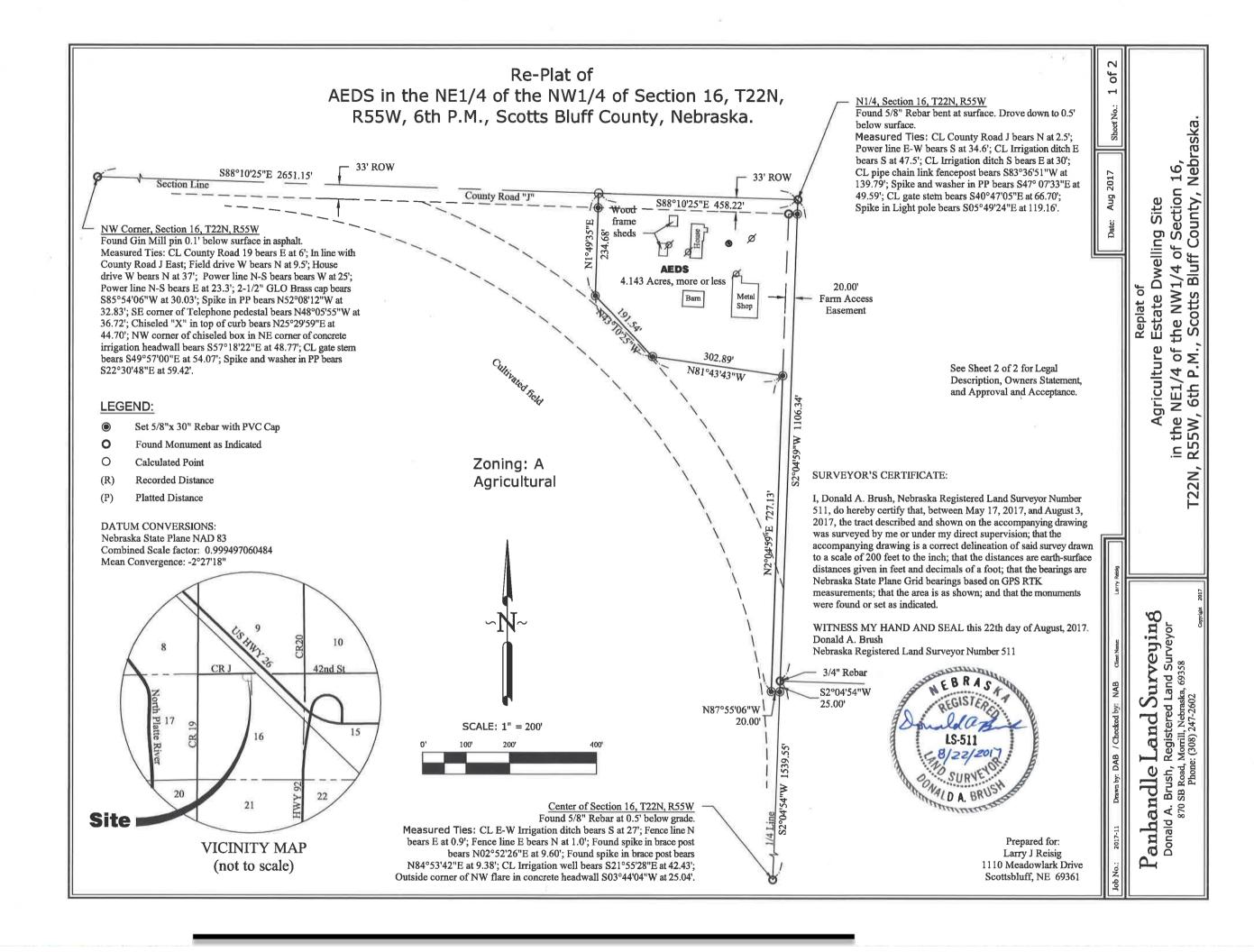
