SUMMARY EXPLANATION: The contract with Copier Connection, Inc., is a full service contract on a Canon copier that includes service checks, replacement of parts, photosensitive drum, intervening service calls and labor resulting from customary and normal use. The contract fee remains the same and is based upon 36,000 copies at a rate of \$350.00 per year plus sales tax. The contract is for a 3 year period and can be terminated by either party with 30 days written notice.
