

- Per Neb. Rev. Stat. §53-134(7), a copy of this application will be forwarded to your local governing body for recommendation. After approval by the local governing body, there is a 10-day holding period by the NI.CC for citizen protest;
- Annual Renewal Fee of \$100 is payable when renewing primary liquor license \$53-124.12 (1);


