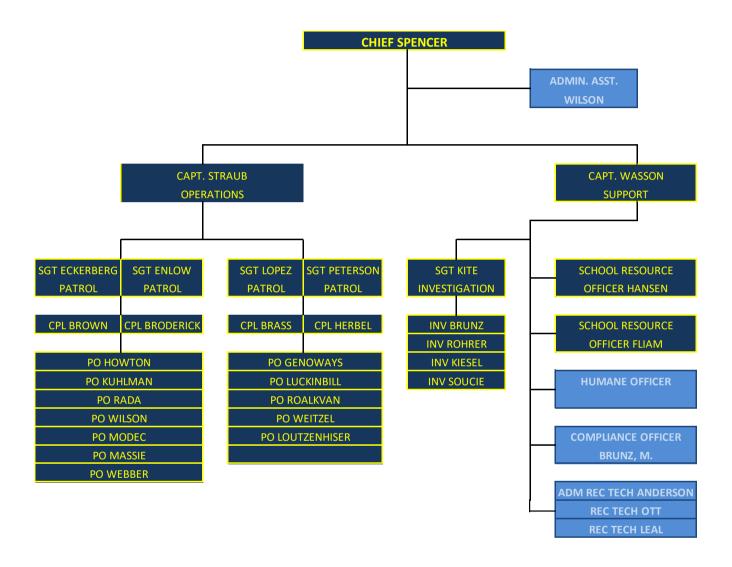

V. Support Services Division

Support Services provides assistance to the operations division and provides administrative services to the community. Support Services includes the department's investigations division, SWAT Team and Explosives Ordinance Disposal (EOD) Unit. The Support Services Division is supervised by Captain Brian Wasson.

Support Services staff also includes the School Resource Officers, Animal Control Officer, City Code Compliance Officer, an Admistrative Records Technician, two record technicians, and ten school crossing guards.

Activities of the School Resource Officers (SRO's) and the Animal Control Officer will be detailed within this report.

The records technicians perform a myriad of tasks from day to day. The record technicians process and route incident reports to the city and county prosecutors and enter data from reports and citations into records management systems.

There are several priorities within the division such as increasing technological capabilities of the department and enhancement of resources.

A. Investigations

Personnel assigned to this division investigate cases initiated by the patrol division as well as respond to and investigate larger cases and crime scenes. These cases often need additional and specialized follow-up like the application for search and arrest warrants, polygraph examinations or the collection of forensic evidence at crime scenes. The division is staffed with, one Administrative Sergeant, three criminal investigators and one drug investigator assigned to the WING Drug Task Force.

The Investigations Section is supervised directly by the Administrative Sergeant. The Administrative Sergeant and the investigators are assigned to work from 8:00 a.m. to 4:00 p.m. Monday through Friday. They also share on call assignment, normally being on call one week a month. One investigator in the division investigates the majority of child abuse and neglect cases referred to the department. The WING Investigator works a flexible schedule due to the nature of their assignment.

B. Records Management

In 2015 efforts to obtain a new records management system for the department commenced. With a group of area public safety administrators and users, the project began with formulation of a committee to address the needs of all public safety partners within Scotts Bluff County. Together this committee successfully identified and acquired a new software solution to provide Computer Aided Dispatch (CAD) and Records Management Systems (RMS) for all law enforcement, fire departments and the jail within Scotts Bluff County.

This was a large project and will serve all of the agencies participating. This project will significantly reduce the amount of time officers and staff is spending to enter data. It will dramatically increase the ability to use the information, a limitation of our current system. The most crucial goal of the project is to create the ability to share information with other agencies.

VI. Operations Division

Operations Division consists of the patrol division and also works in conjunction with the investigative division. Captain Tony Straub is in charge of the Division. The Operations Division is committed to providing excellent customer service and quality law enforcement. Our Patrol Officers not only respond to the day to day calls for service, but also initiate and complete investigations, enforce traffic statutes, city ordinances and accident investigations.

A. Patrol

The Patrol Section is comprised of 13 Patrol Officers, 4 Patrol Corporals and 4 Patrol Sergeants.

The position of Corporal was established in 2017 to help provide continuity and supervision to the four patrol teams. Officers are assigned to a Sergeant and Corporal, creating a team concept which helps to promote team cohesion and accountability within the division. Officers pick their Sergeants based on seniority and are assigned to a specific team for a period of one year.

B. Police Service Dog Program

With the retirement of Police Service Dog "Riki", the department is formulating a plan to replace both the K-9 and train a new handler as well.

C. Training

Training is coordinated through the Operations Division. Officers receive training to increase proficiency in specific disciplines of law enforcement and to reduce liability. At this point the department is maintaining monthly training for the entire department with as much specialized training as possible.

Mandated annual training in Domestic Violence, Firearms and Emergency Vehicle Operation is included in the statutorily required 20 hours annual training, although annual firearms qualifications cannot. A portion of the mandated training can be done on-line and the Scottsbluff Police Department has already implemented on-line training for its Officers through LARM and the Nebraska Law Enforcement Training Center (NLETC).

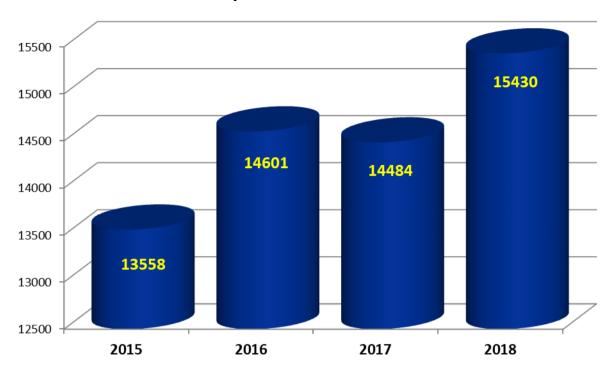
Scottsbluff Police Department has conducted two days of in—service training in Domestic Violence, Use of Force, and Emergency Vehicle Operations and may consider conducting this training twice annually. In 2017 there were a total of 2805 hours of continuing education hours conducted by members of the department. In 2018 a total of 3601 training hours were conducted by members of the Police Department.

VII. Activity Summaries

The graph below shows the number of calls received by the Scottsbluff Police Department for the past four years.

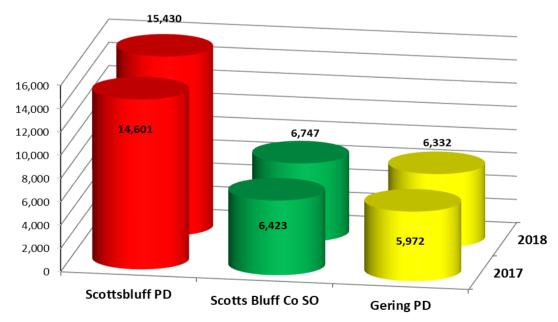
With the total calls for 2018 being 15,430, the department received an average of 42 calls per day and the average number of calls per officer is 593 for 2018.

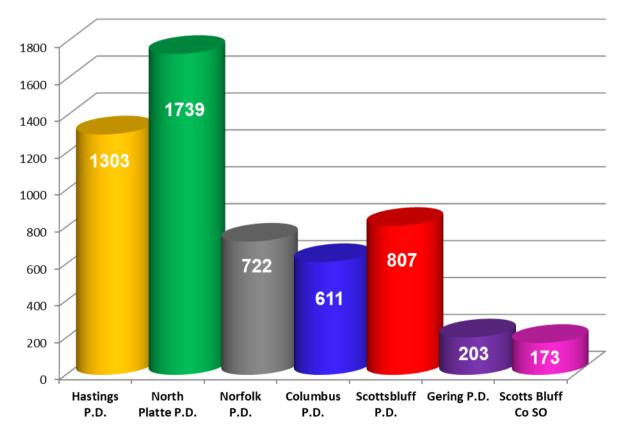
VIII. Offenses and Statistics

This graph compares the total number of offenses reported by each of the respective police departments in 2017.

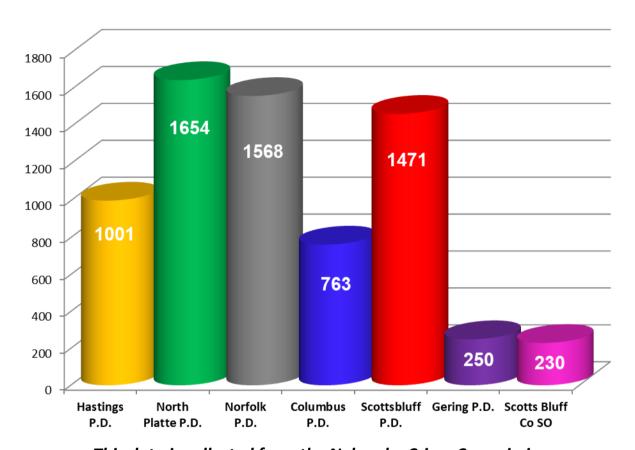

B. 2017 Arrests Reported by Agency

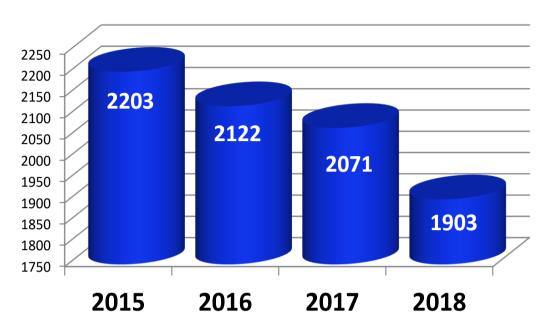
This graph compares the total number of crime arrests by each agency. (2018 offense totals are not yet available from the Nebraska Crime Commission.)

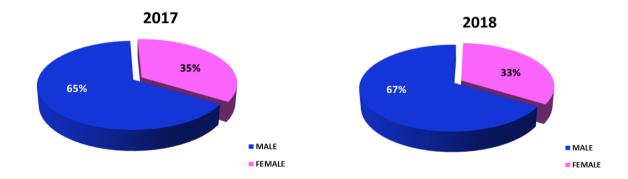
This graph shows the total number of <u>all</u> arrests by the Scottsbluff Police Department (Part I and Part II Crimes and will include ordinance violations).

Total Arrests (SPD Only)

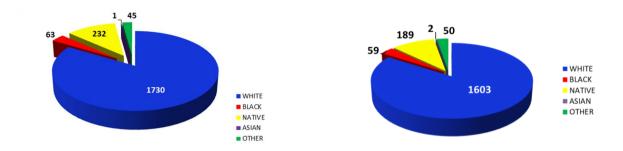


C. 2017 & 2018 Arrest Totals by Gender

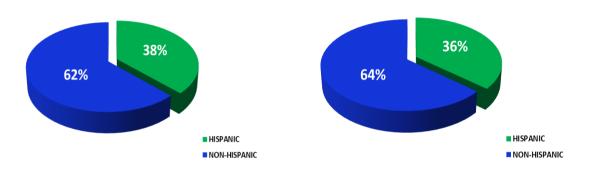

D. 2017 & 2018 SPD Arrest Totals by Race

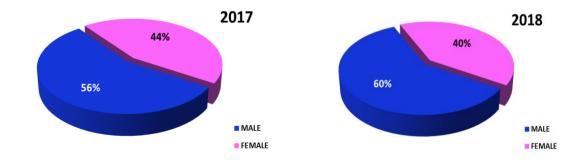


E. 2017 & 2018 Arrest Totals by Ethnicity

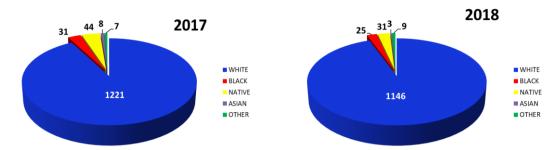


F. 2017 & 2018 SPD Citations by Gender

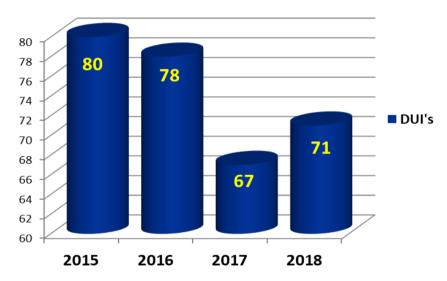


G. 2017 & 2018 SPD Citations by Race

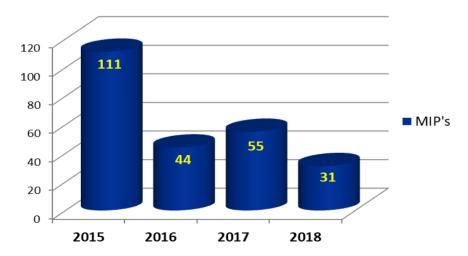


H. DUI Arrest Violations 4-Year Trend

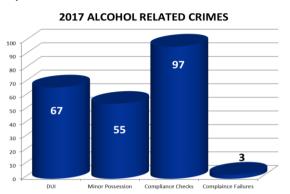
These charts show the number of persons arrested from 2015 through 2018 for the respective alcohol related violations. Below is the number of DUI arrests within the city for the past 4 years.

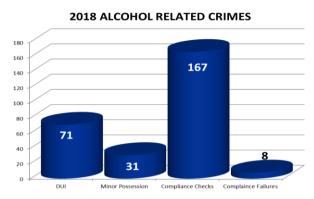


MINOR IN POSSESSION (MIP) ARRESTS 4-YEAR TREND

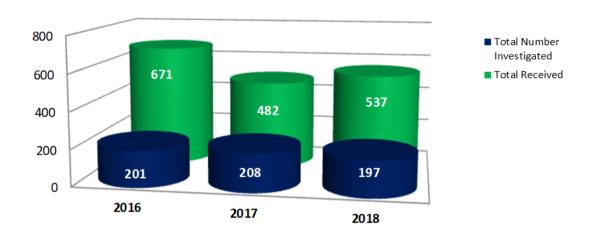


I. Child Abuse Investigations

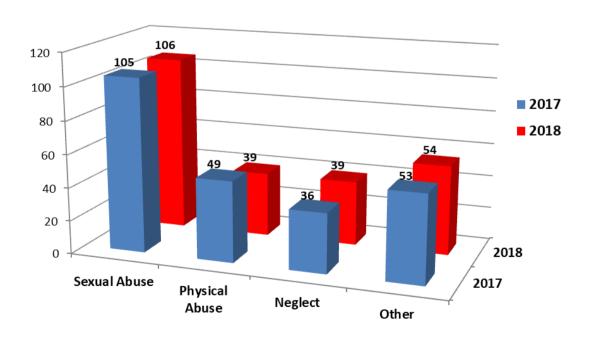
Scottsbluff Police Officers spend a considerable amount of time investigating allegations of child abuse and neglect. The vast majority of these reports come into the police department through the Nebraska Department of Health & Human Services (NDHHS) Hotline. The police department received approximately 500 reports of child abuse/neglect 2017 & 2018. Of these reports received over the past three years, more than 25% require an active investigation and most are conducted with an assigned HHS/Child Protection & Safety worker. These numbers also include domestic violence (DV) cases where children are present in the home at the time of occurrence. These investigations take multiple hours to investigate, coupled with forensic interviews of all children under the age of 17 at an accredited child advocacy center. The department works closely with the Department of Health and Human Services and staff at the CAPstone Child Advocacy Center with these sensitive investigations.

The graph below shows the activity that officers and investigators managed for the past 3 year period. The second graph shows the number of forensic interviews conducted at the CAPstone Child Advocacy Center in 2017 & 2018. Approximately 40% of these allegations involve sexual abuse or contact of a child.

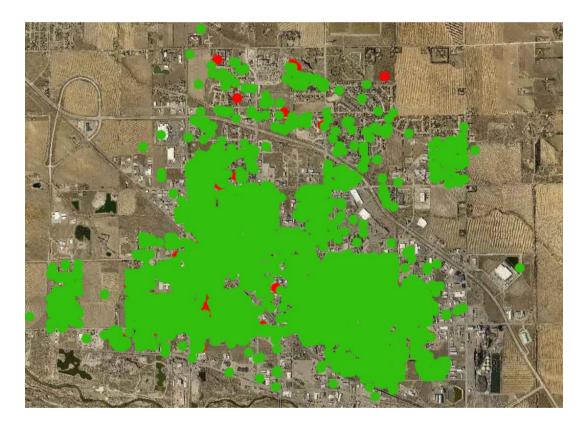

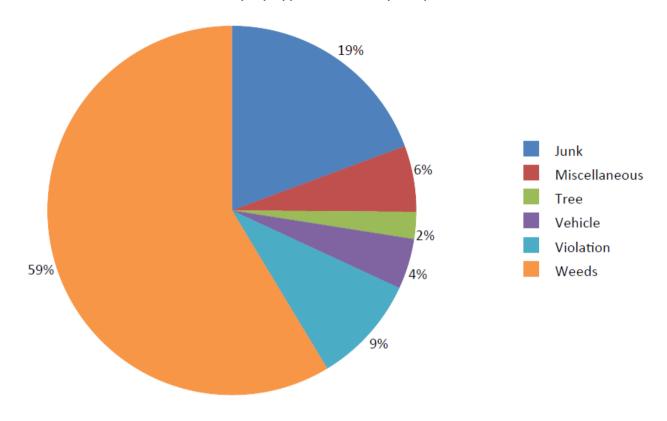

IX. Revenues

X. School Resource Officers

The School Resource Officer Program began with funding from the Department of Justice COPS in Schools program in 2002. The school resource officer has served the schools since and maintains a close relationship with staff and students throughout the district. Grant funding ceased for this position in 2005. Through an agreement with Scottsbluff Public Schools the funding of this position is now shared equally by the district and City of Scottsbluff. This funding is shared during the months that school is in session. In February, 2014 a second school resource officer was added. When school is not in session both are used to supplement normal patrol shifts.

The chart below shows the activity of the school resource officers. Officers deal with calls for service on school property but are also able to provide other patrol functions

around district properties while on duty to address issues occurring around school zones.

XI. Animal Control

In 2017 & 2018 Humane Officer James Bornschlegl responded to 523 and 570 animal related calls respectively. In addition to his animal control duties Officer Bornschlegl conducts vehicle releases, and assists with school crossing guard duties. Officer Bornschlegl works week days from 8:00 a.m. to 4:00 p.m.

XII. Drugs & Weapons

In 2017 & 2018 the Scottsbluff Police Department seized numerous firearms and other weapons as well as several varieties of dangerous drugs. In many cases, the department worked with members of the Western Nebraska Intelligence & Narcotics Group (WING) task force. The task force is also designated by the Midwest High Intensity Drug Trafficking Area (MWHIDTA).

In 2017 & 2018 there were a total of 391 / 304 drug related incidents respectively investigated by the department. 409 arrests for narcotic violations were made from these investigations in 2017 and 372 arrests were made in 2018.

In 2014, Colorado leagalized marijuana for recreational consumption. This action has made marijuana more available to Nebraska residents traveling to that state and meeting the age requirement for purchasing the drug. The graphs below show a steady increase from 2013, the year prior to Colorado's legalization and compares it to the last two years. The second graph shows a decrease in the number of drug paraphernalia arrests from 2017 to 2018. The increased available of edible forms of marijuana (THC) may be a contributor of this trend. The department has seized edibles in the form of chocolate bars and gummy bears among these forms of the drug.
