SUMMARY EXPLANATION: The Park, Cemetery, and Tree Board made a positive recommendation at the August 11, 2021 regular meeting to change the name of Mini Park to 18th Street Plaza, add Donor Plaza, add 23 Club Complex, and update the address of Monument Valley Pathway. City Council at the September 7, 2021 regular meeting voted to send the ordinance back to the PCT for review and recommended the removal of the senior center. The PCT made a positive recommendation at the October 13, 2021 to remove the Senior Center from 15-1-1.

BOARD/COMMISSION RECOMMENDATION: PCT made a positive recommendation on the removal of the senior center from 15-1-1 and to keep the other proposed additions and revisions.

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF SCOTTSBLUFF, NEBRASKA AMENDING CHAPTER 15, ARTICLE 1, SECTION 1 OF THE MUNICIPAL CODE TO UPDATE THE NAMES AND LISTINGS OF PARKS IN THE CITY OF SCOTTSBLUFF, PROVIDING FOR AN EFFECTIVE DATE AND PROVIDING FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SCOTTSBLUFF, NEBRASKA:

Section 1. Section 15-1-1 of the Scottsbluff Municipal Code is now revised and amended to read as follows:

“15-1-1. Parks; identified.

(1) For the purposes of this Municipal Code the following named parks shall be deemed to be comprised of the areas owned or controlled by the City of Scottsbluff, Nebraska and located at the following addresses:

18th Street Plaza, 18th Street and Broadway
23 Club Complex, 2nd Avenue and E. 29th Street
Bee Lovell Park, 18th Street and 10th Avenue
Centennial Park, 400 East 20th Street
Cleveland Field, 1615 West 20th Street
Constitution Park, 1809 3rd Avenue
Don Park, Railroad Street and Avenue I
Donor Plaza, Broadway and South Beltline Highway
Dr. Allan C. Landers Memorial Park, 4205 5th Avenue
East Overland Park, 1221 East 12th Street
Frank Park, 2804 2nd Avenue
Fairview Cemetery, 4109 5th Avenue
Lacy Park, 240071 Highland Road
McCaffree Park, 600 West 15th Street
Monument Valley Pathway, Broadway and South Beltline Highway
to College Park and East 27th Street
Neighbor Park, 9th Avenue and 11th Street
Northwood Park, 801 West 31st Street
Pioneer Park, 102 27th Street
Platte Valley Park, 1222 Circle Drive
Riverside Park, 1514 South Beltline West
Terry Carpenter Park, 2902 2nd Avenue
Veterans Park, 715 14th Avenue
Westmoor Park, 1936 Avenue I

Section 2. Prior section 15-1-1 is now repealed.

Section 3. This Ordinance shall become effective upon its passage, approval as provided by law and publication shall be in pamphlet form.
