COMMERCIAL LEASE AGREEMENT

THIS LEASE AGREEMENT is made and entered into this 1 day of January 2022, by and between GRASS INVESTMENTS, LLC, referred to herein as LANDLORD, and GRASS RETAIL, LLC, referred to herein as TENANT.

WITNESSETH:

PREMISES

Landlord leases to Tenant and Tenant leases from Landlord the premises identified as:

The South 45 foot by 60 foot portion of Lot 12 in Block 8, LAUCOMER ADDITON to the City of Scottsbluff, Scotts Bluff County, Nebraska,

located at 2002 Avenue I, Scottsbluff, Nebraska. Also included are the petroleum storage tanks, all pumps, and pump infrastructure, the pump canopy, and parking area. The leased premises are all those portions of the property used for the operation of a convenience store and gas station. Also included are all coolers, computers, computer software, fixture and signage used in the operation of the convenience store, all of which is collectively the "Premises".

TERM OF RENTAL AGREEMENT

The term of this Lease Agreement shall be for a period of five (5) years, commencing on the date Tenant closes on the Purchase Agreement with Cheema Capital, LLC, for the purchase of the convenience store business and shall continue for a period of 60 months thereafter.

USE OF PREMISES

The Premises shall be used by Tenant for the operation of a convenience store and gas station, or for such other lawful purposes as Tenant shall elect.

RENT

Tenant shall pay to Landlord as rent for the leased premises, the sum of \$3,500.00 per month. This lease shall be a triple net lease, and Tenant shall be responsible for and shall pay all

building maintenance and repairs, including without limitation, repairs to the heating, cooling and ventilation systems, the electrical and plumbing systems. Landlord shall pay for any structural damage, any damage caused by fire, not resulting from Tenant's negligence. Any damage from, wind, tornado, or other acts of God. Tenant shall pay, or reimburse Landlord for all casualty insurance premiums for coverage provided during the term of this lease. Landlord shall pay the real property tax assessed for the leased premises during the term of the lease.

PAYMENT OF RENT

Tenant shall pay all Rental payments when due and payable, without any setoff, deduction or prior demand therefor whatsoever. Any Rental, or other sum due Landlord under the terms of this Lease, not paid when due shall bear interest from the original due date at the rate of not less than 14% per annum until paid.

ALTERATIONS TO THE PREMISES

Tenant shall not, without the written consent of Landlord, be permitted to make any structural modification to or remodeling of the premises, including by way of example but not limitation, removal or relocating of interior walls, doorways, windows or hallways, removal of wall or floor coverings, lighting fixtures or plumbing fixtures. Landlord will consider any request of Tenant for permission to remodel or make structural modifications to the premises, and will not unreasonably withhold such consent provided the same shall not diminish the value or utility of the premises, and provided further that Tenant shall provide Landlord with a detailed description of the proposed work and Tenant's plan for restoring the premises at the expiration of the term of this lease.

UTILITIES

Tenant shall pay all utility charges for water, gas, electricity, sewer, trash removal, and other city services and utility charge, accruing during the term of the lease or any extension or renewal thereof, promptly when the same shall be due. In the event any deposits for utilities shall be required, Tenant shall pay the same, and shall cause the utility accounts to be established in Tenant's name.

DEFAULT AND TERMINATION

- 4. Files or has filed against it, any case under the Federal Bankruptcy Act; and

PURCHASE AGREEMENT AND SECURITY AGREEMENT

THIS AGREEMENT is made and entered into this ______ day of December 2021, by and between, CHEEMA INVESTMENTS, L.L.C., referred to in this agreement as "SELLER", and CRAIG GRASS and GRASS INVESTMENTS, LLC, referred to in this agreement as "BUYER".

WITNESSETH:

1. <u>Property</u>. The property which SELLER agrees to sell and BUYER agrees to purchase, consists of SELLER'S convenience store, real estate, improvements, fixtures, inventory, fuel storage tanks, fuel dispensing equipment, office, surveillance and business equipment, all located at the business known as Cheema's Gas & Liquor, 2002 Avenue I, Scottsbluff, Nebraska 69361, legally described as:

Lot 12, Block 8, LAUCOMER ADDITION to the city of Scottsbluff, Scotts Bluff County, Nebraska

The parties agree, and BUYER acknowledges that SELLER is also selling, and BUYER is purchasing SELLER'S inventory of alcoholic, non-alcoholic beverage, perishable or non-perishable food items, tobaccos products, and gasoline fuel contained in the fuel storage tanks on the premises. The specific details of the contents and value of inventory, shall be determined an independent party, prior to closing.

2. <u>Purchase Price and Terms of Payment</u>. The purchase price for the property described above, exclusive of inventory, is the sum of Eight Hundred Thousand Dollars (\$800,000.00). The additional amount due for SELLER'S inventory on hand at the time of closing shall be paid by BUYER to SELLER as hereafter provided. The purchase price for the property and premises, exclusive of inventory, shall be paid by BUYER to SELLER as follows:

- a. At the time of execution of this agreement, BUYER will deposit the sum of \$10,000.00 to the trust account of Sorensen, Hahn, Browning & Judy, P.C., as a down payment and earnest money deposit.
- b. The remaining sum of \$790,000.00 for the property, exclusive of inventory shall be paid by BUYER as follows: The remaining balance of \$790,000.00, together with interest thereon at the rate of 6.5% per annum shall be amortized over 30 years (360 months) and shall be due and payable in monthly installments of \$5,044.12 each, the first of which shall be paid by BUYER to SELLER on the 1st day of March 2022, and a like amount on the 1st day of each month thereafter until the entire remaining principal balance and all accrued and unpaid interest shall be due and payable, the "Balloon Payment Date" which date shall be due on February 1, 2025. BUYER may prepay the entire principal and accrued interest, without penalty, at any time. An amortization schedule is attached hereto as "Exhibit A" and incorporated herein by reference.
- 3. <u>Inventory</u>. Prior to closing, SELLER'S inventory of alcoholic, non-alcoholic beverages, food items and other perishable and non-perishable items, tobacco products, as well as gasoline inventory, shall be determined by an independent third-party. BUYER will pay SELLER for such inventory, as needed, at SELLER'S cost, plus any freight charges paid by SELLER for delivery of such inventory. The total cost of the inventory that BUYER is purchasing from SELLER shall be paid in full, at closing. SELLER shall cease sale of inventory after the inventory shall have been completed, and pending closing.
- 4. <u>Security and other Documents</u>. All remaining sums due from BUYER to

 SELLER at the time of closing shall be secured by Deed of Trust describing the real property

 herein sold to BUYER, and by such other financing statements and instruments as SELLER shall

deem necessary and appropriate to secure payment of all remaining sums due with all personal property, equipment, inventory, accounts receivable, and other property herein sold to BUYER, and including after acquired property. This Agreement shall additionally constitute a Security Agreement between the parties, it being the intention of the parties that all such property and after-acquired property shall be security for the payment of the debt owed by BUYER to SELLER. At the time of closing, BUYER shall execute an installment promissory note or notes in favor of SELLER for the amounts owed by BUYER to SELLER for the premises, equipment, fixtures and other personal property, exclusive of inventory, as provided for herein. This contract, together with all additional documents and instruments executed by BUYER shall collectively constitute the "SALE DOCUMENTS" and such documents, and the obligations, covenants and conditions contained therein are by reference made a part of this agreement. BUYER agrees to execute any other or additional documents reasonably requested by SELLER to fully carry out the terms of this agreement. All security documents, inclusive of the Deed of Trust, financing statements and other lien instruments, if any, shall secure payment of all obligations herein provided for.

- 5. Taxes. SELLER will be responsible for and agrees to pay all real property taxes and personal property tax assessed against the property for the years 2021 and prior. The 2022 real property taxes and personal property taxes will be prorated between the parties to the date of closing and BUYER will receive a credit against the remaining purchase price for any portion of the pro-rated tax not paid by SELLER.
- 6. <u>Title Insurance</u>. As soon as this contract is executed by the parties, SELLER will obtain a title insurance policy, insuring merchantable title, free and clear of all liens and encumbrances, excepting easements, restrictions, reservations, and rights-of-way of record.

SELLER shall deliver the title insurance policy to BUYER or to BUYER'S attorney. BUYER shall have ten (10) days to notify SELLER in writing of any merchantable defects in title. If BUYER shall fail to give SELLER written notice of any merchantable defect within this period, any such defect shall be considered to have been waived by BUYER. If BUYER shall give notice of defect to SELLER, SELLER shall cure such merchantable defect on or before closing, and if SELLER is not able to cure the defect by closing, closing may be extended for a reasonable period of time not to exceed 30-days to allow SELLER time to cure the defect. If SELLER shall be unable to cure any such defect in the time allowed to do so in this agreement, or if SELLER shall, for any reason, fail to cure such defect, BUYER shall have the right to either declare this contract void, and have the full down payment refunded to BUYER including that portion identified as the non-refundable portion hereafter, or BUYER may complete the purchase and close in spite of the defect, in which case BUYER shall have waived such defect.

7. Insurance. During the term of this agreement, and until the SELLER has been fully paid all sums herein provided to be paid, BUYER shall purchase and keep in full force and effect, casualty and hazard insurance, insuring the building, fixtures, improvements, pumps and dispensing equipment, canopy, and all insurable personal property against loss from fire, flood, tornado, wind, hail, or other Act of God, and from damage caused by vandalism, or vehicle collision with structures or improvements. Such insurance shall be in an amount sufficient to replace the premises and improvements, and in no event less than the amount needed to fully pay SELLER the remaining sums due to SELLER. Such insurance shall contain a loss payee provision requiring all claim payments to include SELLER'S name on such checks or drafts, and the insurer shall be obligated to provide SELLER with written notice of any threatened cancellation, lapse, termination, or change in coverage. BUYER shall provide SELLER, at

closing, and on the occasion of each policy period renewal, with a certificate of insurance demonstrating that such insurance is in full force and effect. BUYER shall additionally purchase and carry in full force and effect, premises liability insurance in an amount not less than \$1,000,000.00, and SELLER shall be identified as an additional insured on such policy until BUYER shall have fully paid SELLER all sums due to SELLER herein.

- 8. <u>Default</u>. In the event BUYER shall default in performance of any of the terms or conditions of this contract, SELLER shall be entitled to retain BUYER'S down payment as liquidated damages arising out of BUYER'S default and breach in the performance of the terms and conditions of this agreement, and this contract shall be of no further force and effect. Should SELLER default in performance of any of the terms or conditions of this contract and fail to close as required herein, BUYER shall be entitled to maintain any legal or equitable remedy available to BUYER arising out of SELLERS' default.
- 9. Closing, Possession, and Risk of Loss. Closing shall occur at an agreed upon time by the parties on or before January 31, 2022, at the office of Title Express, 2122 Broadway, Scottsbluff, Nebraska, which will serve as escrow/closing agent. If the parties have completed the taking of inventory, and BUYER has secured the necessary licenses and they are prepared for closing before the specified time, the parties may mutually agree to advance the closing time. At the time of closing, BUYER will execute the installment promissory note, deed of trust and other security documents herein provided for, SELLER will execute and deliver the Warranty Deed to the premises to the BUYER, and a Bill of Sale for personal property. Possession of the premises will be given to BUYER at the time of closing. Risk of loss to the premises passes to BUYER at the time of closing.

- 10. <u>Expenses</u>. The expenses incurred in completing this transaction shall be paid by the parties as follows:
- a. SELLER shall pay the documentary-stamp tax required as a condition to the recording of the Warranty Deed from SELLER to BUYER.
- b. BUYER shall pay the costs of recording the Warranty Deed from SELLER to BUYER, and the cost incurred to record the Deed of Trust.
- c. Nebraska Liquor Control Act §53-149 (2) A license issued under the act terminates immediately upon the sale of the licensed premises named in such license. The purchaser or transferee may submit an application for a license under the act prior to closing such sale or transfer. While such application is pending, the purchaser may request and obtain a temporary operating permit from the commission which shall authorize the purchaser to continue the business which was conducted on the purchased premises under the terms and conditions of the terminated license for ninety days or until the purchaser has obtained a license in its own name, whichever occurs sooner. Prior to the issuance of a temporary operating permit, the purchaser shall supply the commission with documentation from the seller that the seller is current on all accounts with any wholesaler under section §53-123.02. A seller who provides false information regarding such accounts is guilty of a Class IV misdemeanor for each offense. In the absence of such temporary operating permit, the purchaser shall not manufacture, store, or sell alcoholic liquor on the purchased premises until the purchaser has obtained a license in the purchaser's own name. If the application is withdrawn by the applicant or is denied by the commission, the previous license may be reinstated at the discretion of the commission upon request by the previous licensee.



Rules and Regulations Chapter 2 Section 004 TEMPORARY OPERATING PERMITS

004.01 Someone other than a licensee may operate a business holding a liquor license if all of the following criteria are met:

004.01A A formal application for a new license must be on file with the Commission.

004.01B A request for a temporary operating permit must be filed with the application.


004.01C Temporary operating permits may not exceed 90 days in total duration.

004.01D If the sale of the business fails to occur, the previous licensee can be reinstated during the pendency of the temporary operating permit upon request of the previous license holder.

004.02 Any violations occurring during the pendency of a temporary operating permit will be adjudicated in the following manner:

004.02A Any violations occurring during the temporary operating permit will be used and conferred upon a license if issued. Any violation may be used to determine the fitness of the applicant to receive the requested license.

RECITALS

SELLER is the owner of all of the petroleum inventory, convenience store inventory, beverage and liquor inventory, shelving, office equipment and other miscellaneous non-fixture personal property and good will, located in the convenience store portion of the building located at 2002 Avenue I, Scottsbluff, Nebraska.

AUTHORITY: The Scottsbluff Police Department reports specific information to the City Council whenever a liquor license application is presented. The information furnished by the Police Department conforms to Chapter 53, Reissue Revised Statutes of Nebraska 1943, and Section 53-132, which outlines the factors which the Commission may consider in granting a liquor license.

COMMENTARY

53-132: Section 2

(A) The applicant is fit, willing and able to properly provide the service proposed within the city where the premises described in the application are located:

A background investigation was conducted on Craig and Nikki Grass as a means to determine their fitness to hold a liquor license. Craig reported the following criminal convictions; speeding and reckless driving tickets in 1983-1985 in Dawes County, Driving Under the Influence 1996 or 1997 Scotts Bluff County, Failure to use seatbelt 2004 Scotts Bluff County, Reckless driving 2006 Scotts Bluff County, Disturbing the peace 2008 Scotts Bluff County, and Violated load contents 2017 Scotts Bluff County. Nikki Grass reported having one criminal conviction for Driving under the influence 2008 Scotts Bluff County. I did not find any other convictions for either Craig or Nikki.

Considering all the information gathered, none of the criminal convictions are disgualifying and all happened several years ago. I find no reason to believe the applicant is not fit to hold a liquor license.

(B) The applicant can conform to all provisions, requirements, rules and regulations provided for in the Nebraska Liquor Control Act:

Any operator must adhere to the existing laws while doing business in the community and adhere to acceptable business practices.

On Thursday, February 24, 2022 Craig and Nikki Grass appeared before the City of Scottsbluff Liquor License Holders Investigatory Board to answer questions regarding their application. Craig told us that there is currently one other employee at the business other than Nikki and himself. Craig told us that they are hoping to hire at least one more, adding that none of the previous employees wanted to stay and work for them. Craig told us that he currently has all of the alcohol that they purchased from the previous owner locked in a room, secured in the cooler, or covered on the shelf. There were several questions regarding the inventory and the lack of an inventory attached with the application. Craig told the board that there were two inventories done, one was turned in with a "Temporary License Permit," that was denied and another done by a third party

hired by the seller that inventoried the entire store. There was much discussion regarding the legalities of Craig and Nikki's ability to sell the beer and alcohol inventory. Chairman of the Board Russ Knight told Craig Grass that they would not be able to sell the beer inventory and would have to destroy it. Craig told the board that he will reduce the business's focus on alcohol making it more of a convenience store. Craig told me in a later conversation that he already removed much of the alcohol advertising from the store's windows and replaced it with non-alcohol product advertising. On February 25th, 2022 we received an inventory of the alcohol from the Nebraska Liquor Commission.

Based on the questions surrounding the inventory the board decided to take no action thus making no recommendation to the city council.

The applicant appears to have the ability and willingness to conform to language within the Nebraska Liquor Control Act.

(C) The applicant has demonstrated that the type of management and control exercised over the licensed premises will be sufficient to ensure that the licensed business can conform to all provisions, requirements, rules and regulations provided for in the Nebraska Liquor Control Act:

Craig and Nikki told us that the business does have security cameras and an intrusion alarm. Craig stated that Nikki and he will be responsible for the inventory and ordering all of the alcohol. Nikki added that any overstock of alcohol will be kept in a locked room in the back of the business. Craig and Nikki both explained that they have a point of sale system that requires employees to scan an alcohol purchaser's identification prior to proceeding with the sell. Craig told the board that everyone is required to show identification adding that any employee who would sell alcohol to a minor would be terminated immediately.

(D) The issuance of the license is or will be required by the present or future public convenience and necessity:

The business is a convenience store that has existed at this location for several years.

SPECIFIC ISSUES COMMISSION MAY CONSIDER

(E) The existence of a citizen's protest made in accordance with Section 53-133:

There have been no known citizen protests of this business.

(F) The nature of the neighborhood or community of the location of the proposed licensed premises:

The business is located at 2002 Ave I, Scottsbluff, Nebraska. It is the type of business that will attract customers when open, seven days a week Sunday through Saturday. Its location is easily accessible and convenient for customers. I would not anticipate any issues with location.

(G) The existence or absence of other retail licenses or bottle club licenses with similar privilege within the neighborhood or community of the location or the proposed licensed premises.

There is one other businesses of this type in the close proximity that has liquor license.

(H) The existing motor vehicle and pedestrian traffic flow in the vicinity of the proposed licensed premises:

Although no recent traffic studies have been completed regarding motor vehicle traffic of the general area, the traffic flow is not of a concern at this time nor is pedestrian traffic.

(I) The adequacy of existing law enforcement:

The Scottsbluff Police Department is allowed 33 full time officers in the department and handled approximately 17,073 calls for service in 2021. The number of liquor licenses within the jurisdictional boundaries of the Police Department, regardless of the class, continues to be a priority to the Police Department and even routine monitoring of their business practices is difficult. Compliance checks continue to remain a concern to those businesses that sell alcohol to minors. The Nebraska State Patrol has assumed liquor law enforcement duties and their wide jurisdiction generally precludes any particular focus in the city.

- (J) Whether the type of business or activity proposed to be operated in conjunction with the proposed license is and will be consistent with the public interest:
- **(K)** Adequate staffing and training, as well as close supervision of patrons are important. Cooperation with the Police Department by management will help to eliminate or diminish potential problems with violations.

Grass Retail, LLC, DBA Shortstop have applied for a new liquor license.

The Development Services Department is required by Article 1, Chapter 11 of the Scottsbluff Municipal Code to report specific information to the Mayor and City Council whenever a liquor license application hearing is held. In accordance with that directive the following information is offered:

- (1) The property at 2002 Avenue I is situated in a C-2 (Neighborhood and Retail Commercial) zoning district where retail stores and services are allowed by right pursuant to the City's Zoning Ordinance, Chapter 25, of the City's Municipal Code of Ordinances. The properties to the south, north, and east are zoned R-1a (Single Family Residential) and the property to the west is zoned O & P (Office & Professional).
- (2) The off street parking requirements are 1 space for every 500 square feet of building space is required for general commercial use. The building is 2700 square feet. The occupancy has access to at least 5 off street parking spaces as required by ordinance. This requirement is found in 25-5-1 (18) of the City's Municipal Code of Ordinances.
- (3) The use of this property is consistent with a C-2 zone.
- (4) There are no churches, schools, or other similar institutions within 300 feet of the subject property.
- (5) According to the 2020 census the population of Scottsbluff is approximately 14,417.
