Addendum to a Contract

This Addendum to a Contract ("Addendum"), which is made effective November 1, 2023, is made by and between the City of Scottsbluff, Nebraska, a first class city ("Scottsbluff") and the City of Minatare, Nebraska, a second class city ("Minatare"). The Addendum is intended to alter and modify a Contract entered into by Scottsbluff and Minatare, dated December 19, 2011, hereinafter referred to as "Contract".

Scottsbluff and Minatare acknowledge and agree to alter and modify paragraph 14. of the Contract as follows:

14. For water furnished pursuant to this Contract, Minatare shall pay, within thirty (30) days of the date of a statement is sent to Minatare, the sum of \$.81 for each 1,000 gallons of water delivered to Minatare. Scottsbluff may modify the rates upon demonstrable increase or decrease in the costs of performance hereunder, but such cost will not include any capital expenditures for water system improvements which are due to the growth or repair of the system for the sole benefit of the other customers served by Scottsbluff. These capital costs cannot be included in the water rate adjustments to Minatare. Scottsbluff may, from time to time, increase water rates at such times as water rates charged to the customers of its municipal system are changed. And such increase or decrease shall be equal to the same percentage increase or decrease charged to the municipal customers. Notice of modification will be given to Minatare thirty (30) days in advance of the Scottsbluff City council meeting where such modification will be considered. Other provisions of this Contract may be modified or altered by mutual agreement.

Except as specifically altered and modified by this Addendum, the terms and conditions of the Contract shall continue in full force and effect.
