# 4. PUBLIC HEARING - 7:00 P.M. - REVIEW THE FUNCTIONING AND PROGRESS OF THE SEWARD ECONOMIC DEVELOPMENT PROGRAM (LB840) FUNDED BY LOCAL CITY SALES TAX

Greg Walz, Citizen Advisory Review Committee Member, 726 Bader Avenue, addressed the City Council presenting the semi-annual report in response to review and progress of the Seward Economic Development Plan. The report indicated the Committee met on June 24, 2015 and the Committee felt the Economic Development Plan is operating as intended and the Committee had no comments or recommendations.

# 5. PUBLIC HEARING - 7:00 P.M. - CONSIDERATION OF AMENDING THE AREA WITHIN THE CITY TO BE SUBSTANDARD AND BLIGHTED AND IN NEED OF REDEVELOPMENT

Building/Zoning & Codes Enforcement Director Ed Gonzalez addressed the City Council stating this amended blighted area now includes the Lincoln/Seward Rail Campus development area. The property must be determined to be blighted and substandard to qualify for Tax Increment Financing. The Planning Commission considered the amended blighted area at a public hearing on July 13, 2015 with unanimous approval of the amended area. Mr. Gonzalez stated, if approved, the City will have 29% of total City acres declared blighted; the maximum is 35%. He also added that the western portion of the proposed development site would need to be annexed into the City for Tax Increment Financing consideration. He stated, while not required by law, the property owners affected by this proposed amended blighted area were notified of the proposed amendment and the public hearing. He stated he is not aware of any other areas that are being proposed for development that would need to be blighted.

- 6. CONSIDERATION OF A PLAN FOR STORM WATER RUNOFF AND SANITARY SEWER IMPROVEMENTS FOR ST. JOHN'S NEW DAYCARE CENTER TO BE LOCATED AT HILLCREST DR. AND COLUMBIA AVE
  - A. Consideration of financial participation in the relocation of sanitary sewer line and improvements
  - B. Consideration of financial participation in the relocation of storm sewer and consideration of constructing a new storm sewer line

City Administrator Bruce Smith addressed the City Council stating St. John's Church came to the City Council June 2, 2015 requesting financial participation in the relocation and replacement of a sewer line and financial participation in constructing a new storm sewer line. On July 7, 2015, the City Council approved payment for replacing the north/south sewer line to the west of the new development, at a cost of \$52,000. Mr. Smith stated

Water/Wastewater Director Tim Richtig does not believe the City should assist with the relocation of the existing 8" sanitary sewer line that runs under the private property. Mr. Smith stated, with regard to participating with building a new 48" storm sewer and accepting land from St. John's for a retention cell, additional review/study needs to be done. He added that none of these projects are included in the current budget.

Additional discussion was held on dollar amounts requested from St. John's Church, whether the project consideration should be included in upcoming budget discussions, the actual dollar amount requested by St. John's Church, and how the cost share would be applied, including the proposed retention cell property.

Councilmember Singleton moved, seconded by Councilmember Beck, that consideration of financial participation in the relocation of sanitary sewer line and improvements, relocation of storm sewer, and construction of a new storm sewer line be tabled until the City Administrator can meet with St. John's Church to clarify the City's participation in these projects and the funding requested.

#### 7. CONSIDERATION OF A NON-BINDING LETTER OF INTENT REGARDING PROJECT HOT MILL

Darl Naumann of Ayars & Ayars, 2436 N 48<sup>th</sup> St, Lincoln, addressed the City Council stating letters of intent are common tools for economic development projects and he has been involved with them when he worked for the State of Nebraska and City of Lincoln. He stated he prepared the proposed letter of intent and added that this is a non-binding document. He added that he contacted the developer regarding proposed language change in the first sentence, which the developer approved. The language read, "The City of Seward is committed determined to having have your company become the flagship industry of the Seward/Lincoln Regional Rail Campus." Mr. Naumann stated, if approved, he believes Mr. Havens can take this to his investors to assist in moving forward to the next stages of the project.

City Attorney Kelly Hoffschneider stated, that he agrees the letter is a non-binding letter of intent and he does not have a concern with how the letter is written or with the proposed language change.

Mayor Eickmeier reiterated the non-binding intent of the letter and added that the City Council will have several opportunities for voting on moving forward with the project, which includes a Tax Increment Financing application, redevelopment agreement and plan, annexation, and bonding.

Jessica Kolterman, 1059 Plainview, Seward, stated she is a business owner, a member of the Seward County Economic Development Corporation and the Chamber of Commerce and is very interested in opportunities to grow the City of Seward. She stated she supports the proposed Letter of Intent. She said she fears that if the City chooses to not sign the letter, it may appear to this company and other potential developers that the community is not interested in developing the rail campus.

Gerald Homp, 1210 Eastridge, Seward, stated he is one of the owners of Bottle Rocket Brewing and as a new business owner, feels this is a great opportunity for the community. He stated the letter of intent indicates the community is excited about the project and will not only bring in a projected 150 employees, but their families as well.

Diana Garske, 432 S Columbia Ave, Seward, stated she is a Seward County Commissioner and she and other Commission Members had the opportunity to attend one of the meet and greet sessions with the proposed developer and the feedback on the project has been positive. She stated, as a member of the SCEDC, she also is excited for the opportunities.

Councilmember Beck moved, seconded by Councilmember Singleton, that the proposed nonbinding Letter of Intent regarding Project Hot Mill be approved, contingent upon the wording changed in the first sentence from "...committed to having..." to "...determined to have..." as this wording is more consistent with the remainder of the letter.



Thanks for your review. Regarding the wetland delineation, the work has been done but I have not submitted the report as of yet. The original estimate for the wetland delineation (\$3080.00) was underestimated a little bit for a 5-mile trail with 1 mile of it being through trees. The additional wetland delineation fee of \$3500 is composed of the additional work that was original underestimated along with the additional 2200 feet that still needs delineated due to the new alignment of the trail. I have reviewed the CWO with our surveyor and the additional hours for the survey work are reasonable. I will need justification and a cost breakdown for the wetland delineation. No delineation has taken place yet that I can tell and there is no breakdown of what the previously scoped amount covers or why additional funds will be needed.

The bigger issue that we will need to discuss is that it appears you are nearly out of hours for functional design and survey (1400 hours billed out of approx. 1500 available) and we do not even have a 30% plan set or the alignment of the north end of the trail determined. We need to discuss why the survey hours are over, if the reason is justifiable, and what will be needed to finish the survey and functional trail design. After each decennial census the Federal Highway Administration (FHWA) initiates an update, applying the latest census data, to the Federal-Aid Urban Area Boundaries. Along with this update the functional classifications are reviewed. As per guidelines from the FHWA, the State Transportation Agency shall have the primary responsibility for developing and updating urban area boundaries and functional classifications and shall work with appropriate local governmental entities to complete this update.

To insure that urban areas in Nebraska meet the requirements of the 2010 Census update, Census boundaries for the Seward Urban Area were reviewed. Where necessary the boundary was extended to encompass the census designated area and the corporate limits of the city. Functionally classified routes may have been revised.

I have enclosed a copy of the updated Seward Urban Area Map for review by the Seward City Council. If the council concurs with the revised system and boundary, have a designated representative sign the signature block and return the map in the enclosed envelope. A county map was enclosed for reference.

This report is in reference to the NDOR's request to review their map of the City's Urban Area Boundaries, which includes the City's Corporate Limits, and City Street classifications (see enclosed NDOR letter dated July 15, 2015, and Seward Urban Area map).

After reviewing the Seward Urban Area map, there is one discrepancy on the Corporate Limit boundary. A section of South Hwy 15 (South 6<sup>th</sup> St.), just north of the Big Blue River, to an area just south of Izaak Walton Road, which is not depicted on the map as being included in the Corporate Limits.

This area was annexed into the City's Corporate Limits by the City Council by Ordinance No. 7-09, on September 1, 2009 (see enclosed copy of Ord. 7-09).

NDOR Roadway Asset Management Representative David Brokaw, was contacted and advised of this. Brokaw advised to submit the map to the City Council for their review, and if there were no other corrections, ask the Council to approve the map, with the correction of the South Hwy 15 section to be added, and then return the signed map, and a copy of the Ordinance which annexed that area, back to the NDOR.

It should be noted that the NDOR does not include Private Streets on the Urban Area map, such as Ridge Run, Wildwood, and Goldenrod Lane.

Section 5. PAMPHLET FORM; PUBLICATION; WHEN OPERATIVE. This ordinance shall be published in pamphlet form and shall be in full force and effect from and after its passage, approval, and publication as provided by law and city ordinance.


