3. CONSIDERATION OF AN ORDINANCE AMENDING WATER UTILITY RATES

Andrew Ross, Nebraska Municipal Power Pool Director, presented the rate study information for the electric, water and sewer utilities. He stated that earlier projections suggested increasing the electric rates by 4.7% beginning October 1. However, based on current cash reserves, debt service, cost of power purchase, and capital needs, the result is a recommendation of no electric rate change at this time and possibly none in 2016; however, after that, due mainly to the capital needs, increasing cost of transmission and NPPD rising costs, there will likely be proposed increases of 3-4% each year beginning in 2017.

Mr. Ross stated the rate study for the sewer utility also indicated no need for an increase, but is indicating a 4.5% rate increase in October of 2016.

Mr. Ross then reviewed the rate study information for the water utility and stated that due to the capital expenses, the recommendation is to increase the rates by 2.6%. He stated the cash reserves are healthy; however, there

are some very large expenses planned and even with the 2.6% increase, there will be a need to use some of the cash reserves for stabilization of rates.

Mr. Ross stated the 2014 community survey is complete and he will forward this information to the City to share. He stated this comparison does not compare facilities, but just rates.

Ordinance No. 2015-15 initiating a 2.6% increase for water rates was adopted.

Councilmember Pike moved, seconded by Councilmember Schmit, that the minutes of the proceedings of the Mayor and Council of the City of Seward, Seward County, Nebraska in the matter of passing and approving Ordinance No. 2015-15, "AN ORDINANCE TO AMEND SECTION 3-127 OF THE CITY CODE; TO INITIATE A 2.6% INCREASE IN REVENUES CHARGED TO CUSTOMERS FOR SERVICE FROM THE WATER SYSTEM OF THE CITY EFFECTIVE WITH THE OCTOBER 2015 BILLING; TO PROVIDE FOR BILLING THEREOF; TO REPEAL SECTION 3-127; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT" be preserved and kept in a separate and distinct volume known as "Ordinance Record, City of Seward, Nebraska" and that said separate and distinct volume be incorporated in and made a part of these proceedings the same as though it were spread at large herein.

4. AUTHORIZE PLACEMENT OF "WELCOME TO SEWARD" SIGN ON CITY PROPERTY ON EAST HWY 34

Clarence Wattier, representing the Seward Area Chamber of Commerce First Impressions Committee, presented a request to utilize City property to erect a "Welcome To Seward" sign on east Highway 34 north of the old John Deere building. The sign is meant to enhance and compliment Seward's Fourth of July City designation, the Parade of Flags, and the National Guard museum while welcoming visitors. He stated the plan is to have two galvanized steel sign posts and aluminum tube construction with 3M high performance vinyl lettering. He stated the funding for the project will come from private donations, and the Seward Area Chamber of Commerce will serve as the grant applicant for potential grants through Seward County Visitors' Committee, Seward Foundation, LB840 grant, and WalMart. He said the City will be asked to provide the electricity to illuminate the LED lights, and they may be requesting City assistance for dirt work and concrete for construction, but there should be very little maintenance. The proposed cost of the project is \$11,755.86 and none of the work would begin until the funds are secured.

There was additional discussion as to whether this new sign would replace the current sign on east Hwy 34 or if that sign would remain and whether the proposed location for the new sign is the best location considering potential growth of the City to the east and the tree line which would obstruct view of the sign. There was a suggestion to contact the property owners further to the east and inquire whether they would allow placement of the sign on their property.

City Attorney Hoffschneider stated that if the City approves placement on City property, it would be recommended to prepare an easement for construction and a maintenance and utility agreement so all parties understand the future responsibility for the sign.

Councilmember Singleton moved, seconded by Councilmember Pike, that the City supports the sign conceptually; however, requests the Seward Area Chamber of Commerce Impressions Committee look at alternative locations for placement

of the sign east of the proposed location north or south of Hwy 34.

8. CONSIDERATION OF A SETTLEMENT AGREEMENT WITH CHARLES AND LAVONNE EVANS REGARDING PURCHASE OF CEMETERY LOTS AT SEWARD GREENWOOD CEMETERY

City Attorney Kelly Hoffschneider presented an agreement with Charles and LaVonne Evans to settle any potential dispute arising from two cemetery lots purchased by the Evans that were erroneously sold to another party. The agreement states the City shall provide the opening and closing of two newly deeded cemetery lots at no additional cost to the Evans.

Councilmember Kamprath moved, seconded by Councilmember Pike, that the Settlement Agreement with Charles and LaVonne Evans regarding purchase of cemetery lots at Seward Greenwood Cemetery be approved.

9. CONSIDERATION OF SEWARD FOUNDATION APPLICATIONS

Becky Baker, Seward Memorial Library Director presented a request in the amount of \$1,135 as a grant funding match to purchase a table and chairs for use with an Early Literacy Station (Bilingual) and Edge Tablet equipment.

She stated this same grant was approved by the City Council last year and forwarded to the Seward Foundation; however, the Library did not receive the grant funds from the Nebraska Library Commission, so she withdrew the request from the Seward Foundation.

There was an inquiry as to whether this application should be submitted to the Seward School Board, since it involves educational equipment and the Seward School system is part of the educational arm of the community. It may be beneficial on the grant application to get the School Board's support.

Ms. Baker stated that everything about the Library is educational and all City requests have always come to the City Council and teacher and school requests go to the School Board.

Councilmember Schmit moved, seconded by Councilmember Singleton, that the request in the amount of \$1,135 as a grant funding match to purchase a table and chairs for use with an Early Literacy Station (Bilingual) and Edge Tablet equipment be approved and forwarded on to the Seward Foundation for consideration.

10. CONSIDERATION OF A RESOLUTION AUTHORIZING THE LEASE/PURCHASE AND/OR FINANCE OF EQUIPMENT THROUGH CATERPILLAR FINANCIAL SERVICES CORPORATION

Public Facilities/Capital Improvement/GIS Director John Hughes presented a lease agreement with Caterpillar Financial Services for a 60-month lease of a motor grader at an annual cost of \$20,258.69.

Councilmember Singleton introduced the following resolution:

RESOLUTION NO. 2015-23

WHEREAS, the laws of the State of Nebraska (the "<u>State</u>") authorize City of Seward (<u>the "Governmental Entity</u>"), a duly organized political subdivision, municipal corporation or similar public entity of the State, to purchase, acquire and lease personal property for the benefit of the Governmental Entity and its inhabitants and to enter into any necessary contracts; and

The Governmental Entity wants to lease, purchase and/or finance equipment ("Equipment") from Caterpillar Financial Services Corporation and/or an authorized Caterpillar dealer ("Caterpillar") by entering into that certain Governmental Equipment Lease-Purchase Agreement (the "Agreement") with Caterpillar; and

the form of the Agreement has been presented to the governing body of the Governmental Entity at this meeting.

BE IT THEREFORE RESOLVED, that: (i) the Agreement, including all schedules and exhibits attached to the Agreement, is approved in substantially the form presented at the meeting, with any Approved Changes (as defined below), (ii) the Governmental Entity enter into the Agreement with Caterpillar and (III) the Agreement is adopted as a binding obligation of the Governmental Entity; and

that changes may later be made to the Agreement if the changes are approved by the Governmental Entity's counsel or members of the governing body of the Governmental Entity signing the Agreement (the "Approved Changes") and that

the signing of the Agreement and any related documents is conclusive evidence of the approval of the changes; and

that the persons listed below, who are the incumbent officers of the Governmental Entity (the "Authorized Persons"):

Joshua Eickmeier, Mayor

be, and each is authorized, directed and empowered, on behalf of the Governmental Entity, to (i) sign and deliver to Caterpillar, and its successors and assigns, the Agreement and any related documents, and (ii) take or cause to be taken all actions he/she deems necessary or advisable to acquire the Equipment, including the signing and delivery of the agreement and related documents; and

that the City Clerk of the Governmental Entity is authorized to attest to these resolutions and affix the seal of the governmental Entity to the Agreement, these resolutions, and any related documents; and

that nothing in these resolutions, the Agreement or any other document imposes a pecuniary liability or charge upon the general credit of the Governmental Entity or against its taxing power, except tot eh extent that the payments payable under the Agreement are special limited obligations of the Governmental Entity as provided in the Agreement; and

that a breach of these resolutions, the Agreement or any related document will not impose any pecuniary liability upon the governmental Entity or any charge upon its general credit or against its taxing power, except to the extent that the payments payable under the Agreement are special limited obligation of the Governmental Entity as provided in the Agreement; and

that the authority granted by these resolutions will apply equally and with the same effect to the successors in office of the Authorized Persons.





Consideration of an Ordinance approving the Final Plat of Pitsch Addition

Administrative Report: This is a replat of 2 existing lots located at 864 N 5th St and 916 N 5th St. This subdivision involves moving the middle property line, making 1 lot bigger and 1 lot smaller. Since the parcels have been re-platted previously, City Zoning regulations require that it has to go through the Major Subdivision process, requiring a Preliminary

Administrative Report: Only one bid was received on the Roberts Street Area Distribution Line Upgrades at a price of \$692,875. The Engineer's estimate for the project was \$450,000. Olsson Associates is recommending this bid be rejected and rebid, if the Council so chooses. The attached letter from Garrett Klein of Olsson Associates provides his reasoning in recommending rejection of the bid.

Mayor Eickmeier and Members of the City Council:

Bids for the Roberts Street Area electrical project were opened at the Seward City Offices at 2:00 p.m. on Thursday, September 24, 2015. One (1) bid was received as shown on the attached bid tabulation and below:

IES Commercial, Inc. \$692,875.00

The Engineer's opinion of probable construction cost provided in a letter to the Council dated August 11, 2015 was \$425,000.00. With the \$25,000 contingency allowance, our bid expectation was \$450,000.00. We have reviewed the unit costs included with IES's bid as compared to those used in our estimate. We revised our opinion of cost as discussed herein, and we discussed the difference between the bid and the updated Engineer's estimate with IES. Based on this portion of the evaluation, we do not recommend award of the construction contract at this time.

Revised Estimate

Costs for major material items were re-verified. In general, material costs used in the original estimate were appropriate. IES and another contractor (whom did not submit a bid) indicated that working around existing energized circuits and in areas with moderate traffic would drive labor costs up for this project. From this input, we made adjustments to the labor components in unit costs used in our estimate.

Based on the above, our revised estimate for the project is **\$504,000.00** (excluding Owner-furnished materials), or 12% higher than the initial estimate.

Low Number of Bids

We contacted three non-bidding contractors to discuss their apparent lack of interest in the project. Two advised that the bid date followed closely the dates of other proposals they were preparing, and they did not have adequate time to secure material pricing and/or prepare a bid. The third contractor did not recall having received the bid notice. It is our opinion, from the discussions, that these contractors would submit bids if the project were re-advertised.

Recommendation - Re-Bid the Project

As noted previously, we do not recommend awarding the contract at this time. We recommend that the project be re-advertised at a time convenient to the City. It is our opinion that the City will receive more competitive bids, and a better response from contractors. We would anticipate approximately \$3,000.00 in additional costs related to rebidding the project, including plan updates and reproduction, publication costs, and engineering/administrative expenses. At the Council's direction, we will arrange for the project to be re-bid. Dear Bruce:

JK Energy Consulting, LLC (JKEC) is pleased to submit this letter agreement (Agreement) to provide consulting services to complete a Power Supply Evaluation for the City of Seward (City) and its municipal electric utility (Utility). This Agreement is based on our conversation on August 12, 2015, and JKEC's understanding of the City's power supply resources and agreements.

Project Understanding

The City purchases its capacity and energy from the Nebraska Public Power District (NPPD). The NPPD purchase is for the City's long-term, total requirements under the General Firm Power Service (GFPS) Generation Station rate schedule. The NPPD agreement is scheduled to expire in 2022, after which the City will need to either renew the agreement or purchase its firm requirements from an alternate supplier.

NPPD has approached its wholesale customers about the possibility of replacing the existing agreement with a new agreement with an initial term of 20 years. The reason for the proposed new contract is NPPD's need to issue bonds to pay for capital improvements and secure the payment of "Other Post-Employment Benefits" for retiring employees. NPPD recently proposed contractual terms for the new 20-year agreement, along with a higher rate beginning in 2016 for any City that remains on the existing GFPS agreement.

The City would like to evaluate its purchased power options for the period beginning in 2022, when the existing agreement expires. The GFPS agreement provides options to reduce capacity and energy prior to the expiration of the agreement. Depending on market rates and alternate suppliers, it may be cost effective for the City to reduce purchases from NPPD prior to 2022 by providing the appropriate notice. This proposal provides a scope of service to evaluate potential power suppliers at the conclusion of the existing agreement, as well as the feasibility of reducing purchases under the existing agreement. The City could potentially reduce its purchases beginning in 2019, if notice is provided before January 1, 2016. The amount of additional reductions that may be made after an initial reduction request are the subject of litigation between NPPD and one of its customers.

Scope of Services

Task 1: Data Collection. This task involves collecting projected peak demand and energy loads, existing contract information, and hourly load profile information from the City. Information about proposals to extend the existing contract would be collected along with power supply and transmission rate projections.

Task 2: Develop Request for Proposals. This task involves developing a request for power supply proposals (RFP) that would be sent to prospective power suppliers. Discussions with potential suppliers would be held prior to sending out the RFP to determine whether the supplier is capable of providing service and the reliability of their rate projections. The RFP would include information about the Utility's load patterns, existing power supply arrangements, and transmission service arrangements. Rate projections, power supply resource profiles, fuel use characteristics, environmental risk information, and financial information would be collected from each respondent. Proposers would be given approximately 30 days to respond after the issue date of the RFP.

Because of the length of time until the contract starts, it may not be possible to get reliable fixed rate proposals from potential suppliers. It may be necessary to complete the assessment based on known rates and rate projections over the near-term and provide an estimate of potential savings from an alternate supplier on the basis of costs between now and 2022.

Task 3: Prepare Assessment of Proposals. This task involves calculating the annual power supply costs associated with each proposal. The net present value of power supply costs would be calculated for each proposal and ranked from lowest to highest. Wholesale rate projections would be based on information provided by each respondent and reviewed for reasonableness. This assessment would take into account the projected rate differential between the GFPS rate and rates under the new contract being proposed by NPPD. Non-economic factors, including rate stability, term of agreement, transmission arrangements, and reliability would be reviewed. Any technical or operational issues associated with splitting the City's power supply purchases between two suppliers would be identified as well.

Task 4: Prepare Letter Report. A letter report will be prepared, summarizing the findings of the RFP process and a recommended course of action. The letter report will be written in a manner that is suitable for review by the City Council.

Task 5: Present Findings. The letter report would be presented in summary form at a regularly scheduled meeting of the City Council. The meeting provides the City Council an opportunity to ask questions about the study process, proposals, and findings.

Task 6: Assist in Negotiations. This task involves assisting in contract negotiations with potential suppliers, if the City decides to change power suppliers or reduce purchases under the existing agreement. This assistance would be provided in cooperation with the City's legal counsel.

Fee

JKEC will provide the above listed services for Tasks 1 through 6 on a billable time and out-of-pocket travel expenses. The projected fee for the Scope of Services is approximately \$12,000-\$15,000. The fee is dependent on a number of factors, including delays in data collection and complications in reviewing power supply proposals. The cost estimate will likely be more toward the high-end of the range if the City decides to pursue a reduction in purchases under the existing agreement, or if there is a need to negotiate a new contract with an alternate supplier. JKEC will notify the City as soon as possible if it is anticipated the original estimate of \$15,000 will be exceeded and provide a revised budget.

JKEC will bill the City on an hourly basis for actual time spent providing the services listed. Mr. Krajewski's current billing rate is \$125 per hour, which includes overhead expenses including telephone calls, copying, and postage. Administrative services are billed at \$50 per hour. Automobile mileage would be billed at the then-current IRS reimbursement rate, which is \$0.575 per mile as of January 1, 2015. Other travel expenses would be billed based on the actual out-of-pocket cost, without markup.

JKEC will invoice the City monthly (via electronic mail) for work completed during the previous month and payment is due upon receipt. Invoices unpaid after 30 days will accrue interest at 12% per annum (1.0% per month). JKEC agrees that for purposes of this Agreement, the hourly rate charged will remain the same through the completion of this project.

Schedule

The timeframe to complete the study would be as follows. This schedule is based on a notice-to-proceed of October 20, 2015. The schedule for contract negotiations will be dependent on the results of the study. The presentation date may vary based on the meeting schedule for the City Council. The key factor in this schedule is the need to provide notice to NPPD if the City would like to either reduce its purchases or sign a new 20-year agreement.

City Responsibilities

- 1. Provide existing power supply data and hourly load data (preferably in electronic format).
- 2. Provide copy of existing agreements with NPPD as well as information provided in conjunction with efforts to extend the GFPS agreement.
- 3. Provide timely review and comment on information submitted to the City.

Meetings

The above-listed fee includes three site meetings: An initial project kickoff meeting, a meeting to discuss draft results with City staff, and a final meeting to present the letter report to the City Council. If additional visits are requested, billing would be based on JKEC's standard billing rate schedule (see Attachment 1).

Additional Services

Any services not included in the above-listed Scope of Services would only be provided upon written agreement by the City and JKEC. Such services would be billed at JKEC's standard billing rate schedule (see Attachment 1).

Other Terms and Conditions

JKEC shall exercise the same degree of care, skill, and diligence in the performance of services as is ordinarily possessed and exercised by a professional consultant under similar circumstances. No warranty, expressed or implied, is included in this Agreement or in any drawing, specifications, report or opinion produced pursuant to this Agreement.

All expressed representations, indemnifications or limitations of liability included in this Agreement will survive its completion of termination for any reason.

This Agreement may be terminated for convenience by the City upon five days written notice and by JKEC upon 30 days written notice. Termination for convenience by either party will not affect the requirement for the City to pay for services rendered prior to the termination date of the Letter Agreement. This Agreement will terminate on January 1, 2017, unless extended by mutual agreement of the parties.

JKEC appreciates the opportunity to provide this Agreement to the City of Seward. If it is acceptable, please print two copies, sign and return one copy to JKEC, and retain the other copy for your records.

CONSIDERATION OF AN AGREEMENT WITH EARTH NETWORKS, INC FOR PLACEMENT OF A WEATHER CAMERA, WEATHER STATION, AND RELATED HARDWARE AND SOFTWARE ON THE WATER TOWER-Tim Richtig

HOSTING AGREEMENT by and between Earth Networks, Inc. And City of Seward

This HOSTING AGREEMENT (the "Agreement") is made effective as of the last signed date by and between Earth Networks, Inc. a Delaware corporation with principal offices at 12410 Milestone Center Drive, Suite 300, Germantown MD 20876 ("EN"), and City of Seward, 537 Main Street, Seward, NE 68434 ("HOST").

WHEREAS, EN manufacturers and deploys WeatherBug Weather Stations, each such system being comprised of a weather sensor suite, a master control unit, a digital display, a communications device, and a sensor shelter, or optional equipment such as a camera, weather server and computer (referred herein as the "Hardware"), and computer programs for collection, display and dissemination of real-time and historical data via an Intranet or the Internet (referred herein as the "Software");

WHEREAS, EN desires to install 1 HD Pan/Tilt/Zoom camera and Weather Station, related Hardware and Software (if applicable) at designated locations owned or controlled by HOST for continued collection and dissemination of local weather information;

WHEREAS, both parties agree that it is of mutual benefit to have the HOST participate in this program;

THEREFORE, the parties agree to the following terms and conditions:

- 1. Weather Systems. EN will place at designated HOST facilities, at no cost to the HOST, 1 HD Pan/Tilt/Zoom camera and Weather Station, including Hardware and Software, (as determined by EN), to collect and report real-time and historical weather data and/or digital camera images via the Internet as described herein.
- 2. **Term and Termination.** This Agreement shall have a term of one year, with automatic yearly extensions unless either party opts out of such extension with notice at least 30 days prior to the expiration of either the original or any renewal term, as applicable.
- 3. **Rights and Licenses.** EN retains all rights to the design of the Earth Networks Weather Stations and Cameras, Hardware, Software, and ownership of the Systems, the data generated by the Systems (including weather data measured directly by System components, calculated data from the Software, and video imagery from cameras), which rights the HOST and each participating site hereby acknowledges and agrees not to assert or claim any interest in, save and except only as otherwise expressly granted in paragraph 4.

4. Data Rights

(1) EN grants to the HOST a royalty-free license for the term of the Agreement to use data generated by Earth Networks Weather Stations solely and exclusively for educational, research and internal operational purposes within the HOST network, which the parties agree includes all subsidiary and affiliated companies of HOST.

(2) Except as noted in (1) above, the HOST may not, without express permission of EN, provide the data generated by HOST sites to any party, including other government agencies. HOST may, however, provide and/or allow links to data pages created pursuant to this Agreement.

(3) Except as otherwise stated herein, EN has the exclusive right to resell, provide, or otherwise use the data generated by the Systems.

5. **Installation and Maintenance.** The installation and maintenance of the Earth Networks system provided to HOST under this Agreement is the responsibility of EN. Installation and maintenance shall be in accordance with EN standard specifications, which includes but is not limited to the requirement for multiple small building penetrations where agreed and directed by the HOST in order to affix the system to the building structure and the running of data

cable to an internal termination point. In this regard, mast installation may require drilled holes for bracket support and cable access may require new building penetrating conduit. HOST shall allow the previously described work to be completed, shall provide the site and power supply (described in #8 below) for the Systems and Hardware. HOST shall keep the systems powered up and connected to an "always-on" Internet connection configured to EN' specifications (described in #8 below) regarding firewall and port security required to allow live data to transmit at all times. EN shall provide a toll-free technical support service line as well as online technical support to assist such maintenance

- 6. **Delivery and Shipment Costs.** The HOST will provide EN the delivery address for each site where a system is to be installed. EN shall pay all shipping costs including optional equipment and software.
- 7. **Disposal.** EN reserves the right to remove the Earth Networks system upon termination of the agreement. EN shall ensure that the removal is done with minimal damage to the HOST building and further agrees to pay for any costs necessary to ensure the building is in the same condition, excepting only normal wear and tear, as it was prior to the installation.
- 8. **HOST Requirements.** The HOST shall provide for each participating site the following site related requirements (minimum specifications are indicated): (1) electrical power sufficient for operation of the Systems which includes two 120V outlets within 5 feet of where the indoor equipment is to be located; (2) direct, high speed "always on" Internet connection (ISDN, T-1, T-3, or equivalent) where port 9500 UDP/TCP outbound and port 80 TCP are open. Earth Networks will provide a technical support service line as well as online technical support to assist with such efforts. HOST shall allow EN access to the Hardware, upon reasonable notice, for the purpose of supplying necessary maintenance and/or the installation of additional sensor equipment.
- 9. Limitations/Disclaimer of Liability. The HOST assumes no responsibility to protect the equipment from damage of any kind. Except for damages caused by EN's willful misconduct, recklessness, or gross negligence, the parties agree that to the extent permitted by applicable law, EN disclaims liability related to the manufacture, or delivery, of the equipment, the software and/or supplies used in connection with the equipment or the provision of services for the equipment whether such claim alleges breach of contract, or tortious conduct including but not limited to negligence or any other theory. Both parties disclaim liability for indirect, incidental, special, or consequential damages (including but not limited to, loss of use, revenue, or profit) whether such claim alleges breach of contract, tortuous conduct including but not limited to negligence, or any other theory.
- 10. **Extraordinary Circumstances.** Except for obligations of payment, neither EN nor the HOST shall be liable for nonperformance caused by circumstances beyond their control, including but not limited to, work stoppages, floods, lightning and all other acts of God. In the event of the loss of any weather station hardware at any installed HOST site, the replacement of such hardware shall be at the sole discretion and cost of EN.
- 11. **Necessary Maintenance by EN.** HOST will provide upon reasonable notice by EN access to the system(s) for the purpose of supplying necessary maintenance and/or the installation of additional sensor equipment.
- 12. **Non-Waiver of Rights.** The failure of EN or the HOST to insist upon strict performance of the terms and conditions of this Agreement or to exercise any rights or remedies, shall not be construed as a waiver of its rights to assert any of the same rights or to rely on any such terms or conditions at any time thereafter.
- 13. **Governing Law.** This Agreement shall be governed by the laws of the State of Nebraska without reference to its conflict of laws rules.
- 14. **Breach**. Either party may terminate this Agreement on breach by the other party of any material term or condition hereof 30 days after written notice is given to the breaching party by the non-breaching party if such breach is not cured.
- 15. **Business Relationship**. Nothing contained herein shall create or be deemed to create any association, partnership, joint venture, the relation of principal and agent, or the relationship of employee and employer between the parties herein.

All notices given under any of the provisions of this Agreement shall be deemed to have been duly given when made in writing and either delivered via overnight express delivery requiring the signature of the accepting party's representative or three days after the date of mailing via U.S. Postal Service, certified mail, return receipt requested, to the addresses of the parties set forth in this Agreement as the principal offices or to other such addresses as such party shall specify in writing to the other party.

- 17. **Severability**. If any provision of this Agreement shall be held to be invalid or unenforceable, the remainder of this Agreement shall not be affected thereby and shall remain valid and enforceable.
- 18. Assignment. Neither party may assign this Agreement or any of its rights and obligations hereunder to any person, firm, or corporation, without the prior written consent of the other, which consent shall not be unreasonably withheld, provided that either party may, on notice to the other, assign this Agreement to a subsidiary or to any party that acquires or succeeds to all or substantially all of such party's business or assets. This Agreement shall bind and inure to the benefit of each party's successors and permitted assigns.
- 19. **Modification**. No provision of this Agreement may be changed, waived, discharged or terminated orally, but only by an instrument of equal formality signed by duly authorized representatives of the parties hereof.
- 20. Entire Agreement. This Agreement embodies the entire understanding of the parties and there are no further or other agreements or understandings, written or oral, in effect between the parties relating to the subject matter hereof. The division of the Agreement into paragraphs is only a matter of convenience for reference and shall not define or limit any of the terms or provisions hereof. Any term used in the singular shall be deemed to include the plural when the context of its use is so required. The fact that the wording of this Agreement has been provided by one party or the other shall not be taken into consideration in the construction or interpretation of this Agreement.
