Minutes of Le Sueur County Board of Commissioners Meeting January 19, 2016

The Le Sueur County Board of Commissioners met in regular session on Tuesday, January 19, 2016 at 9:00 a.m. in the Courthouse at Le Center, Minnesota. Those members present were: Steve Rohlfing, Lance Wetzel, Dave Gliszinski, John King and Joe Connolly. Darrell Pettis and Brent Christian were also present.

On motion by Connolly, seconded by Rohlfing and unanimously approved, the Board approved the amended agenda and consent agenda:

- Approved the CD #22, Spur B Repair Request

On motion by Gliszinski, seconded by Wetzel and unanimously approved, the following cases and claims were approved:

Soc Serv: \$ 210,684.93 Financial: \$ 69,348.85

Sue Rynda, Human Services Director, appeared before the Board to give the monthly Human Services Report. This presentation covered Finance, Income Maintenance, Child Support, Family Services, and Mental Health.

On motion by Wetzel, seconded by Gliszinski and unanimously approved, the Board approved and authorized the Board Chair to sign the 2016-17 Child Support Cooperative Agreement.

On motion by Connolly, seconded by Rohlfing and unanimously approved, the Board approved and authorized the Board Chair and County Administrator to sign the Minnesota Valley Action Council Contract and Notice of Funds.

On motion by Gliszinski, seconded by Wetzel and unanimously approved, the Board approved and authorized the Board Chair and County Administrator to sign the Counseling Services of Southern Minnesota Contract.

On motion by Rohlfing, seconded by Connolly and unanimously approved, the Board approved and authorized the Board Chair and County Administrator to sign the Blue Earth County Human Services Psychiatry Contract.

On motion by Rohlfing, seconded by Connolly and unanimously approved, the Board recessed the Board meeting and convened the public hearing on County Ditch #28.

Darrell Pettis, County Administrator gave an overview of County Ditch #28.

John Kolb, Attorney with Rinke Noonan gave information regarding County Ditch #28 and was available to answer questions.

There were 2 public comments.

On motion by Gliszinski, seconded by Wetzel and unanimously approved, the Board closed the public hearing and reconvened the Board Meeting at 10:20 a.m.

Commissioner Rohlfing made a motion to adopt the following Findings and Order:

WHEREAS, the Le Sueur County Board of Commissioners, Drainage Authority for Le Sueur County Ditch (LCD) 28, upon staff recommendation and upon the request of landowners within the benefitted area of LCD 28, investigated whether conditions exist to warrant the redetermination of benefits of LCD 28; and

WHEREAS, the Board noticed and held a hearing on Tuesday, January 19, 2016, for the purpose of soliciting and gathering public comment on the need for a redetermination of benefits for LCD 28; and

WHEREAS, upon investigation and the receipt of public comment, the Board has determined the following:

LCD 28 was established in 1906 and the current benefits roll reflects the benefited and damaged properties and benefitted and damaged areas as determined in the original proceedings. Since the original determination of benefits and damages, land uses and drainage practices have changed to accelerate and increase to flow of water to the drainage system changing the nature and value of benefits accruing to lands from construction of LCD 28.

Since the original determination of benefits and damages, modification to the outlet of Renneberg Lake, in section 15 of Derrynane Township has changed the nature of benefits accruing from the original construction of LCD 28.

Since the original determination of benefits and damages additional lands, not previously determined to be benefitted have improved drainage to take advantage of LCD 28 as an outlet for drainage.

Since the original determination of benefits and damages land values have substantially changed within the benefitted area of LCD 28.

THEREFORE, the Le Sueur County Board of Commissioners, Drainage Authority for LCD 28, finds that the conditions required for the initiation of a redetermination of benefits exist, that the original benefits and damages do not reflect reasonable present day land values and the benefitted areas have changed.

ORDER

IT IS HEREBY ORDERED that a Redetermination of Benefits, pursuant to Minnesota Statutes 103E.351 is ordered to be completed and that viewers be appointed by subsequent order to redetermine and report the benefits and damages for LCD 28.

The motion was seconded by Commissioner Connolly and after discussion, the motion passed and the Findings and Order were adopted by a vote of 5 yes and 0 no.

On motion by Connolly and seconded by Gliszinski, the Board recessed the Board meeting and convened the public hearing on County Ditch #69 at 10:25 a.m.

Darrell Pettis, County Administrator gave an overview of County Ditch #69.

John Kolb, Attorney with Rinke Noonan gave information regarding County Ditch #69 and was available to answer questions.

There was 1 public comment.

On motion by Connolly, seconded by Wetzel and unanimously approved, the Board closed the public hearing and reconvened the Board Meeting at 10:35 a.m.

Commissioner Gliszinski made a motion to adopt the following Findings and Order:

WHEREAS, the Le Sueur County Board of Commissioners, Drainage Authority for Le Sueur County Ditch (LCD) 69, upon staff recommendation and upon the request of landowners within the benefitted area of LCD 69, investigated whether conditions exist to warrant the redetermination of benefits of LCD 69; and

WHEREAS, the Board noticed and held a hearing on Tuesday, January 19, 2016, for the purpose of soliciting and gathering public comment on the need for a redetermination of benefits for LCD 69; and

WHEREAS, upon investigation and the receipt of public comment, the Board has determined the following:

LCD 69 was established in 1964.

LCD 69 outlets to Renneberg Lake, in section 15 of Derrynane Township.

LCD 28 provides the outlet to Renneberg Lake.

Upon landowner petition and findings of the drainage authority, benefits for LCD 69 were redetermined in 1992.

The current benefits roll reflects the benefited and damaged properties and benefitted and damaged areas as determined in the 1992 redetermination proceedings.

Since the 1992 redetermination of benefits and damages, land uses and drainage practices have changed to accelerate and increase to flow of water to the drainage system changing the nature and value of benefits accruing to lands from construction of LCD 69.

Since the 1992 redetermination, modification to the outlet of Renneberg Lake has changed the nature of benefits accruing from the original construction of LCD 69.

Since the original determination of benefits and damages additional lands, not previously determined to be benefitted have improved drainage to take advantage of LCD 69 as an outlet for drainage.

Since the original determination of benefits and damages land values have substantially changed within the benefitted area of LCD 69.

THEREFORE, the Le Sueur County Board of Commissioners, Drainage Authority for LCD 69, finds that the conditions required for the initiation of a redetermination of benefits exist, that the

original benefits and damages do not reflect reasonable present day land values and the benefitted areas have changed.

ORDER

IT IS HEREBY ORDERED that a Redetermination of Benefits, pursuant to Minnesota Statutes 103E.351 is ordered to be completed and that viewers be appointed by subsequent order to redetermine and report the benefits and damages for LCD 69.

The motion was seconded by Commissioner Rohlfing, and after discussion, the motion passed and the Findings and Order were adopted by a vote of 5 yes and 0 no.
